### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Comet Signs, LLC 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of July 11, 2023 and December 31 2022, and the related statements of changes in net assets in liquidation available for benefits for the period from January 1, 2023 to July 11, 2023, and the year ended December 31, 2022 and the related notes to the financial statements.

**Emphasis of Matter – Basis of Accounting**

As further discussed in Note B to the financial statements, the governing body of Comet Signs, LLC 401(k) & Profit Sharing Plan on April 17, 2023, approved a plan of liquidation, as management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from going-concern of accounting in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A – SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Presentation:* The accounting records of the Comet Signs, LLC 401(k) & Profit Sharing Plan (the "Plan") are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles. The Plan was adopted effective March 1, 2014.

The Plan Sponsor adopted a resolution to terminate the Plan on April 17, 2023, and net Plan assets of \$5,688,965 were distributed from the Plan on July 11, 2023 and transferred to the Stratus Unlimited, LLC 401(k) Plan. As a result, the Plan's financial statements as of July 11, 2023 and December 31, 2022, and for the period January 1, 2023 to July 11, 2023, and the year ended December 31, 2022 have been prepared on the liquidation basis. See Note B.

*Recognition of Income:* The basis of investments held by the Plan is adjusted annually to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized and unrealized gains and losses on investments are computed using adjusted basis (beginning of year market value) on the first-in, first-out method. Security transaction expenses are considered in computing realized gains and losses on investments.

*Investments:* Investments in mutual funds (registered investment companies) are carried at the fair market value (net asset value), as determined by quoted prices in an active market. Purchases and sales of securities are recorded on a trade-date basis. Gains and losses (realized and unrealized) included in changes in net assets are reported in net (depreciation) appreciation in fair value in the statement of changes in net assets available for plan benefits. Dividends are recorded on the ex-dividend date and are considered in the fair market value determination. Interest is recorded on the accrual basis. The benefit responsive fixed income account is stated at contract value.

*Benefit Payments:* Benefits are recorded when paid.

*Subsequent Events:* Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*Use of Estimates:* The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

*Plan Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

*Concentration of Credit Risks:* Concentration of credit risk with respect to investments held by Voya Retirement Insurance and Annuity Company is reduced as a result of the diversity of the underlying investments.

*New Accounting Pronouncements:* Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact to its financial position or results of operations in future periods.

**NOTE B – PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING**

Following the sale of the Plan Sponsor, Comet Signs, LLC to Stratus Unlimited, LLC in December 2022, Plan management adopted a resolution on April 17, 2023, to terminate the Plan effective July 11, 2023. Accordingly, the Plan's financial statements as of and for the period ended July 11, 2023 have been prepared on the liquidation basis of accounting. The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The Plan had no assets as of July 11, 2023 as liquidation had taken place. The estimated net realizable value for investments as of December 31, 2022 is fair value.

**NOTE C – DESCRIPTION OF PLAN**

The following description of the Comet Signs, LLC 401(k) & Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan.

*General:* The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and covered substantially all employees of the Comet Signs LLC (Plan Sponsor) who are age twenty-one or older and have completed three months of service. The Plan was for the exclusive benefit of its participants and their beneficiaries.

*Contributions:* Each year participants could elect to contribute up to 100% of pretax annual compensation as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor could elect to contribute a discretionary matching contribution, the amount of which was determined by the Board of Directors and allocated based on each participant's contributions. Participants also directed the investment of any matching contribution received. For the six and a half month period ended July 11, 2023, and year ended December 31, 2022, the Plan Sponsor elected to contribute 30% of the first 6% of compensation that a participant contributed to the Plan.

*Participant Accounts:* Each participant's account was credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations were based on participant contributions or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

*Vesting:* Participants were 100% vested at all times in their voluntary contributions plus actual earnings thereon. A participant's interest in the discretionary contributions the employer made to the Plan became 20% vested after one year of service and an additional 20% for each year of service thereafter until fully vested. If employment was terminated prior to normal retirement age for any reason other than death or disability, then the employee's interest in employer contributions became 100% vested following 5 years of employment in accordance with specific vesting schedules based on years of service as required by the Department of Labor Rules and Regulations.

*Payment of Benefits:* On termination of service a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the total vested account balance was less than \$5,000, the participant would receive a single lump sum payment as soon as administratively possible following termination of employment. Hardship withdrawals were also available to participants subject to certain limitations and upon approval by Plan management.

*Forfeited Accounts:* Forfeited non-vested accounts totaled \$-0- at July 11, 2023, and \$23,591 at December 31, 2022. Forfeitures could be used to pay administrative expense and reduce employer contributions. The Plan used forfeitures of approximately \$3,000 in 2023 and \$16,000 in 2022 towards administrative expenses and approximately \$26,000 in 2023 and \$9,000 in 2022 to reduce employer contributions.

**NOTE D – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)**

As permitted by Department of Labor CFR 2520.103-8, Plan investments at July 11, 2023, and December 31, 2022 and the related investment earnings for the periods then ended, were certified and held by Voya Institutional Trust Company, the Trustee, and were not audited by the independent auditor.

**NOTE E – FIXED INCOME ACCOUNT WITH INSURANCE COMPANY**

The Plan had a fully benefit-responsive investment option, the Voya Fixed Account, with a balance of \$-0- at July 11, 2023, and \$24,633 at December 31, 2022. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group funding agreement provided a fixed account which was contractually obligated to repay the principal and a specified minimum interest rate that was guaranteed to the Plan.

Because the fixed account was fully benefit-responsive, it was stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants would ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants was probable.

There was no maturity date for the contract. Voya had the right after five years to terminate this agreement provided the Plan is given 90 days written notice.

**NOTE F – TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan included certain investments managed by Voya, the Third-Party Administrator. Therefore, these investments and transactions were considered party-in-interest transactions. Fees paid for legal, accounting, and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan's administrative expenses were paid either by the Plan or the Plan Sponsor as allowed for in the Plan document.

**NOTE G – INCOME TAX STATUS**

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 11, 2023 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**NOTE H – FAIR VALUE MEASUREMENTS**

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets in active markets, including pooled separate accounts
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
  - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of July 11, 2023, all of the Plan’s assets had been transferred out.

There have been no changes in methodologies used to estimate fair value, nor transfers between levels. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the net asset value (NAV).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE I – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
