Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 - PLAN DESCRIPTION

The following description of The SSI Group, LLC Employees' Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended for a more complete description of the Plan's provisions.

General. The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of The SSI Group, LLC (the Company) and additional adopting employers and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The SSI Group, LLC is the Plan's sponsor and serves as Plan Administrator.

Administration. The Company has appointed The SSI Group Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company contracted with Charles Schwab Trust Bank to act as the Trustee and custodian and an affiliate of Charles Schwab Trust Bank to process and maintain the records of participant data.

Eligibility. Employees of the Company are eligible to participate in the Plan upon reaching age 21. Participants must complete at least one year of service to be eligible to receive any employer match contributions. Participants are eligible to receive an allocation of the profit-sharing contribution if they have completed at least 6 months of service during the year and have at least one year of eligibility in the Plan.

Contributions. Each year, participants may contribute between 1% and 50% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions and after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total pretax and Roth contributions cannot exceed 80% of annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 15%.

The Company may elect to make discretionary matching and profit sharing contributions to the Plan. The Company matches 50% of employee contributions, up to 6% of eligible compensation deferred to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. For the year ended December 31, 2024, the Company made a \$329,576 profit sharing contribution to the Plan. Contributions are subject to regulatory limitations.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

Participant accounts. Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan. Participants may invest in publicly traded securities through a self-directed brokerage feature.

Vesting. Participants are vested immediately in their contributions, as well as the Company's contributions, plus actual earnings thereon.

Notes receivable from participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed thirty years. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan Administrator. Principal and interest is paid ratably through bi-monthly payroll deductions.

Payment of benefits. On termination of service due to death, disability, or retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments. The Plan allows for automatic distributions of participant vested account balances that do not exceed \$5,000. Funds may also be accessed prior to the date they become distributable by way of in-service distributions and/or a financial hardship withdrawal. In-service distributions are available once the participant has reached the age of 59 1/2. Hardship withdrawals are allowable in accordance with current Internal Revenue Service guidelines.

Forfeitures. Forfeitures retained in the Plan must be used no later than the end of the following Plan year in which they occur to pay administrative expenses and to reduce Company contributions. Amounts forfeited during 2024 totaled \$711. As of December 31, 2024 and 2023, there were no unallocated forfeited accounts. Forfeitures are applied annually to fund the prior Plan year's profit-sharing contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

Investment valuation and income recognition

The Plan's investments are reported at fair value as provided and certified by the Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and the unrealized appreciation and depreciation of those investments and is reported in the statement of changes in net assets available for benefits.

Notes receivable from participants

Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

Subsequent events have been evaluated through October 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

Investments held by the Plan are valued as follows:

Mutual funds and money market fund. Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

NOTE 4 - TAX STATUS

The Company adopted a Non-standardized Pre-Approved Profit Sharing Plan with CODA which received an opinion letter from the Internal Revenue Service on September 21, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The investments information included in the accompanying financial statements and supplemental schedule, in total, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value, dividends and interest for the year ended December 31, 2024 was obtained from data prepared by the Trustee of the Plan and provided to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. During the year ended December 31, 2024, fees of \$5,680 were paid by the Plan to various service providers which qualify as party-in-interest transactions under ERISA.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
