To the Plan Administrator Parr Brown Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Parr Brown Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Parr Brown Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Parr Brown Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Plan Description

Parr Brown Gee & Loveless P.C. (the Company, Employer, or Sponsor) restated the Parr Brown Profit Sharing Plan (the Plan) effective April 1, 2022 (the "2022 Plan Documents"). It continues, as amended, from a previous plan originally established on April 1, 1975. The Plan was established to provide employees of the Company an opportunity to accumulate funds for retirement, disability, or death benefits for beneficiaries. Certain members of management of the Company serve as trustees for the Plan.

The following description of the Plan provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is designed to be a qualified defined contribution plan. Employees became eligible to participate in the Plan following the date they attain age 21 and complete the lesser of (a) at least three consecutive full calendar months of service for the Company, or (b) one year of service, provided that in either case they are still an eligible employee on the entry date. Employees initiate participation in the Plan either on April 1st or October 1st after having met the eligibility requirements. Certain employees classified as "of counsel attorney" are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute up to 75% of their eligible compensation, as defined in the Plan. Contributions are subject to Internal Revenue Code (IRC) limitations of \$23,500 and \$23,000 (\$31,000 and \$30,500 for participants aged 50 or older) during calendar years 2025 and 2024, respectively.

The Company is required to contribute 3% of a participant's eligible compensation. The Company may also make discretionary contributions to the Plan. A participant becomes eligible for the discretionary contribution on the April 1st or October 1st following his or her completion of two years of service. When discretionary contributions have been declared, the Company has historically contributed an additional 8% of a participant's eligible compensation plus 5.7% of a participant's eligible compensation in excess of the Social Security tax limits established by law (\$176,100 for 2025 and \$168,600 for 2024). Plan Sponsor contributions are subject to IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the participant's allocable share of Plan Sponsor required contributions and Plan Sponsor discretionary contributions, and the participant's allocable share of earnings on investments. Each participant's account is charged with losses on investments, administrative expenses, and distributions. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participant Options for Investments

For both participant contributions and Plan Sponsor contributions, participants may designate how their account balances are allocated into various investment options selected by the Plan Administrator.

Vesting

Participants are immediately vested in their contributions, the Plan Sponsor contributions, and actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms may not exceed five years (except for amounts related to a principal residence, which may not exceed 15 years). Each note receivable is secured by the balance in the participant's account and bears interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator, currently at the applicable prime rate plus 3%. As of March 31, 2025, interest rates on outstanding notes receivable ranged from 5.87% to 11.5% with maturities through April 2040. Principal and interest payments are collected ratably through payroll deductions. Note receivable repayments may be suspended for periods in which the participant is on an authorized leave of absence without pay for a period of up to one year. Loans against account balances of greater than \$5,000 require spousal consent.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of the Plan's financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefits at the date of the financial statements and the changes in assets available for benefits during the reporting period. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in securities that are exposed to various risks, such as interest rate movement, currency exchange rate, credit quality, liquidity, overall market volatility, and economic conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Investment Valuation and Income Recognition

The Plan utilizes market data or assumptions about risk and the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated or generally observable. The Plan primarily applies the market approach for recurring fair value measurements and endeavors to utilize the best available information.

Accordingly, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan is able to classify fair value balances based on the observance of those inputs into the fair value hierarchy levels as set forth in the fair value accounting guidance.

Each investment is individually valued as described below:

- a. Investments in mutual funds are stated at quoted market value.
- b. Investments in common/collective trusts are stated at fair value measured at net asset value (NAV) as a practical expedient.
- c. Investments in insurance policies are stated at fair value based upon the policies' cash surrender values.

Purchases and sales of securities are recorded on a trade-date basis. The net change in value of investments represents the difference between the carrying value (which represents the prior year ending value or cost if the investment was purchased during the year) and the value of investments held at year end. The net change in value of investments is recognized in income currently. Dividends and are reinvested as earned.

Notes Receivable from Participants

Notes receivable from participants represent loans to participants that are recorded at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Fees related to notes receivable from participants are recorded as administrative expenses when they are incurred. If a participant defaults, the carrying amount of the note receivable from the participant is eliminated and a benefit payment is recorded at the time the participant is deemed to receive a distribution.

Administrative Fees and Life Insurance Premiums

For the year ended March 31, 2025, administrative fees of the Plan were paid by the Company, except for origination fees for notes receivable from participants, certain consulting and recordkeeping fees, other fees that are allocated to the specific participants benefiting from the related service, and life insurance premiums. In accordance with the Plan document, the Company may pay administrative fees but is not required to do so.

Payment of Benefits

Benefits are recorded when paid by the Plan. Upon a participant's death, retirement or termination of employment, the Plan may distribute the participant's vested account balance in a single, lump-sum cash payment to the participant or to his or her beneficiaries, or through various installment options. In all instances, if a participant's vested account balance does not exceed \$1,000, the Plan Administrator will distribute the balance in a lump sum as soon as administratively practicable. However, if a participant's vested account balance exceeds \$1,000, the Plan Administrator will commence distribution at the time and in the form the participant elects. Under certain circumstances, including financial hardship, participants may withdraw their contributions prior to the occurrence of these events. Financial hardship withdrawals require approval, and after such a withdrawal, 401(k) elective deferrals cannot be made to the Plan for six months. In-service distributions are allowed prior to the age of 59½ of profit-sharing contributions that have been held in the Plan more than two years. A participant may only receive one in-service distribution in this manner not to exceed \$25,000.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 30, 2025, which is the date the financial statements were available to be issued.

3. Investments

Prior to April 1, 1998, participants were able to direct their contributions into various investments consisting of common stocks, corporate bonds, and insurance policies. The trustees of the Plan elected on that date to only allow participants to direct their contributions into investments consisting of a money market account, mutual funds, or common/collective trusts. Any investment as of April 1, 1998 was grandfathered to remain in the Plan until sold or otherwise liquidated.

4. Fair Value Measurements

Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, the fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three broad levels. These levels, in order of highest priority to lowest priority, are described as follows:

Level 1: Quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities.

Level 2: Observable prices that are based on inputs not quoted on active markets but corroborated by market data.

Level 3: Unobservable inputs are used when little or no market data is available.

5. Exempt Party-in-Interest Transactions

The Plan's investments, other than the life insurance policies, are held by Charles Schwab Bank and affiliates. Therefore, any fees paid by the Plan to Charles Schwab Bank and affiliates qualify as exempt party-in-interest transactions. The notes receivable from participants are also considered exempt party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their account balances.

7. Income Tax Status

The 2022 Plan documents have been approved by the Internal Revenue Service (IRS), and the IRS issued an opinion letter dated September 21, 2020, on which Management and the Plan can rely, indicating that the Plan is designed in accordance with applicable sections of the IRC. Plan management believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC and the trust established under the Plan is tax-exempt under the IRC. Accordingly, an income tax provision is not recorded by the Plan. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax years in progress.

Management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

8. Custodian Certification

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Charles Schwab Trust Bank, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- All investment assets held by the Plan, except for the life insurance policies
- Notes receivable from participants
- The recording of transactions related to all investment assets (except for the life insurance policies) and notes receivable from participants, including related earnings (losses) and interest and dividends.
