Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets Held for Investment Purposes at End of Year - December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A: DESCRIPTION OF THE PLAN

The following description of Keter Environmental Services Inc - 401(k) (the "Plan") provides only general information. Participants should refer to the Plan agreement, including amendments, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code that was established on October 1, 2021, covering eligible employees of Keter Environmental Services, Inc., Kes Industrial LLC and, effective January 1, 2024, Waste Harmonics, Inc. (the "Plan Sponsor" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company and the Administrative Committee is responsible for oversight of the Plan.

Eligibility

Employees who have attained the age of 21 years or older and have completed one month of service, as defined in the Plan document, are eligible to participate in the Plan. Employees are eligible to enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are met.

Contributions

Each year, participants may contribute up to 90% of their pre-tax annual compensation, as defined in the Plan document. Participants may also make rollover contributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Participants may also designate some or all of their elective deferral on a post-tax basis ("Roth Deferral Contribution"). Once the Roth Deferral Contribution election is made, the contribution amount will be included in the participant's income for income tax purposes, and the income tax withholding amounts will be deducted from the remainder of the participant's pay.

The Company's safe harbor matching contributions are equal to 100% of the first 4% of compensation that a participant contributes to the Plan. Company contributions are invested directly in the investment options as directed by the participant.

Qualified nonelective contributions may be made at the option of the Company. To be eligible for the Company's contributions, employees must be employed on the last day of the Plan year and must be credited with at least 1,000 hours of service during the Plan year, as defined. For the year ended December 31, 2024, the Company elected not to make discretionary nonelective contributions to the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and qualified nonelective contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivables from participants

Participants may borrow from their fund accounts a minimum amount of \$500 up to a maximum amount equal to the lesser of a) \$50,000, or b) 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar loans. Participant loans generally must be fully repaid within five years, unless the loan was for the purchase of a primary residence, in which case the period can be extended to 30 years. Participants can have no more than two loans outstanding at any given time.

Vesting

Participants are immediately vested in their elective deferral, rollover contributions, safe harbor matching contributions and the Company's qualified nonelective contributions, plus actual earnings thereon.

Forfeitures

Forfeitures are used to pay for the administrative expenses of the Plan and to reduce employer contributions. At both December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$10. During the year ended December 31, 2024, the Plan Sponsor used approximately \$900 of available forfeitures to reduce the employer matching contributions.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the participant's vested interest in his or her account or annual installments over a period of not more than their assumed life expectancy as determined at the time of distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements and supplemental schedule of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are considered to be deemed distributions and are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. These expenses are party-in-interest transactions.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through October 14, 2025, which is the date the financial statements are available to be issued. See Note J.

NOTE D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its operations at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and their accounts will be paid to them as provided by the plan document.

NOTE E: TAX STATUS

The Internal Revenue Service determined and stated by a letter dated October 6, 2020, that the non-standardized, pre-approved plan under which the Plan was adopted, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: TRANSACTIONS WITH PARTIES-IN-INTEREST

Notes receivable from participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. As described in Note B, the Plan paid certain expenses related to the plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

NOTE H: FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE H: FAIR VALUE MEASUREMENTS, Cont'd

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded, open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value and to transact at that price.

Common/collective trust: Valued at the net asset value reported by the fund as a practical expedient. There are no unfunded commitments as of December 31, 2024 and 2023, and investments can be redeemed on a daily basis without restriction and are not subject to redemption notification provisions except in the case of a plan-level liquidation.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statements of net assets available for benefits.

NOTE I: PLAN MERGER AND TRANSFER

Effective January 1, 2024 the WH Acquisition LLC 401(k) Profit Sharing Plan and Trust was merged into the Keter Environmental Services Inc - 401(k). As of the effective date of the merger, all eligible participants of WH Acquisition 401(k) Profit Sharing Plan and Trust were eligible to participate in the Keter Environmental Services Inc – 401(k). In March 2024, all net assets of the WH Acquisition LLC 401 (k) Profit Sharing Plan and Trust, totaling approximately \$4,002,000, were transferred to the Keter Environmental Services Inc – 401(k). The transfer included all investment and related participant account balances.

NOTE J: SUBSEQUENT EVENT

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.
