As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Texas Medical Liability Trust 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, formed January 1, 1992, covering all employees of Texas Medical Liability Trust (the “Company”), meeting participation requirements described below. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”) and all requirements of Section 401(a) of the Internal Revenue Code (“IRC”).

Participation

All employees (excluding leased employees, employees previously misclassified as independent contractors, and interns) who have reached their 18th birthday and have completed 90 days of employment are eligible for participation in the Plan.

Contributions

Effective January 1, 1992, participants may elect to contribute a portion of their pre-tax compensation pursuant to their salary deferral agreements on file with the Company’s manager of payroll and benefits. As required per IRC Section 401(a)(17), participant’s compensation taken into account under the Plan was limited to \$345,000 and \$330,000 for the Plan years ended December 31, 2024 and 2023, respectively. An employee participant’s elective contribution may not exceed \$23,000 and \$22,500 for the Plan years 2024 and 2023, respectively. If the participant is age 50 or greater, a “catch-up” contribution of \$7,500 for Plan years 2024 and 2023 is also allowed. Compensation includes the employees’ elective contributions.

At its discretion, the Company may make matching contributions. For Plan years 2024 and 2023, the Company matched 100% of employee deferrals, up to a maximum of 6% of their eligible salary.

Participants may elect to begin salary reduction contributions on the following January 1st, April 1st, July 1st, or October 1st after they become eligible.

At the end of the Plan year, at the discretion of the Company, the Company may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions were allocated to eligible participants based upon 6% of each Participant’s compensation for Plan years ended December 31, 2024 and 2023. The discretionary profit-sharing contributions for the Plan years ended December 31, 2024 and 2023 were \$1,032,306 and \$1,028,310, respectively.

Participant's Account

Accounting records for individual participants are maintained by a third-party administrator. Each participant's account is credited with the participant's directed salary deferral, any employer contributions, forfeitures and Plan earnings and losses, net of appreciation and depreciation.

Administrative Expenses

All reasonable expenses of administration including, but not limited to, those involved in retaining necessary professional assistance may be paid from the assets of the Plan. The Company may, at its discretion, pay such expenses. The Plan is required to disclose service provider fees paid directly from Plan assets. Service provider fees paid by Plan assets totaled \$119,531 and \$102,168 for Plan years ended December 31, 2024 and 2023, respectively.

Investments Options

Participants direct the investment of their contributions into various options offered by the Plan. The Plan currently offers various mutual funds, collective investment trust funds, a stable value collective investment fund, and a participant-directed brokerage account as investment options for participants. If elected, a participant-directed brokerage account allows a participant to direct the investment of the participant's contributions to the Plan among various investments that are not otherwise offered as options under the Plan. Participant contributions may be invested in any or all of the investment options. Participants may change their investment options at any time.

Vesting

Participants are immediately and fully vested in their salary deferral contributions to the Plan plus actual earnings thereon. Vesting in Company contributions and earnings thereon is based on years of service with the Company and is subject to the graduated vesting schedule as follows:

Years of service	Percentage
1	0%
2	50%
3	100%

Payment of Benefits

The Plan does not allow withdrawals of contributions or earnings thereon by active employees of the Company, except for hardship distributions and upon reaching age 59½. Hardship distributions may be received from participant accounts that are 100% vested. On termination of service due to attaining normal retirement age, disability or death, a participant or his beneficiary may elect to receive an amount equal to the value of his or her account balance, irrespective of the vesting schedule, in a lump-sum distribution. An employee who terminates employment before reaching normal retirement age may elect to receive a distribution of his or her vested account balance.

Forfeitures

Participant forfeitures of non-vested contributions are used to reduce the Company's future contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,780 and \$6,215, respectively. Also, in 2024 and 2023, employer contributions were reduced by \$18,432 and \$6,162, respectively, from forfeited nonvested accounts.

Notes Receivable – Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates range from 4.25% to 10.50%. Principal and interest are paid through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

3. Plan Revision, Amendment and Termination

The Company may revise and / or amend the Plan as deemed necessary. Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA.

4. Tax Status

The Plan is as a volume submitter plan sponsored by Schwab Retirement Plan Service Inc. The Internal Revenue Service (“IRS”) has determined and informed Schwab Retirement Plan Service Inc. by a letter dated September 21, 2020 that the volume submitter plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5. Information Certified by the Plan’s Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. Fair Value Measurements

FASB Accounting Standards Codification 820, *Fair Value Measurement*, ("FASB ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the plan can access at the measurement date.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust funds: Valued at their daily published NAV available on a securities exchange registered with the SEC. The value is deemed to be readily determinable.

Participant-directed brokerage account investments: The participant-directed brokerage account represents various investments, including unit investment trusts, common stock, and interest-bearing cash. Unit investment trusts and common stock are valued at the NAV of shares or units held by the Plan at year end. The carrying value of interest-bearing cash approximates fair value.

Stable value collective investment fund: Valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value.

8. Subsequent Events

The Plan has evaluated subsequent events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, through September 23, 2025, the date the financial statements were available to be issued. The Plan does not believe any subsequent events have occurred that would require further disclosure or adjustment to the financial statements.
