Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### 1. DESCRIPTION OF PLAN

The following description of the George Walton Academy 403(b) DC Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a 403(b) defined contribution plan covering all eligible employees of George Walton Academy, Inc. (the School). All employees are eligible to participate in the Plan unless they are a student of the School. Employees who normally work more than 20 hours per week are eligible for the School's match (See Note 3). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On January 1, 2019, the George Walton Academy 403(b) TDA Plan was merged with and into the George Walton 403(b) DC Plan with the George Walton 403(b) DC Plan being the surviving plan.

#### **Participant Accounts**

Each participant's account is credited with the School's contributions, participant contributions, and allocation of Plan earnings. Allocations of earnings are based on account balances as defined by the Plan. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in their contributions, including rollovers, as well as the School's contribution plus actual earnings thereon.

#### **Participant loans**

Loans are permitted from the Plan under certain circumstances.

#### **Payment of benefits**

On termination of service, a participant may elect to receive a distribution equal to the vested portion of their account balance. The elections available are (a) an installment distribution, (b) a lump sum distribution, (c) partial payments, or (d) an annuity contract.

#### **Forfeited Accounts**

The Plan does not provide for forfeited accounts because participants are always 100% vested.

## Notes to Financial Statements

### **Plan loans**

Participants may borrow directly from the Custodian, subject to certain limitations, by using a portion of their Plan account as security for the plan loan. These loans do not occur directly within a participant's account but rather through a designated Custodian account. Outstanding loan balances were \$19,250 and \$17,450 at December 31, 2024 and 2023, respectively, and are not reported within the accompanying financial statements of the Plan but serve as collateral against the outstanding plan loan balances. Interest on these loans is paid directly to the Custodian.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

### **Plan Administration**

The Plan Sponsor serves as the plan administrator. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The plan administrator has engaged Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (see Note 8) as custodians and to assist in the administration of the Plan.

### **Investment Valuation and Income Recognition**

The Plan's investment options include the TIAA Traditional Annuity, TIAA Real Estate Account, CREF Annuities, TIAA Access, and TIAA-CREF Mutual Funds. All fixed-rate annuity contracts are valued at fair value, and all other investments are priced at fair value in a process described in Note 5. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. See Note 5 for discussion of fair value measurements.

### **Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Tax Status**

The Plan uses a 403(b) pre-approved plan document sponsored by TIAA. The document has received an IRS opinion letter under the 403(b) Pre-Approved Plan Program (Cycle 2).

## Notes to Financial Statements

### **Administrative Expenses**

Administrative expenses incurred by the custodians and asset management and advisory fees are paid from the assets of the Plan. Administrative expenses of the Plan are also paid by the Plan Sponsor. Administrative expenses for the Plan totaled \$974 for the year ended December 31, 2024.

### **3. CONTRIBUTIONS**

Participants may contribute, and the School will match, 5% of annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The limit that participants may contribute for 2024 is \$23,000. The Plan allows for Catch-Up Contributions of up to \$7,500 per year for participants who are 50 or older. Additionally, Special 403(b) Catch-Up Contributions are allowed for participants who have at least 15 years of Service. This Special 403(b) Catch-Up Contribution is equal to the lesser of: (a) \$3,000; (b) \$15,000 minus the amount of Special 403(b) Catch-Up Contributions made in prior years; or (c) \$5,000 times the number of years of service less the total amount of Deferral made while during years of service. These catch-up contributions are eligible for Matching Contributions by the School.

### **4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **5. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520-103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodian as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to the information included in the Plan's financial statements and supplemental schedules. Investments held and certified by the custodian in the accompanying statements of net assets available for benefits totaled \$18,846,593 and \$18,026,132, as of December 31, 2024 and 2023, respectively. Investment gain reported and certified by the custodian in the accompanying statement of changes in net assets available for benefits totaled \$2,302,578 for the year ending December 31, 2024.

## George Walton Academy 403(b) DC Plan Notes to Financial Statements

U.S. generally accepted accounting principles establish a framework for measuring fair value. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC 820), Fair Value Measurements and Disclosures, provided the framework for measuring fair value. That framework provides a fair value hierarchy that give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 Measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 or 2023.

TIAA Traditional Annuity—A guaranteed annuity, provides a guaranteed minimum interest rate. Valued at fair market value (See Note 7).

TIAA Real Estate and TIAA Access—Do not provide guaranteed returns. Daily Accumulation Unit Values are calculated by the Factor Calculation application on a daily basis.

CREF Accounts—Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each Account determines its unit value each day.

**7. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The TIAA Traditional Annuity, a guaranteed annuity backed by TIAA's claims-paying ability, provides a guaranteed minimum interest rate. TIAA earnings above this rate may be paid if declared by TIAA's Board of Trustees. Interest rates are generally in effect for a 12-month period, March 1 through the last day of February of the following year. However, for new monies coming in, rates may change more frequently, but no more frequently than monthly.

TIAA uses a 'vintage' method of crediting interest for funds in the TIAA Traditional Annuity. As the yields available on new long-term investments tend to vary over time, TIAA groups the funds received over discrete time periods into vintages. The interest credited to each vintage reflects the investment returns initially obtained on TIAA's investments during each period.

The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under all accumulating contracts with the exception of the Retirement Choice (RC) and Retirement Choice Plus (RCP) contracts. For the RC and RCP contracts, the guaranteed rate is between 1% and 3%. The TIAA Traditional Annuity holdings within the Retirement Annuity, Group Retirement Annuity, and Retirement Choice contracts have liquidity restrictions and are non-benefit responsive.

The contract is included in the statements of net assets available for benefits at fair value as determined using the market approach based on market prices of similar contracts. The TIAA Traditional Annuity is reported at contract value. The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. The fair value of the investment contract at December 31, 2024 and 2023 was \$ 4,663,701 and \$5,020,342, respectively.

**8. PARTY-IN-INTEREST TRANSACTION**

TIAA, CREF and affiliates (see Note 1) perform services for and sell products to and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The following expenses paid by the plan to TIAA, CREF and affiliates during 2024 are either reflected in the accompanying statement of changes in net assets available for benefits as plan administrative expenses or netted against investment income.

Such fees, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. SUBSEQUENT EVENTS**

In connection with the preparation of the financial statements and in accordance with ASC Topic 855, *Subsequent Events*, Management evaluated subsequent events and transactions through November 3, 2025 , the date the financial statements were issued. No subsequent events requiring recording or disclosure in the financial statements or related notes to the financial statements were noted. Subsequent events after that date have not been evaluated. There were no subsequent events identified by the Plan that required disclosure.
