This is a summary of the annual report for J & R Enterprises Retirement Plan 48-1194958 for December 31, 2021. The form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution plan a single-employer plan.

**Basic Financial Statement**

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$0. A total of two persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$753,355 as of December 31, 2021, compared to \$630,559 as of January 1, 2021. During the plan year the plan experienced a increase in net assets of \$122,796. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$122,796, including employer contributions of \$42,932, employee contributions of \$10,478 and other income of \$69,386.

**Information Regarding Plan Assets**

The U.S. Department of Labor's regulations require that an independent qualified public accountant audit the plan's financial statements unless certain conditions are met for the audit requirement to be waived. This plan met the audit waiver conditions for 2021 and therefore has not had an audit performed. Instead, the following information is provided to assist you in verifying that the assets reported in the Form 5500 were actually held by the plan.

At the end of the 2021 plan year, the plan had \$753,355 in assets held by Principal.
