Opinion

We have audited the financial statements of Carolina Dealerships, Inc. Note 1. Plan Description

The following description of the Carolina Dealerships, Inc. Welfare Benefit Trust Cafeteria Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2005 to provide health and disability benefits covering substantially all of the employees of the employers currently participating in the Plan (collectively referred to as the "Employer"). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits (medical, dental, vision, and prescription drugs), life insurance coverage, and supplemental accident, critical illness, short-term and long-term disability benefits, and cancer insurance to eligible participants on the first day of the month following two full months of employment and eligible dependents subject to payment of deductibles and coinsurance amounts by the participants. The Plan also provides eligible participants on the first day of the month following one year's employment the opportunity to establish health flexible spending accounts and dependent care assistance plan flexible spending accounts.

Medical and pharmacy claims of active participants and dependents are processed and adjudicated by Blue Cross and Blue Shield of North Carolina and health and dependent care assistance plan flexible spending account reimbursements are processed and administered by SHDR, a subsidiary of Truist Bank, but the responsibility for payments to participants and providers is retained by the Plan. The responsibility for all other benefits provided under the Plan is ceded to third-party insurance carriers and vendors under applicable insurance and other arrangements.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop Loss Coverage

The Plan maintains "stop-loss" insurance coverage for large individual claims and Plan claims in the aggregate. For the year ended December 31, 2024, the Plan was covered for annual claims exceeding \$200,000 per person, except for claims exceeding \$850,000 for one participant, and subject to a \$100,000 cumulative deductible with no specific lifetime maximum. For 2024, the Plan aggregate stop-loss limit was set at \$25,047,235 with aggregate annual stop-loss benefits being limited to \$1,000,000. The Employer and the Plan have continued this insurance coverage for 2025.

Contributions

Benefits are funded through contributions from the Employer and from participants. The contribution rates are subject to change at the Employer's discretion based on periodic evaluations of the costs of the Plan. The Employer contributes each year all amounts in excess of participants' contributions which are necessary to provide current cash payments under the Plan, and to meet any premium or other charges necessary for the administration of the Plan.

Termination of Plan

Although it has not expressed the intent of doing so, the Employer has the right under the Plan to modify the benefits provided to active employees, to discontinue its contribution at any time and to terminate the Plan subject

to provisions set forth in ERISA. All previous contributions by the Employer would be used for the purpose of paying benefits for claims arising prior to termination, and allowable claims filed after termination would be limited to the remaining assets of the Plan. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

Subsequent Events

The Plan evaluated the effects subsequent events would have on the financial statements through October 14, 2025, which is the date the financial statements were available for issuance, noting the addition.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Cash and Cash Equivalents

The Plan considers all highly liquid debt instruments purchased with an original maturity of three months or less to be cash equivalents.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Employer or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits and of changes in benefit obligations.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payables to third party administrators in the accompanying statement of changes in net assets available for benefits and of changes in benefit obligations.

Benefit Obligations

Plan obligations at year end for health claims incurred by active participants but not reported at that date are estimated from claims data provided by the Plan's third-party administrator. Such estimated amounts are reported in the accompanying statements of net assets available for benefits and of benefit obligations.

Stop Loss

Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits and of changes in benefit obligations. Individual stop loss refunds totaling approximately \$1,547,000 have been netted with benefits paid for participants in the accompanying statement of changes in net assets available for benefits and of changes in benefit obligations.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Pharmacy rebates totaling approximately \$1,701,000 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024.

Concentration of Credit Risks

The Plan maintains deposits with a financial institution, the balances of which exceed the federally insured amount. The Plan has not experienced any losses in such accounts and believes it is not exposed to significant credit risk on cash and cash equivalents.

Administrative Expenses

The Employer absorbs certain administrative expenses incurred for the Plan, such as personnel, legal, benefit consulting, and audit expenses. The Plan pays all other expenses, including contract third party administrator fees.

Note 3. Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS), dated February 2, 2007, stating that the trust is tax-exempt under to provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Employer believes that the trust, as amended, continues to qualify and operate in accordance with applicable provisions of the IRC, and therefore, believes that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Plan Participation Changes

During 2024, Beach Chevrolet, Inc., Carolina Customs Upfitting, LLC, CVL One LLC, One World Parts LLC, and Michael Automotive, LLC began participating in the Plan.

Note 5. Related-Party Transactions

As described in Notes 1 and 2, the Plan has arrangements with various service providers. These transactions are considered exempt party in interest transactions under ERISA.

Note 6. Risk and Uncertainties

The Plan's benefit obligations are reported based on certain assumptions pertaining to claims reporting lag times and payment history, both of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
