### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of the BancFirst Employees' Health Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits and the plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits and changes in plan benefit obligations for the years then ended and the related notes to the financial statements.

Management has obtained a certification from BancFirst Trust and Investment Management (the trust division of BancFirst Corporation), a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### **Basis for Opinion**

### **Responsibilities of Management for the Financial Statements**

#### (1) DESCRIPTION OF THE PLAN

The following description of the BancFirst Employees' Health Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

##### General

The Plan provides health and other benefits covering all employees of BancFirst Corporation (the "Sponsor"). Certain plan assets are held in a Voluntary Employee's Beneficiary Association (VEBA) trust. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Payment of Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, and dental) and permanent disability benefits to full-time participants (regular, full-time, active employees who work 30 hours or more per week) and to their beneficiaries and covered dependents. Retired employees are entitled to similar health benefits (in excess of Medicare coverage), provided they have attained at least age 62 and have 10 consecutive years of service before retirement or have attained at least age 55 and have 25 years of service before retirement. Retirees are eligible under the Plan until they attain the age of 65. The Plan also provides health benefits to participants during periods of unemployment for up to 18 months.

Health and disability claims of active and retired participants, dependents, and beneficiaries are processed by The Kempton Group ("Kempton") and by Blue Cross and Blue Shield of Oklahoma, a division of Health Care Service Corporation ("BCBS"), but the responsibility for payments to participants and providers is retained by the Plan.

Benefit payments are expensed when reimbursements are made by the third-party administrator.

##### Contributions

The Sponsor's regular contributions reflect amounts determined annually by the Plan's actuary. In addition, the Sponsor may make contributions for the purpose of funding future benefits. Employees and retirees contribute specified amounts, determined periodically by the Plan's actuary, toward the cost of the Plan.

#### (1) DESCRIPTION OF THE PLAN, CONTINUED

##### Plan Termination and Other

Although it has not expressed an intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Additionally, the Sponsor reserves the right to periodically amend the benefits provided under the Plan.

#### (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States require management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

##### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value (see Note 7). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee services rendered to December 31, 2024, and 2023.

Postretirement benefits include future benefits expected to be paid to or for: (a) currently retired or terminated employees and their beneficiaries and dependents; and (b) active employees and their beneficiaries and dependents after retirement from service. The postretirement benefit obligation represents the amount that is to be funded from the Plan's contributions and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

**Postretirement Benefits, Continued**

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7.50% annual rate of increase in the per capita cost of covered healthcare benefits was assumed for both 2024 and 2023. That rate is assumed to decrease annually gradually to 4.5% for 2037 and thereafter.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

**Other Plan Benefits**

Plan obligations for accumulated eligibility of participants and for future disability payments to members considered permanently disabled are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statements of plan benefit obligations at present value based on a 5.49% and 4.81% discount rate in 2024 and 2023, respectively.

Plan liabilities for health claims incurred but not reported are estimated based on historical claims experience and actual claims reported subsequent to the Plan's year-end.

**Tax Status**

The Plan has not obtained a determination letter in which the Internal Revenue Service would state that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specified dollar amount, as well as its aggregate exposure for all claims). Premiums for stop-loss coverage are included in administrative expenses in the accompanying statements of changes in net assets available for plan benefits. Stop-loss refunds totaling \$41,027 and \$445,244 in 2024 and 2023, respectively, have been netted with benefits paid in the accompanying statements of changes in net assets available for plan benefits.

**Administrative Expenses**

Administrative expenses may be paid by the Sponsor or by the Plan, at the Sponsor's discretion.

**Date of Management's Review of Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, the date that the financial statements were available to be issued, and determined that no subsequent events occurred that require adjustment to or disclosure in the financial statements.

**(3) INVESTMENTS**

The Plan's investments are held by a trust fund administered by the trust division of BancFirst of Oklahoma. The Plan's investment fair values as of December 31 were as follows:

- Schedule H, line 4j—Schedule of Reportable Transactions for the year ended December 31, 2024, as shown on supplemental Schedule II.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### (5) POSTRETIREMENT BENEFIT OBLIGATIONS

The weighted-average healthcare cost-trend rate assumption (see Note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the postretirement benefit obligations as of December 31, 2024 and 2023, by approximately \$134,000 and \$146,000, respectively.

#### (6) PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's investments are held by the trust division of the Sponsor as trustee. For both of the years ended December 31, 2024 and 2023, the Plan paid the trustee \$5,000 for administrative expenses.

The Plan recognized total payables of approximately \$1,505,000 and \$1,551,000 to BCBS and Kempton for administrative expenses and claims paid by BCBS and Kempton during the years ended December 31, 2024 and 2023, respectively, which had not been reimbursed by the Plan as of the respective year-end.

The Sponsor provides certain administrative services at no cost to the Plan and does not expect to be reimbursed for the services provided.

#### (7) FAIR VALUES OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

**(7) FAIR VALUES OF PLAN ASSETS AND LIABILITIES, CONTINUED**

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits, as well as the general classification of such assets pursuant to the valuation hierarchy.

Money Market Fund

Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The money market fund is deemed to be actively traded.

There have been no significant changes in the valuation techniques during the year ended December 31, 2024 or 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**(8) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, inflation rates, healthcare inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.



