Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Description of plan

The following is a brief description of the Summit Ridge Energy 401(k) Plan and is provided for general purposes only. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General – Summit Ridge Energy 401(k) Plan (the Plan) was established January 1, 2017 and restated most recently on January 1, 2023. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all eligible employees. Employees are eligible to participate in the Plan on the first day of the month following employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has appointed Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) and Principal Life Insurance Company (Principal Life) to act as the trustees of the Plan and, as such, Principal Retirement Plan Processing Services acted as the recordkeeper.

Certain administrative functions are performed by officers or employees of Summit Ridge Energy, LLC (the Company or Plan Sponsor). No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Company.

Participant contributions – Participants may make salary contributions up to 100% of their compensation, subject to limitations of the IRC. The Plan has an auto-enrollment feature where eligible employees are automatically enrolled in the Plan at a pre-tax contribution percentage of 8% per pay period, unless they make an affirmative election not to contribute to the Plan or to contribute a different percentage. This auto-enrollment feature increases by 1% each year until reaching 15%. Employees can choose pre-tax contributions and after-tax Roth contributions or a combination of both, subject to the limitations of the IRC. Participants may, at any time, change their contribution percentage or suspend future deductions from their pay. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants are immediately fully vested in their salary deferral and rollover contributions.

Company contributions – In 2024, the Company contributed matching contributions equal to fifty percent of each participant's contribution up to the first eight percent of each participant's contribution. In addition, the Company can elect to make discretionary profit sharing contributions. In order to qualify for this discretionary contribution, a participant must be employed on the last day of the calendar year. There were no profit sharing contributions during the year ended December 31, 2024.

Vesting - To earn a year of service, a participant must be credited with at least 1,000 hours of service during a plan year for vesting purposes. Participants are vested immediately in their contributions plus actual earnings thereon and in the safe harbor employer match. Vesting in

the Company's discretionary profit sharing contribution portion of their accounts is based upon years of service, as defined. Vesting uses a graded scale; whereby a participant is 100% vested after 3 years of credited service.

Investment Options - Participants are afforded several investment options covering a wide range of investment objectives and risk. Participants may allocate their contribution across these options in any proportion they wish, and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time. As of December 31, 2024, participants have the choice of investing their contributions, along with Company contributions, in approximately 30 different investment options.

Forfeitures – Terminating participants forfeit the non-vested portion of the participant's employer discretionary profit sharing contributions. Forfeitures can be used to pay administrative expenses or to reduce the Company's discretionary contributions. During the year ended December 31, 2024, \$23,593 of forfeitures were used to pay administrative expenses and Company contributions. At year ends December 31, 2024 and 2023, the remaining balances in the unused forfeitures account was \$39,129 and \$23,593, respectively.

Participants' accounts – Individual accounts are maintained for each participant and include participants' salary deferral contribution, rollovers (transfers in from other qualified plans), the Company matching contribution and an allocation of the Company discretionary contribution (if any), plan earnings, and realized and unrealized gains and losses on investments. Discretionary Company contributions are allocated on a pro rata basis in proportion to each participant's share of total eligible compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits – Participants are eligible for retirement benefits upon attaining the age of 65. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account or installments over a period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or elect a direct rollover contribution. In-service distributions are also allowed for participants that are 100% vested and 59-1/2 years of age.

Hardship withdrawals – The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw part or all of their account balances while actively employed. These hardships withdrawals are subject to IRC restrictions and penalties

Notes receivable from participants – The Plan allows participants to borrow against their vested account balances, subject to IRC restrictions. Participant loans require periodic payments, bear interest at rates charged on similar commercial loans under like circumstances, and are due within 5 years. However, loans to purchase a principal residence may be repaid over a period longer than 5 years. Participant loans were \$75,960 and \$85,842 at December 31, 2024 and 2023, respectively. Interest rates as of December 31, 2024 range from 4.11% - 9.50% and loans mature by October 2033.

Note 2 – Summary of significant accounting policies

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value (with the exception of the fully benefit responsive contract as described in Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Investment transactions are recorded on the date of purchase or sale (“trade date”). Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Valuation of notes receivable from participants – This asset is stated at the unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document.

Payments of benefits – Benefits are expensed when paid.

Risks and uncertainties – The Plan invests in various investment securities. Such investments are exposed to various risks, such as interest-rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events – The Plan has evaluated events through October 31, 2025 in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.

Note 3 – Fair value measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). Fair value is determined based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. An asset or liability's classification is based on the lowest level of input that is significant to the fair value measurement. Assets and liabilities carried at fair value are classified and disclosed in one of the following categories:

Level 1 – Quoted market prices in active markets for identical assets or liabilities.

Level 2 – Observable market-based, or unobservable, inputs corroborated by market data.

Level 3 – Unobservable inputs reflecting management's own assumptions.

The following is a description of the valuation methodologies and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used. There are no plan assets requiring the use of level 3 inputs at December 31, 2024.

Mutual Funds – The fair value of the investments in this category are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The fair value of the investments in this category are valued at quoted market prices and are Level 1 in the fair value hierarchy.

Common Collective Trust – The fair value of the investments in this category have been estimated using the Net Asset Value (NAV) per unit provided by the trustee of the fund. The NAV of this account is based on the value of the underlying assets owned by the fund, minus liabilities divided by the number of shares outstanding. The NAV is not a publicly quoted price in an active market since the investments' unit prices are quoted on a private market that is not active; however, the unit price is based on the underlying investments which are traded on an active market.

Pooled Separate Accounts – The fair value of the investments in this category have been estimated using the NAV per unit provided by the trustee of the fund. The NAV of this account is based on the value of the underlying assets owned by the fund, minus liabilities divided by the number of shares outstanding. The NAV is not a publicly quoted price in an active market since the investments' unit prices are quoted on a private market that is not active; however, the unit price is based on the underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine fair value of certain financial

Note 4 – Fully benefit-responsive investment contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.30 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The current crediting rate is 1.65%. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

Note 5 – Information certified by the trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Principal and Principal Life, the

trustees, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

Principal and Principal Life have supplied the Plan administrator with certifications as to the completeness and accuracy of certain investment information presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) at December 31, 2024.

Note 6 – Tax status

The Plan is an adoption of a Principal Life Insurance Company non-standardized, pre-approved profit sharing plan with CODA designed to be qualified under the IRC as exempt from Federal income taxes, and has received a favorable determination letter dated June 30, 2020 from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Plan Management evaluates the tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax

periods in progress. Plan management believes it is no longer subject to income tax examinations for any years prior to 2021.

Note 7 – Plan termination

Although it has no present intention of doing so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

Note 8 – Related party and party-in-interest transactions

Under ERISA rules related to 401(k) plans, transactions with related parties of the plan such as plan sponsor, administrator, trustee or participant (party-in-interest) are considered either exempt or nonexempt from ERISA prohibited transaction provisions. Nonexempt transactions are subject to penalty and/or taxes.

Certain Plan investments and the related transactions at December 31, 2024 and 2023 are invested in funds sponsored by Principal and Principal Life. Principal and Principal Life are also the Plan's trustees. Transactions involving these investments are considered to be party-in-interest transactions for which statutory exemption exists under the Department of Labor Regulations. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.
