## INDEPENDENT AUDITORS' REPORT

Board of Trustees

### Opinion

We have audited the accompanying financial statements of Local 231 IBEW Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Local 231 IBEW Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

### **General**

The Plan is a participant-directed defined contribution retirement savings plan covering eligible employees (Participants) as provided by collective bargaining agreements (Agreements) between Local 231, Sioux City, Iowa, International Brotherhood of Electrical Workers (Union) and Sioux City Division, National Electrical Contractors Association (Association). A trust, with Trustees designated by the Union and Association, has been established to manage and operate the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

The Plan receives contributions from participating employers who are in the electrical industry in northwest Iowa, northeast Nebraska, and southeast South Dakota. Participating employers are required to contribute a specified amount per hour of covered compensation to the plan based on the collective bargaining agreement in effect for each classification of employee. Employers must remit the contributions to the Plan along with a report on a monthly basis. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) where allowed under the terms of the plan. There is no collateral or other security held by the Plan to secure these contributions. Contributions from participating employers are fully funded. Reciprocity contributions are received through reciprocity agreements with other jurisdictional areas. Participants are also able to make contributions to the Plan under the Plan's 401(k) provision.

### **Participant Accounts**

Each participant's account is credited with the employers' contribution for the participant and each participant self-directs his or her own investments. Each participant's account is charged a quarterly service charge which is used by the plan to pay administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### **Vesting**

Participants become immediately 100% vested in employer contributions and earnings (losses) and are also immediately 100% vested in their own contributions and earnings (losses) thereon.

### **Payment of Benefits**

Provisions relating to payments of vested benefits are as follows: (1) Participants or their beneficiaries may, at date of disability, death or termination with a required waiting period, elect to receive one of several options, including a lump sum benefit or receive an annuity; or (2) at retirement each Participant may elect one of several options, including a lump sum benefit or an annuity arrangement.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for details.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Revenue Recognition**

Employers' contributions receivable represents accrued employer contributions for the current year that were received after the end of the year. Delinquent employer contributions are not recorded as revenue until the amounts are known and received. This effectively establishes an allowance for doubtful accounts of all outstanding delinquent contributions that the amounts are either not yet known or collected. As of January 31, 2025 and 2024 there were no outstanding contributions that were known but were not deemed collectible.

#### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution. As of January 31, 2025 and 2024, there was none payable to participants who had requested distribution from the Plan prior to year-end, but did not receive the distribution until after year-end.

#### **Risks and Uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Date of Management's Review**

Subsequent events were evaluated through November 1, 2025, which is the date the financial statements were available to be issued.

### NOTE 3 – TAX STATUS

The Internal Revenue Service has informed the Plan Sponsors by a letter dated June 9, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan sponsor believes that the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management of the Plan believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 4 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Board of Trustees have the right under the Plan provisions to discontinue contributions at any time and to terminate the Plan. In the event of termination of the Plan, the net assets will be distributed according to the Plan document and as required by ERISA. Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

### NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2025 and 2024.

*Fixed Annuities:* This is a guaranteed income fund that is a group annuity product issued by Empower Annuity Insurance Company (EAIC). The values are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

*Money Market Funds:* Valued at cost, which is equal to the net asset value of shares held at year end.

*Mutual Funds:* Valued at the net asset value of shares held by the Plan at year-end.

*Collective Investment Trust and Pooled Separate Account:* Valued at the Net Asset Value (NAV) of units of the fund held by the Plan based on the fair market value of the underlying investments of the fund. The funds do not have a finite life, there are no unfunded commitments or significant restrictions on redemptions relating to these types of investments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets identified as participants account balances are assets that are specifically allocated to each members' account at Empower Annuity Insurance Company of America.

The Plan used to withhold \$5.00 per month per active employee for benefit crediting purposes and also for administrative purposes. These assets are in the "Unallocated net assets - crediting account". Effective with June, 2017 work month, the \$5 administrative fee is no longer withheld from participant's contributions. The crediting account now just earns interest.

The Plan also charges a service charge to each participant's account to pay administrative expenses. The Plan charges \$80 per participant per quarter. These assets are in the "Unallocated net assets – administrative" account.

The Plan also charged a quarterly fee of \$15.00 to participants to pay for Empower's services.
