## INDEPENDENT AUDITORS' REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed audits of the financial statements of Shockwave Medical, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 7, 2025 (liquidation basis) and December 31, 2024 (ongoing basis), and for the period from January 1, 2025 through May 7, 2025 (liquidation basis), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, during 2024 the Plan sponsor elected to terminate the Plan. Effective May 2025, the Plan and all participant assets were fully liquidated. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2024 financial statements, to the liquidation basis used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

#### **Note 1: Description of Plan**

The following description of the Shockwave Medical, Inc. 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established by Shockwave Medical, Inc. (the "Company" or "Plan Sponsor") on January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan provides benefits for all eligible employees of the Company. Effective January 1, 2025, the Plan was amended to become frozen and contributions were suspended at the effective date. The amendment froze all contributions into the Plan, except for loan payments and rollovers.

The Plan is administered by the Company, who retained the services of Fidelity Management Trust Company ("Fidelity") as the trustee and third party administrator of the Plan's assets through May 7, 2025.

**Transfer of assets:** In May 2025, in connection with the Plan merger described in Note 6, \$100,008,706 was transferred into the Retirement Plan of Johnson & Johnson and Affiliated Companies ("J&J 401(k) Plan").

**Eligibility:** All employees of the employer are eligible to participate in the Plan once they have attained a service eligibility requirement of one month, except for employees covered by collective bargaining agreements and leased employees. Once these service requirements have been met, participants will be eligible to participate on the next first day of the month.

**Participant contributions:** Participants may elect to contribute up to 90% of their eligible compensation subject to the maximum allowed under section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan period can elect to contribute up to 90% of eligible compensation as catch-up contributions. Participants are also permitted to deposit into the Plan distributions received from other plans (rollovers). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set initially at 5% of eligible compensation. The Plan includes a provision to allow after-tax contributions at a limit of 90% of employee's eligible compensation.

**Employer matching contributions:** The Plan provides for discretionary employer matching contributions to be determined by the Plan Sponsor. The Company has the right to discontinue and reinstate the discretionary employer matching contributions. For the period ended May 7, 2025, the Plan Sponsor elected to not make any matching contributions.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** The Plan provides for investments to be directed by participants into a number of investment options held by the trustee. Participants may change their investment options daily. Upon enrollment in the Plan, a participant may direct employee contributions into investment options consisting of mutual funds and a money market fund of varying risks. Earnings of each investment fund are allocated to participant's accounts in proportion to each participant's share of that fund.

**Vesting:** Participants are immediately vested in their contributions, including rollovers of funds from other qualified retirement plans and earnings thereon. Participants are immediately vested in employer matching contributions.

**Notes receivable from participants:** Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at market financing rates. Note terms range from one to five years, but may not exceed five years except for notes used for a purchase of a primary residence, which may be repaid over a longer period of up to fifteen years. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** On termination of service due to normal retirement age, disability, death, or termination of employment, the entire balance in the participant's deferral account as well as the participant's vested balance in the Company's contributions may be distributed to the participant (or, if applicable, the beneficiary) in a lump sum or partial payment, rolled over into another qualified plan, or left in the Plan (subject to minimum balance requirements). Unless otherwise instructed by the participant, participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested accounts balances ranging from \$1,000 to \$7,000 will automatically be rolled over to an individual retirement account ("IRA") or another retirement plan eligible to receive rollover contributions.

As an active participant in the Plan, a participant may, upon attaining age 59 1/2, request the distribution of his or her balance. In addition, a participant may apply for a hardship withdrawal, if he or she is experiencing an immediate and heavy financial need as defined by the specific criteria in the Plan document.

**Administrative expenses:** Substantially all administrative expenses of the Plan are paid by the Company. Separate fees for loan processing and certain investments as specified in the service agreement, are charged to individual participant's accounts.

**Forfeited accounts:** Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining forfeitures may be used to reduce future employer contributions. Forfeitures remaining in the Plan as of December 31, 2024 were immaterial and there were none remaining as of May 7, 2025. Forfeitures used to fund employer contributions for the period from January 1, 2025 through May 7, 2025 were immaterial.

#### **Note 2: Significant accounting policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are stated at fair value. The shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset values of shares held by the Plan at period end. The money market fund is valued at cost plus accrued interest, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Fair value measurements:** The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan's investments.

**Net appreciation (depreciation) in fair value of investments:** The earnings, expenses, realized gains and losses, and unrealized appreciation (depreciation) in registered investments companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through the date that the financial statements were available to be issued which is the date of the independent auditors' report.

#### **Note 3: Fair value**

The Plan performs fair value measurement in accordance with ASC 820. ASC 820 defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value calculation may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of May 7, 2025, the Plan held no investments. Investments measured at fair value on an ongoing basis consist of mutual funds and a money market fund as of December 31, 2024 and have all been determined to be level 1 by the Plan Sponsor.

#### **Note 4: Investments**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, the trustee of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements.

The following information included in the financial statements was provided by and certified by the Plan's trustee as complete and accurate:

- Investments as shown in the Statement of Net Assets Available for Benefits as of May 7, 2025 (liquidation) and December 31, 2024 (ongoing).
- Notes receivable from participants as shown in the Statement of Net Assets Available for Benefits as of May 7, 2025 (liquidation) and December 31, 2024 (ongoing).
- Investment income (loss) and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2025 through May 7, 2025.

#### **Note 5: Party-in-interest transactions**

Fidelity, the Plan's trustee, serves as Plan fiduciary, investment manager, custodian, and third party administrator to the Plan. As of May 7, 2025 and December 31, 2024, the Plan held for investments an aggregate of approximately \$0 and \$100,958,000, respectively, in Fidelity mutual funds and a Fidelity money market fund.

#### **Note 6: Plan termination**

In May 2024, the Company was acquired by Johnson & Johnson, at which time it was determined the Plan's assets will be transferred into the J&J 401(k) Plan upon finalized. Effective January 1, 2025, the Plan was amended to suspend all employee contributions, to begin the liquidation process. As a result of the acquisition, terminated participants became 100% vested in their employer matching account balances. As of May 7, 2025, all assets were liquidated or transferred into the J&J 401(k) Plan.

#### **Note 7: Income tax status**

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent to receiving this opinion letter, the prototype plan was amended. The Plan administrator believes that the amended prototype plan, as adopted by the Company, is operating in compliance with the requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8: Risks and uncertainties**

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
