Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Language Line Services 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Language Line Services 401(k) Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Language Line Services 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Language Line Services 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Note 1 – The Plan and Its Significant Accounting Policies

General – The following description of the Language Line Services 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement and amendments for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established on August 1, 1999, by Language Line, LLC (the Company and Plan Sponsor) to provide benefits to eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration – The Company has appointed an Investment Committee (the Committee) to manage the operation and administration of the Plan. Additionally, the Company has contracted with Lincoln Financial Group Trust Company, Inc. (Lincoln Financial), to act as the trustee and custodian, and an affiliate of Lincoln Financial, to act as the third-party administrator to process and maintain the records of participant data.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses – Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor, as provided in the plan document. Certain fees paid by the Plan for investment management services are netted against net appreciation in fair value of investments.

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Forfeited nonvested amounts – Forfeited nonvested amounts are used to reduce administrative fees or to reduce future Company contributions.

Investment valuation and income recognition – The Plan's investments are reported at fair value and contract value. The Plan's trustee, Lincoln Financial, certifies the contract value of the fixed annuity contract, and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits – Distributions to participants are recorded when paid.

Income taxes – The Plan has adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risks and uncertainties – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent events – The Plan has evaluated subsequent events through November 3, 2025, which is the date the financial statements were available to be issued.

Note 2 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest priority level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation method used for investments measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023:

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Plan investments include a fixed annuity investment contract managed by Lincoln National Life Insurance Company, a related party to the Plan's trustee. Therefore, any related transactions qualify as party-in-interest transactions. Any purchases and sales of such annuity are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Note 4 – Participation and Benefits

Eligibility – All employees of the Company are eligible to participate in the Plan, except employees who are leased employees or contract workers, and there is no age requirement.

Participant contributions – Participants may contribute up to 60% of their annual compensation, as defined, on a pre-tax or after-tax basis (as Roth contributions), limited to the maximum amount allowed by the IRS (\$23,000 in 2024). Additionally, participants age 50 and older may make catch-up contributions of up to \$7,500 in 2024.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions – For participants that have completed six months of service, the Company makes safe harbor matching contributions equal to 100% of the first 3% of compensation that a participant contributes to the Plan and 50% of the next 2% of contributed compensation. Additionally, the Company may make discretionary matching contributions. No discretionary matching contributions were made in 2024.

Vesting – Participants are immediately 100% vested in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Discretionary employer matching contributions are not vested until completion of three years of service, at which time they become 100% vested.

Participant accounts – Individual accounts are maintained for each participant. Each participant may elect to have his or her individual account invested in any combination of the investment options available under the Plan. Participant gains and losses are valued on a daily basis and an allocation is received at the end of each business day.

Payment of benefits – Upon retirement, termination, disability, or death, the vested value of the participant's account may either be distributed in a lump-sum payment or in partial distributions. With the plan administrator's approval, participants may withdraw all or part of their elective deferrals in the event of financial hardship. The Plan allows for automatic distribution of participant vested account balances that do not exceed \$7,000 (\$5,000 prior to April 1, 2024).

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one outstanding loan at a time. Loan repayment terms shall not exceed five years, with the exception of loans for the purchase of a primary residence, for which repayment beyond five years is eligible. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with maturities through September 2039.

Note 5 – Fixed Annuity Contract

The Plan has a fixed annuity investment contract, the Lincoln Stable Value Account (the Contract), designed to provide liquidity and safety of principal, along with a competitive guaranteed rate of return. Lincoln National Life Insurance Company invests the deposits of plan participants as part of its general account assets and guarantees return of principal and interest. A participant's return is determined by a declared interest rate, which is reset every six months, and will never be less than 1.0%.

The Contract meets the fully benefit-responsive contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value and represents contributions made, less withdrawals and administrative expenses, plus interest credited.

Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

No event will result in the Plan not being able to receive contract value over a five-year installment period. Any of the following events can trigger termination by the issuer, resulting in the plan not being able to receive immediate contract value:

- Any charges billed to the contract owner that have not been paid to Lincoln Financial Group Trust Company, Inc. (Lincoln), within 30 days.
- The Plan ceases to meet the requirements of the Internal Revenue Code for purchasers of this contract.
- At any time following the end of the third contract year, the contract owner's account balance is less than \$15,000.
- At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000.
- The contract owner fails to furnish requested information or other documentation.
- Lincoln discovers any misrepresentation of material information.

- Lincoln discontinues offering this contract form to the public.
- The Plan terminates its recordkeeping agreement with Lincoln.

Note 6 – Plan Termination or Modification

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 7 – Certified Investment Information

The following information related to investments and notes receivable was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net realized and unrealized appreciation in fair value of investments, dividends, and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 8 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.

Note 9 – Subsequent Events

Effective January 1, 2025, AllianceOne, Inc. (related entity to the Company) became a participating employer in the Plan. As a result, on January 24, 2025, assets of approximately \$11,400,000 were transferred from the TPUSA 401(k) Plan, representing the accounts of participants who are employees of AllianceOne, Inc., into the Plan.

Effective January 1, 2025, PSG Global Solutions LLC (related entity to the Company) became a participating employer in the Plan. As a result, on January 29, 2025, assets of approximately \$4,000,000 were transferred from the ADP TotalSource Retirement Savings Plan, representing the accounts of participants who are employees of PSG Global Solutions LLC, into the Plan.

Effective March 1, 2025, participants aged 60 to 63 will be eligible for an increased catch-up contribution limit. For 2025, the maximum increased catch-up contribution is \$11,250.
