Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spring Oaks Capital 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) Description of Plan

The following brief description of the Spring Oaks Capital 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Spring Oaks Capital, LLC (the Company), who have attained the age of 21, except persons engaged as independent contractors or as specific project workers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

New employees will be required to complete 90 days of service in addition to the requirements above to be eligible for participation in the Plan. An employee will be automatically enrolled at a 6% pre-tax deferral on the first day of the month following the date they become eligible, unless the participant opts out or elects to enroll at a different deferral rate.

Contributions

Participants may contribute up to 100% of eligible compensation, as defined by the Plan. Annual salary deferrals (pre-tax and Roth) are limited to the maximum allowable amount under the Internal Revenue Code (IRC) (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (a maximum of an additional \$7,500 during 2024). Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes safe harbor matching provisions whereby safe harbor matching contributions are made in an amount equal to 100% of the participants' elective deferral up to 3% of the participant's eligible compensation and 50% of the participant's elective deferral on the next 2% of the participant's eligible compensation. The Company may also make discretionary employer contributions to the Plan. There were no discretionary employer contributions for 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as allocations of plan earnings and losses. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participating earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their contributions from all sources, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, and the combined maximum loans outstanding may not exceed the lesser of 50% of the participant's vested account balance or \$50,000. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest at rates ranging between 6.75% and 10.50%, which are set at 2% above the prime rate at the time of loan issuance, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability retirement or other reasons, a participant with an account balance in excess of \$5,000 may elect to receive either a lump-sum amount equal to the value of his or her accounts, or in monthly installments based on various annuity options. A terminated participant with an account balance less than \$5,000 will receive a lump-sum payment of the balance through either a rollover contribution to an IRA or direct cash out. Benefits are payable upon retirement at age 65, death, disability or termination of employment. The Plan allows for in-service distributions if a participant reaches 59 ½, qualified reservist withdrawals, and hardship distributions. The Plan also allows participants to withdrawal amounts representing rollover contributions. Age 59 ½ distributions and distributions of rollover contributions are limited to 1 withdrawal in a 12 month period.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts may be used to pay administrative expenses or to reduce future employer contributions. During 2024, employer contributions of the Plan were reduced by \$19,782.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

(3) Investment Information Certified by Qualified Institutions

Certain information related to the investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and contract value at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, except for interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (Principal Life), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust), and Principal Global Investors Trust Company (Principal Global), (Principal Life, Principal Trust, and Principal Global collectively referred to as "Principal"), qualified institutions.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology on adjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective investment trusts / pooled separate accounts: Valued at net asset value (NAV) of units of a common collective trust or pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

(5) Guaranteed Investment Contract with Insurance Company

The Plan offers a benefit-responsive guaranteed insurance contract with Principal Life, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023 is \$20,350 and \$7,554, respectively. The crediting rate is based on a formula established by the contract issuer and is 1.55% at December 31, 2024 and 2023.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all of or a portion of their investment at contract value.

(5) Guaranteed Investment Contract with Insurance Company, Continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, and (4) failure of the trust to qualify for exemption under ERISA. The plan administration does not believe that the occurrence of any events which would limit the Plan's ability to transact at contract value with participants is probable.

The guaranteed investment contract does not have a defined maturity specified in the contract. The contract shall terminate on the date when no current deposit arrangements have been made between the Plan and Principal Life and there are no guaranteed interest funds with a value greater than zero under this contract. Provisions relating to annuities in the course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares or units or pooled separate accounts, collective investment trusts, and a guaranteed investment contract managed by Principal. Principal is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules of ERISA. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(8) Tax Status

The Plan uses a standardized pre-approved plan document sponsored by Principal Life. The Internal Revenue Service (IRS) determined and informed Principal Life by a letter dated June 30, 2020 that the prototype plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting policies generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that, such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(10) Prohibited Transactions

During 2024 and 2022, the Company failed to timely remit to the Plan's trustee certain employee withholdings totaling \$2,539, and \$133, respectively, within the period prescribed by DOL regulations. These delinquent contributions are considered prohibited transactions as defined by ERISA. During 2024, the Company corrected the 2022 delinquent contributions as well as delinquent contributions identified in March 2024. The Company intends to correct the remaining delinquent contributions and related lost earnings in 2025.
