Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Premier Diagnostic Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.



Note 1 - Description of Plan

The following description of the Premier Diagnostic Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Premier Diagnostic Services, Inc. (the "Company"). Employees must complete one month of service and have attained the age of twenty-one to be eligible participants and to be entitled to receive safe harbor matching contributions. Additionally, employees must complete one year of service to receive non-elective Company contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA").

Contributions - The Plan contains salary reduction features under Internal Revenue Code Section 401(k). The Plan allows for salary reduction contributions for each participant. Participants may contribute up to the maximum amount allowed by law. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers units of participation in a common/collective trust and investments in various mutual funds provided by Principal Life Insurance Company. The Company makes safe harbor matching contributions and has the option of making discretionary matching and non-elective contributions. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary reduction contributions, safe harbor matching contributions, and rollover contributions received from other plans that are permitted by the administrator plus actual earnings thereon. Vesting in the Company discretionary matching and non-elective contributions plus actual earnings thereon is based on years of continuous service. A participant becomes fully vested after 5 years of service.

A participant can also become fully vested in the employer's discretionary matching and non-elective contributions to their account, if the participant becomes disabled, retires at or after age 59½, or dies, regardless of the participant's years of service at that time.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid over a period no longer than 5 years, unless the note is used to acquire a participant's principal residence, in which case, the term may not exceed 10 years. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 1 - Description of Plan (continued)

Payment of Benefits - On termination of service, a participant may elect to receive the value of his or her vested account.

Administrative Expenses - The Company incurs and pays certain administrative expenses associated with the Plan.

Plan Termination - If the Company terminates or partially terminates the Plan, or if contributions are permanently discontinued, all accrued benefits and accounts are non-forfeitable to the extent then funded and shall be paid to participants in accordance with the provisions of the Plan. A participant's recourse to the satisfaction of his or her rights shall be limited to Plan assets.

Forfeited Accounts - At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$2 and \$913, respectively. Forfeited non-vested accounts may be used to reduce future employer matching 401(k) contributions. During the plan year ended March 31, 2025, employer contributions were reduced by \$8,241 from forfeited non-vested accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting whereby revenues are recognized when earned and expenses are recognized when incurred. The Form 5500 is converted to the cash basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of March 31, 2025 and 2024, no allowance for credits losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - Certain operating expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Uncertain Tax Positions - The Plan's income tax filings are subject to audit by various taxing authorities. The Plan believes its tax positions will be sustained upon examination by taxing authorities. There are no uncertain tax positions for the years ended March 31, 2025 and 2024.

Reclassification - Certain amounts in the 2024 financial statements have been reclassified to conform to the 2025 presentation.

Note 3 - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Plan entered into a benefit-responsive investment contract in the Principal Stable Value Z Fund (the "Fund"), a common/collective trust fund. The Fund's investment objective is to preserve principal while providing a competitive current rate of return. The Fund will be invested and reinvested primarily in guaranteed investment contracts ("GICs"), money market funds, money market instruments, repurchase agreements, private placements, bank investment contracts and synthetic GICs.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at March 31, 2025 and 2024 amounted to \$475,709 and \$439,125, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contract does not permit the common/collective trust to terminate the agreement prior to the scheduled maturity date.

Note 6 - Related Party Transactions

All of the following party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Transactions with Plan Sponsor

Certain Plan investments are shares of common/collective trusts and mutual funds managed by the Plan sponsor.

Notes Receivable from Participants

Notes receivable from participants are party-in-interest transactions.

The Company and its Officers

Certain officers of the Company provide services for the Plan. The Company also pays certain administrative expenses of the Plan.

Note 7 - Tax Status

The Volume Submitter Plan Administrator has informed the Company that the Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Subsequent Events

The Plan has evaluated all subsequent events through September 19, 2025, the date the financial statements were available to be issued. The Plan did not have any recognized or non-recognized subsequent events after March 31, 2025, the date of the financial statements.
