## Independent Auditors' Report

**1. Description of Plan**

The following description of the Defined Contribution Pension Plan for Employees of Westchester Visiting Nurse Services Group, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan established by Westchester Visiting Nurse Services Group, Inc. ("VNSW" or "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. VNSW is the sponsor of the Plan and the insurance company is Mutual of America Life Insurance Company (Mutual of America). The insurance company manages the investments of the Plan. In addition, the insurance company provides recordkeeping services for the Plan.

***Eligibility***

Employees become eligible to participate in the Plan upon reaching the age of 21 and completing one year of service, provided the employee has worked at least 1,000 hours during the first 12 months of employment or has worked 1,000 hours within any subsequent 12-month period beginning on his/her anniversary date. For purposes of eligibility, an employee's service with the Visiting Nurse Services in Westchester, Inc., Union Plan shall be counted towards the minimum service requirement, provided he/she rendered at least 1,000 hours of service during such employment for each year of prior service.

***Participant Accounts***

The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with the applicable portion of the Employer's contribution and an allocation of Plan earnings (net of administrative expenses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

***Contributions***

The Employer will contribute 6% of eligible compensation for each eligible employee.

***Vesting***

Employees become vested in the Employer's contributions as follows:

**1. Description of Plan (continued)**

***Loans to Participants/Collateralized Assets***

Participants may borrow from Mutual of America and use their Plan account balance (invested in the guaranteed interest contract) as collateral. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balance of \$50,000. The loan bears interest at a rate commensurate with local prevailing rates at the time the funds are borrowed as determined by Mutual of America. Loan terms range from 1 to 5 years; however, terms may exceed 5 years, but not to exceed 10 years, for the purchase of a primary residence. The collateral must be equal to or exceed 120% of the loan, and payments on the loan are made outside the Plan. Therefore, the loans are not shown on the statements of net assets available for benefits. As of December 31, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$337,177 and \$271,513. At December 31, 2024, the loans had interest rates at 5.85% with maturities through 2034.

***Forfeitures***

If a participant terminates employment and is less than 100% vested in their employer contributions, the participant will forfeit the non-vested portion of their account. Forfeited non-vested amounts are used to reduce future employer contributions. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$7,822 and \$3. During 2024, forfeitures of \$31,068 were used to reduce employer contributions.

***Payment of Benefits***

Subject to the vesting rules, employees are entitled to pension benefits beginning at the normal retirement age of 65. However, an employee may elect to retire at age 55 and receive a retirement benefit or delay such payments until April 1 of the calendar year following the year in which the employee attains the age of 70½. The benefits payable is based on the vested portion of amounts contributed for the employee plus earnings on such funds. Employees may elect to receive their benefits under several payment options, including life annuity; 10 or 15-year certain and continuous, joint, and survivor annuities; full cash refund annuity; and lump-sum distribution. The Plan also provides for death benefits, payable to the employee's designated beneficiary, should the employee die before retirement.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

***Investment Valuation and Income Recognition***

All of the Plan's investment are stated at fair value. Separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The investment in the insurance company general account is reported at fair value, which is based on the contract value as reported by the insurance company. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Because the investment is not actively traded and relies on valuation inputs provided by the insurance company, it is considered an estimate of fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan may be paid by the Employer and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in value of investments.

***Reclassification***

Certain amounts and level classification for separate accounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation. The change in assets available for benefit is unchanged due to these reclassifications.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is November 3, 2025.

### **5. Insurance Company General Account**

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America Life Insurance Company (“Mutual of America”). Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of the general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.50% or more than 3.00% in any event. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The Mutual of America Interest Accumulation Account is not a fully benefit-responsive investment contract and may be subject to withdrawal or transfer restrictions under certain plan or contract provisions.

The principal and previously credited interest are guaranteed by Mutual of America. This guarantee is subject to Mutual of America’s financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), Standard and Poor’s (A as of December 2022), and Fitch (BBB+ as of April 2025).

The Mutual of America Interest Accumulation Account represents approximately 29% and 32% of the net assets available for benefits as of December 31, 2024 and 2023.

### **6. Separate Accounts**

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan’s separate accounts include various asset classes which are: equity funds, fixed income funds, growth funds, money market funds, balanced funds, bond funds, asset allocation funds, and retirement funds.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

**8. Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the plan document preparer by a letter dated November 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**9. Party-in-Interest Transactions**

All investments of the Plan are managed by Mutual of America Life Insurance Company, the asset holder and record-keeper of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA. During the Plan year ended December 31, 2024 fees in the amount of \$2,859 were paid to Mutual of America for Plan related services.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals, and no costs are charged to the Plan.

**10. Risks and Uncertainties**

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
