### Notes to the Financial Statements

#### 1. Description of Plan

The following description of the TTAI 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 1997 and was restated effective January 1, 2024. The Plan covers all eligible employees of Toyotetsu America, Inc. (the Plan Sponsor and Administrator) and these other employers, Toyotetsu Mid America, LLC. (TTMA) and Toyotetsu Texas, Inc. (TTTX), both majority owned subsidiaries of the Plan Sponsor and Fukai Toyotetsu Indiana Corporation (FTIC) and Y-tec Keylex Toyotetsu Alabama, Inc. (YKTA), both joint ventures of the Plan Sponsor.

##### Eligibility

The Plan covers all employees who are at least age 18, and who have completed one month of service. Employees can begin participating in the Plan on the first day of the month following attainment of eligibility requirements. At that time, participants can begin deferring compensation into the Plan, and become eligible for the employer matching.

##### Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC) including Roth contributions. New employees may transfer assets from their former employers' qualified plans to the Plan, but cannot make any further contributions to the Plan until they have met the eligibility requirements to participate in the Plan.

Effective January 1, 2024, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Participants may elect to change their elective contribution percentages at any time during the year. Participants may direct contributions to any of the Plan's investment options. The Plan provides several mutual funds and a stable value fund as investment options.

The Plan allows for the Plan Sponsor to make matching contributions on behalf of participants as a percentage of the participants' elective contributions. This matching percentage may be determined from year-to-year by the Plan Sponsor. For 2024, the matching contribution was 50% of the first 6% participant elective pre-tax contributions.

##### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Plan Sponsor's contributions, an allocation of Plan earnings or losses, and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined in the Plan agreement.

#### 1. Description of Plan, continued

##### Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching contributions and forfeitures received from terminated accounts, and earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service with 20% vesting earned for each individual service year. Employees become fully vested in the Plan Sponsor's contributions upon retirement, permanent disability, or death.

##### Payment of Benefits

Upon retirement, disability, death or termination of employment, a participant may receive the vested portion of his or her account balance. The payment of benefits may be in the form of a lump-sum distribution or installment payments. If a participant's account balance does not exceed \$5,000, it will be paid in one lump-sum cash payment.

Upon approval by the Plan Administrator, participants may also make withdrawals under hardship cases. In such cases, the hardship withdrawal is limited to the determined level of need, not to exceed the available vested accounts.

##### Forfeited Accounts

Forfeited non-vested accounts are first made available to reinstate previously forfeited account balances of former participants that meet certain criteria. The remaining forfeitures may be reallocated to eligible participants, used to reduce Plan Sponsor contributions, or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$167,460 and \$197,757, respectively. During the year ended December 31, 2024, forfeitures totaling \$185,204 and \$57,646 were used for Plan expenses and to reduce employer contributions, respectively. There were \$206,251 of forfeited participant balances during 2024.

##### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

##### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. All other administrative expenses are paid by the Plan Sponsor.

### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through November 5, 2025, the date that the financial statements were available to be issued. Except as disclosed in Note 10, there were no other events occurring during the evaluation period that require recognition or disclosure in the financial statements.

### 3. Information Certified and Provided by Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by American Trust, the current trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustees related to the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the supplemental schedule.

The following table presents the fair value of assets (except for fully benefit-responsive investment contracts, which are reported at contract value) in the Plan that were certified by American Trust:

American Trust also certified to the completeness and accuracy of \$8,290,297 of net realized and unrealized appreciation in the fair value of investments and \$1,447,803 of interest and dividends related to the investments for the year ended December 31, 2024.

### 4. Fully Benefit-Responsive Investment Contract

The Unified Trust Stable Value Fund (the Fund), an investment option provided by the Plan, has entered into a fully benefit-responsive guaranteed investment contract (GIC) with Unified Trust. The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported by Unified Trust. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because changes in market interest rates affect the yield to maturity and the market value of the underlying investments, they can have a material impact on the contract's interest crediting rate. In addition, participant withdrawals and transfers from the Plan are paid at contract value but funded through the market value liquidation of the underlying investments, which also impacts the interest crediting rate. The embedded market value losses will be amortized in the future through a lower interest crediting rate than would otherwise be the case. The amortization of the embedded market value gains will cause the future interest crediting rate to be higher than it otherwise would have been.

#### 4. Fully Benefit-Responsive Investment Contract, continued

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- (a) The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code; or
- (b) Amendments to Plan documents, including complete or partial termination or merger with another plan; or
- (c) Changes to the Plan's prohibition on competing investment options; or
- (d) Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### 5. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

### 6. Exempt Party-in-Interest Transactions

The Plan has a benefit-responsive investment contract with Unified Trust, a division of American Trust, who serves as the Plan's trustee; therefore, the transactions involving the benefit-responsive investment contract qualify as exempt party-in-interest transactions. Administrative expenses of \$242,206 for the year ended December 31, 2024 were paid to third party administrators for investment advisory, management services and withdrawal charges.

Additionally, indirect fees are paid to American Trust based on investment account values. These fees range from 0.01% to 1.08% of the investment account value. The fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan uses a prototype Plan document sponsored by Unified Trust. Unified Trust received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 8. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.
