## INDEPENDENT AUDITORS' REPORT

Plumbers and Pipefitters  
Local Union #286 Death Benefit Fund

### **Opinion**

We have audited the financial statements of Plumbers and Pipefitters Local Union #286 Death Benefit Fund (the Plan), which comprise the statements of net assets available for benefits - modified cash basis as of May 31, 2025 and 2024, the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - modified cash basis of the Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits - modified cash basis for the years then ended, in accordance with the modified cash basis of accounting described in Note B.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements are prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Notes to the Financial Statements

May 31, 2025 and 2024

#### NOTE A - DESCRIPTION OF PLAN

The following description of the Plumbers and Pipefitters Local Union #286 Death Benefit Fund (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### General

The Plan was formed under the bylaws of the United Association of Journeymen and Apprentices of the Plumbing & Pipefitting Industry of the United States and Canada, Local Union #286 (the Local). The Plan covers all members of the Local.

##### Contributions and Benefits

Participants contribute \$10 to the Plan upon notification by the Union that a member has deceased. Benefits are disbursed to beneficiaries upon notification of the death of a participating member or a retired member. Effective April 21, 2025, the Plan was amended to increase the death benefit paid to a beneficiary from \$14,000 to \$16,000. If an individual ceases to be a member of the Local, they also cease to be a participant and all of their contributions will be forfeited to the Plan.

##### Termination

The Plan may be terminated at any time by the Local.

##### Administration Costs

Taxes and any reasonable administrative expenses may be paid out of the corpus or income of the Plan.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Method of Accounting

The Plan uses the modified cash basis of accounting to present its financial statements. This method recognizes receipts when received by the Plan or the Local rather than when earned and disbursements when paid by the Plan or the Local rather than when the obligation is incurred. This method is a comprehensive basis of accounting other than generally accepted accounting principles.

##### Use of Estimates

Management uses certain estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were assumed in preparing the financial statements.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Federal Income Tax Status

The Plan is intended to qualify pursuant to the appropriate section of the Internal Revenue Code as a tax-exempt organization. The Plan received a letter from the Internal Revenue Service dated April 20, 2005, stating that it has determined that the Plan is exempt from federal income tax under section 501 (c) (9) of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management of the Plan believes it is no longer subject to income tax examinations for years ending May 31, 2022, and after.

Subsequent Events

Management of the Plan has evaluated subsequent events for disclosure through the date of the independent auditors' report, the date the financial statements were available to be issued.

NOTE C - PARTY-IN-INTEREST TRANSACTIONS

Income is deposited into the Local's general bank account and subsequently transferred into the Plan's bank account.

NOTE D - CONCENTRATIONS OF RISK

The Local's membership is comprised of professional plumbers and pipefitters. Plumbers and pipefitters are an integral part of the construction industry and public utilities. Therefore, any changes in the construction industry could significantly impact the Local's membership and ultimately cause significant impact on the financial condition of the Plan.
