Opinion

We have audited the financial statements of National Master Trust (a California trust), an element of a group insurance arrangement subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of National Master Trust as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Master Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about National Master Trust's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current trust instrument, including all trust amendments, administering the trust, and determining that the trust's transactions that are presented and disclosed in the financial statements are in conformity with the trust's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 - Description of the Trust

The following brief description of the National Master Trust is provided for general information purposes only. Participants should refer to the trust agreement for a more complete description of the Trust's provisions.

General

National Master Trust ("NMT" or the "Trust") is comprised of three operating subtrusts (the "Subtrusts"). The Independent Insurance Agents Group Insurance Trust; The Insurance Industries Group Insurance Trust; and The National Group Trust - California.

NMT is an element of a group insurance arrangement, which fully insures the welfare plans of each participating employer and, through the Subtrusts, is the holder of the insurance contracts and the conduit for payment of premiums to the insurance companies. Each Subtrust, with its large participation, is able to purchase insurance from high quality insurance carriers at competitive rates.

Kelsey National Corporation ("KNC" or the "Insurance Coordinator") is the insurance coordinator for the Trust and Mellon Trust of California ("Trustee") is the trustee of the Trust. The Trustee and Insurance Coordinator responsibilities are defined in the Trust Agreement.

Trust Administration of Premiums Received and Paid

KNC negotiates master policies with major insurance carriers ("Carriers") who issue these policies to the appropriate Subtrust. The Carriers determine the appropriate rates and underwriting guidelines to be applied to specific participants within the Subtrust(s). The participants are billed monthly, quarterly or annually for subscriber coverage. Additions are recognized in the period for which payment is received.

The Carriers authorize the Trust to pay participating insurance agents and KNC commissions and fees for marketing their products. The balance of premiums received is remitted to the Carriers by the Trustee. These expenses are recognized in the periods in which the premiums are paid.

The Trust provides that any excess of Subtrust assets over the amount necessary to provide for the payment of administrative expenses, management allowance (Note 5), premiums on insurance policies, and adequate reserves, or any dividend or premium rating refund attributable to the insurance policies purchased hereunder, or any certificates issued thereunder, shall be used by the Insurance Coordinator, in its sole and absolute discretion, in one of the following manners, or in any combination thereof:

- To reduce the premiums under the insurance policy or policies to which the dividend is attributable;
- To increase the reserve fund (see Note 6);
- For any purpose relating to the administration of the Trust or of any Subtrust;
- To provide supplemental benefits to the employees of the participating employers and/or
- For distribution among the participating employers who are assigned by the Insurance Coordinator to the applicable Subtrust.

Eligibility

Employees, former employees, and dependents of employees for participating employers are eligible to participate in the Trust based upon the Trust agreement. Specific eligibility criteria are also established by plans in place for each of the participating employers.

Trust Termination

Although it has not expressed any intention to do so, the Insurance Coordinator has the right under the Trust Agreement to amend or terminate the Trust agreement with written approval of the Insurance Coordinator and the Trustee subject to the provisions set forth in the ERISA. Upon termination of the Trust or any Sub-Trust, any assets of the Trust are to be used and applied as directed by the Insurance Coordinator. The Trust Agreement also allows for merger with similar trusts as long as it will not adversely affect the Participating Employers of the Trust and the merger is authorized under or pursuant to such other trust or trusts and is permitted under applicable law, including ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Trust's financial statements are prepared under the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Premiums Received and Paid

Insurance coverage offered through the Trust to subscribers (participating employers) includes dental, vision, life, short-term and long-term disability coverage. All benefits are fully insured as the Trust does not self-insure any benefits. The Trust Premiums received from subscribers are recorded as additions to net assets when received. Premiums remitted to insurance carriers are recorded as a deduction from net assets when paid.

Premium deposits are recorded as required by insurance carriers with an offsetting liability for amounts due to participants and insurance coordinator in the form of refunds or returned deposits.

Income Recognition

Interest income is recorded on the accrual basis.

Tax Status

The Trust files fiduciary federal and California income tax returns. Because the Trust is structured as a mere pass-through, it usually does not generate taxable income. Accordingly, no accrual for income taxes has been provided for in the Trust’s financial statements for the year ended December 31, 2024 and 2023, respectively. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Expenses incurred in connection with the general administration of the Trust that are paid by the Trust are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Current Benefit Obligations

As further discussed under Trust Administration of Premiums Received and Paid above, the Trust has an obligation to remit premiums collected from Participating Employers to the insurance carriers. See also Note 3.

Concentration of Risk

The Trust maintains its cash in bank deposit accounts which exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, and \$500,000 per brokerage firm, for each account ownership category. At December 31, 2024 and 2023, the Trust had approximately \$104,203 and \$152,229 respectively, in excess of FDIC and SIPC insured limits.

Subsequent Events

The Trust has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued.

Note 4 - Related Party and Party-in-Interest Transactions

The Trust allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Trust. Such transactions, included below, are party-in-interest transactions for which a statutory exemption exists.

KNC performs certain marketing and other services for the Carriers whose policies are issued to the Trust. The Trust has agreed to pay KNC for these services. These fees are recorded as “management allowance” in the Statement of Changes in Net Assets. During the year ended December 31, 2024, the net management allowance surplus of \$32,379 was recorded as the management allowance received from KNC exceeded the fees paid for the services described above. KNC also acts as a general agent and sales agent for the Carriers that have insurance policies administered by the Trust. Accordingly, KNC received approximately \$16,106 from the Trust in commissions during 2024.

During 2024, KNC paid approximately \$580,000 of direct administrative costs and facility expenses on behalf of the Trust and billed the Trust for the expenses. Certain of these expenses are allocated based upon criteria such as, percent of office space utilized, percent of employee compensation, percent of the number of firms in each sub-trust and groups administered or amount of administration activity required to perform task for sub-trust and administrative groups.

The corresponding liability for unpaid management allowance due from current operations, commissions and administrative expenses due to KNC is reported as “due to insurance coordinator” in the Statements of Net Assets Available for Benefits. At December 31, 2024 and 2023, \$418,964 and \$279,122 respectively, remained payable to the Insurance Coordinator.

KNC provides administration services to other insurance trust entities that include billing and payment services and payments of premiums to Carriers on behalf of these trusts. This service was provided through NMT. For its services, NMT billed approximately \$5,900 for the year ended December 31, 2024 to these trusts and such amounts are included in billed fees in the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, there were no amounts due from these trusts.

Related Party Facility Lease

The Trust recognizes right-of-use (ROU) assets and lease liabilities for lease contracts with terms greater than 12 months. Operating lease costs are recognized in the income statement as a single lease cost and finance lease costs are recognized in two components, interest expense, and amortization expense. The Trust has elected the short-term lease exemption for all leases with a term of 12 months or less for both existing and ongoing operating leases to not recognize the asset and liability for these leases. Lease payments for short-term leases are recognized on straight-line basis.

The Trust leases its office facilities on a cancellable annual lease agreement with annual renewals, from a Limited Liability Company owned by a shareholder and former shareholder of KNC. Total lease expense for the office facilities was approximately \$102,000 for the year ended December 31, 2024.

Note 5 - Contingent Payment

In 1990, administrative costs to operate NMT exceeded the additions to the Trust. The Insurance Coordinator agreed to subsidize this shortfall through a rebate to the Trust. The amount of the rebate was approximately \$526,000. In addition, the Insurance Coordinator began allowing the Trust to defer paying a portion of the management allowance.

From 1990 to 1998, this deferral ranged from 9% to 60% of the total management allowance. In 1999, the Trust transferred marketable securities to the Insurance Coordinator to pay down deferred management allowance.

During the periods 2000 through 2004, no management allowance was deferred. Additional amounts were deferred from 2005 to 2023 and during the year ended December 31, 2024, an additional amount of approximately \$520,000 was deferred. The accumulated deferred management allowance at December 31, 2024 was approximately \$4.7 million.

The Trust and the Insurance Coordinator have agreed that, in the event the Trust receives additional funds because of an insurance dividend or other items, the Trust will reimburse the Insurance Coordinator for these subsidies. Since the Trust is unable to estimate the amount that may be paid in the future, no accrual has been made in the accompanying financial statements.

Note 6 - Premium Deposit Receivable and Funds Held on Behalf of Participants and Insurance Coordinator

Funds held on behalf of the participants and Insurance Coordinator, represent minimum deposits with Carriers (reserve funds) and prior year refunds, which had been held for administrative or other purposes, will be allocated to the Insurance Coordinator to offset the deferred management allowance (Note 4), or to the participants upon either the distribution of such funds from the carrier, used for the benefit of the participants or termination of the Trust. During 2024, approximately \$164,425 was deposited to the funds held on behalf of participants and Insurance Coordinator by the Carriers, and approximately \$200,000 was withdrawn from the funds by NMT.
