## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees of HEALTHAlliance Benefit Plan

We have audited the accompanying financial statements of HEALTHAlliance Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of plan benefit obligations as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and statements of changes in plan benefit obligations for the years ended June 30, 2025 and 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of HEALTHAlliance Benefit Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits and plan benefit obligations for the years ended June 30, 2025 and 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis of Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HEALTHAlliance Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

The supplemental schedules of Schedule H, line 4i - Schedule of Assets Held at End of Year and Schedule H, line 4j - Schedule of Reportable Transactions, together referred to as "supplemental information," is presented for purposes of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including the form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the supplemental schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the HEALTHAlliance Benefit Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

**General** - The Plan provides health and other benefits to eligible employees and covered dependents of members of the FUEL Iowa trade association, the Plan sponsor. Premiums are paid to the Plan by the participating Plan members. The Plan is a defined benefit health and welfare plan established as a multi-employer welfare arrangement (MEWA) to provide group health, dental, and vision insurance, and prescription drugs and life insurance benefits.

The Plan is a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Trust Agreement was amended in November 2024 to update the general participation requirements. This states Plan members and beneficiaries under the Plan shall consist of employees in the liquid fuels industry, including the sales, marketing, distribution, and handling of such fuels, as well as the operation of retail convenience stores and the provision of vehicle products and services.

**Benefits** - The Plan is self-funded MEWA providing health benefits (medical, vision, dental and prescription drugs) and life insurance benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Insured Benefits** - The Plan fully insures the vision and life insurance benefits (basic, supplemental, and dependent). The Plan purchases annual insurance contracts for these insured benefits. Premiums for basic life and vision insurance are paid to the insurance company from the general assets of the Plan's VEBA trust.

**Experience-rated Contracts** - Certain insurance contracts are subject to experience-rating adjustments. Experience ratings are calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company. The experience-ratings are determined by the insurance company in the following year and may result in a premium surplus or deficit.

**Stop-Loss Coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured health benefits and prescription drugs. Individual claims over \$200,000, as well as aggregate claims in excess of 120% of expected paid claims are covered by the stop-loss arrangement. Effective January 1, 2026, the threshold for individual claim coverage will increase to \$250,000.

**Self-insured Benefits** - The Plan is self-insured for medical, dental and prescription drug claims. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**Contributions** - In addition to deductibles and copayments, employers and participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Contribution levels are determined by each of the participating members.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting and Use of Estimates** - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Concentration of Credit Risk** - Financial instruments, which potentially subject the Plan to concentration of credit risk, consist primarily of cash deposits. The Plan maintains deposit accounts at financial institutions where at times the account balances exceed the federally insured limits. No balances were in excess of federally insured limits at June 30, 2025. The risk is managed by maintaining all deposits in high quality financial institutions.

As of June 30, 2025, approximately \$1,027,000 was invested in the insured cash sweep accounts included with investments on the Statements of Net Assets Available for Benefits. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash and cash equivalents. Amounts held in the insured cash sweep account during the year ended June 30, 2025 were fully insured under the Federal Deposit Insurance Corporation.

**Unearned Premiums Received** - Unearned premiums represent premiums received prior to June 30 that are for the next fiscal year.

**Plan Benefit Obligations** - Iowa Insurance Division regulations require the Plan to maintain minimum surplus net assets above the claims incurred but not reported (IBNR) equal to the greater of \$500,000 or 10% of annual premiums (calculated in the annual report due to the commissioner of insurance each March covering the preceding calendar year). Management, with the assistance of the Plan's actuary, has determined that total net assets required as of June 30, 2025 and 2024 were approximately \$2,361,000 and \$2,251,000, respectively. Net assets available for benefits exceeded this required amount at June 30, 2025 and 2024.

**Payment of Benefits** - Premiums paid by the Plan's VEBA trust are recorded as premium payments in the accompanying Statements of Changes in Net Assets Available for Benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable on the Statements of Plan Benefit Obligations, and amounts due to the Plan from claims administrator related to claims deposits in excess of claims incurred are recorded as a receivable in the accompanying Statements of Net Assets Available for Benefits.

**Experience-rated Contracts** - For experience-rated contracts, premium surpluses are recorded as a receivable from the insurance company. If the insurance company requires payment of additional premiums due to a premium deficit, an obligation for the additional premiums is included in benefit obligations. There were no premium surpluses or additional premiums due at June 30, 2025 and 2024.

Stop Loss - Premiums for stop loss insurance are shown separately in the accompanying Statements of Changes in Net Assets Available for Benefits. Stop loss refunds are shown separately in the accompanying Statements of Changes in Net Assets Available for Benefits.

Refunds - Refunds due from the Plan's pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset presented as pharmacy rebates in the accompanying Statements of Changes in Net Assets Available for Benefits. Rebates are received quarterly based on the pharmacy claims in the previous quarter. Monthly management records an estimated rebate based off the previous four quarters of rebates received and, as the rebate can have large fluctuations based on the actual claims during the period, the rebate income is tried up when received. Management considered if an allowance for credit losses related to pharmacy rebate receivable was needed based on historical losses, current economic conditions and supportable forecasts regarding future events and determined no allowance was needed as of June 30, 2025 and 2024.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies and procedures. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Subsequent Events - Management has evaluated subsequent events through November 5, 2025, the date the financial statements were available to be issued.

**NOTE C - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). All investments held by the Plan are valued using level 1 inputs.

Interest bearing cash is valued at the closing price of the account.

Mutual funds and exchange traded funds are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used for valuation at June 30, 2025 and 2024.

For plan year 2024, Plan management, with the assistance of the Plan's actuary, had determined a designated reserve for future claims fluctuations based on historical claims data and assumed health care trends in accordance with accepted actuarial principals. The reserve for future claims fluctuations was not separately recorded in the accompanying Statements of Net Assets Available for Benefits and represents an internally designated portion of the net assets available for benefits. For plan year 2025, Plan management elected to not designate any funds for future claims fluctuations. As such, that amount has been reduced to \$-0- and the unreserved net assets have been increased an appropriate amount.

**NOTE E - CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at June 30, 2025 and 2024 for claims incurred but not reported (IBNR) are estimated by the Plan's actuary using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in the prior years. Factors are then applied to paid claims amounts to estimate claims incurred but not reported at year-end. The final trend rates used for the year ended June 30, 2025 was 5.0% for medical and 12.0% for prescription drug. The actuary didn't use a trend rate for dental in 2025 as they determined the dental claims were not material to calculate a separate IBNR. For the year ended June 30, 2024, the final trend rates used was 6.2% for medical, 10.9% for prescription drug, and 3.1% for dental. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Based on actual claims through September 30, 2025, the June 30, 2024 IBNR was overestimated by approximately \$227,000. The June 30, 2024 IBNR recorded on the Statements of Plan Benefit Obligations is based on actuarial estimates and was not retroactively adjusted based on actual claims due to management determining the initial difference was not significant to the financial statements.

**NOTE F - ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, actuary, legal and accounting fees. These expenses are reported on the Statements of Changes in Net Assets Available for Benefits as administrative expenses.

**NOTE G - TAX STATUS**

The VEBA trust funding the benefits of the Plan received an exemption letter from the Internal Revenue Service dated February 23, 1988, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). For 501(c)(9) organizations, federal income taxes are required to be paid on the lesser of investment income or the excess of actual reserves over the IRC Section 419(a) reserve limit. The Plan is a bona fide association which allows for an additional reserve of 35% of employer-paid premiums to the reserve limit. Unrelated business income tax, if any, would be recorded as an administrative expense of the Plan. No federal or state income taxes have been recorded in fiscal years ending June 30, 2025 and 2024 for unrelated business taxable income.

In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate income tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**NOTE H - TERMINATION OF THE PLAN**

Although it has not expressed any intention to do so, the Plan trustees have the right under the Plan to modify the benefits provided to, and the contributions required of participants, and to discontinue its contributions at any time subject to the provisions of ERISA. The Plan trustees and/or all of the participating employers have the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the participating employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE I - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As described in Notes A and F, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

**NOTE J - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to historical claims data, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Department of Labor began conducting a review of the Plan for compliance with Title I of ERISA during fiscal year 2020. The review was closed during fiscal year 2024 with no adverse findings.


