Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Plan Description

The following description of the Midwest Holding LLC, a 401(k) plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's information.

General

The Plan is a defined contribution plan covering all employees of Midwest Holding LLC (the "Company") who are not covered by another plan. The Board of Managers of the Company has appointed the 401(k) Committee to control and manage the operation and administration of the Plan. The trustee of the Plan was Reliance Trust Company. This Trust Agreement creates a trust (the "Trust") forming part of the Plan which is intended to be qualified under Section 401(a) of the Internal Revenue Code of 1986, as amended from time to time, (the "Code") and is intended to be exempt from taxation pursuant to Section 501(a) of the Code, both subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

On December 21, 2023, the Company concluded a transaction with Antarctica Capital LLC ("Antarctica") wherein Antarctica acquired all the issued and outstanding shares of the Company's publicly traded stock. In conjunction with the acquisition, the Company reorganized from a corporation to a limited liability company and changed the name of the Plan.

Contributions

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching and safe harbor contributions made by the Company, (iii) discretionary contributions made by the Company; and (iv) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the plan.

Participants may elect to contribute a percentage of their compensation to the Plan each year, subject to the limitations, as defined in the plan document. Such contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these catch-up contributions are ineligible for safe harbor and Company matching contribution.

The Company makes a matching contribution to each participant's account equal to 100% of each participant's salary reduction contribution (pre-tax only), not to exceed 4% of the amount of the participant's salary reduction contribution. The matching contribution is invested in accordance with the participants investment elections. The Plan also provides for safe harbor nonelective contributions of 3% of a participant's compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company's Board of Directors. During the year-ended December 31, 2024, the Company did not make a profit-sharing contribution to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Individual accounts are maintained for each participant in the Plan. Each participant's account is credited with the participant's contribution and related matching and Company contributions. Participant accounts are also charged with withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may direct the investment of their contributions and any employer contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. Participants may also direct their investments through a Charles Schwab & Company brokerage account, which offers the option to invest in a variety of individual stocks and mutual funds.

Vesting

Participants are vested immediately in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's employer matching contribution portion of their accounts is based on years of continuous service. Vesting is 20% per year for each year of credited service for employer matches over five years of credited service - at which point the Participants employer matching is fully vested.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document. Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at a rate equal to 2% above the prime rate at the time funds are borrowed as determined by the Plan administrator. Principal and interest are paid not less frequently than quarterly or as elected with each payroll cycle. Loan terms range from 1 to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities through 2029 at interest rates ranging from 6.00 percent to 10.50 percent.

Payment of Benefits

On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a 15-year period.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or pay plan administrative expenses for the planned year. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. During 2024, employer contributions were reduced by \$58,445 from forfeited nonvested accounts.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides various investment options for its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances, and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Contributions

Employee contributions are recorded when withheld; safe harbor and employer matching contributions are recorded when earned.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

All investment management and transaction fees related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned daily and are not separately reflected. Consequently, investment management fees and operating expenses are reflected in a reduction of net investment gain (loss) for such investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid on December 31, 2024, and 2023.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year more than the IRC limits. There were no excess contributions due to participants as of December 31, 2024, and 2023.

Subsequent Events

Subsequent events were evaluated through October 22, 2025, the date the financial statements were available to be issued. Effective December 31, 2024, after the close of business, ADP Retirement Trust Services LLC became the trustee of the Plan. No other events occurred that require additional disclosure or adjustments to the Plan's financial statements.

Note 3. Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The levels of the fair value hierarchy are as follows:

Asset Valuation Techniques

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds

Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust to confirm that securities liquidations will be carried out in an orderly business manner.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification to confirm that securities liquidations will be carried out in an orderly business manner. There are no other restrictions on redemptions or unfunded commitments as of December 31, 2024, and 2023.

Self-Directed Brokerage Account

Investments held in self-directed brokerage accounts, which include a variety of common stocks and mutual funds, are valued at fair value based on quoted market prices. The investments are deemed to be actively traded.

Transfers between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The significance of transfers between levels is evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024, and 2023, there were no transfers between levels.

Note 4. Related Party Transactions and Exempt Party Interest Transactions

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. If the Plan is terminated, participants would become 100% vested in their accounts.

Note 6. Certified Investment Information

The following is a summary of the certified information regarding the Plan as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that were prepared by or derived from information prepared by Reliance Trust Company, the trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.
