We have performed audits of the financial statements of SkyBox Packaging, LLC 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 - Plan Description**

The following description of SkyBox Packaging, LLC 401k Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan was a defined contribution plan covering all full-time hourly and salaried employees of SkyBox Packaging, LLC (the "Company"), excluding nonresident aliens and leased employees. Employees who had completed at least three consecutive months of service and attained the age of 18 were eligible to participate in the Plan and receive matching contributions, employer profit-sharing contributions, and safe harbor match contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective April 1, 2025, the Plan was merged into The York Container Company Retirement Savings Plan. Accordingly, for 2025, the period covered by the financial statements is as of April 1, 2025 and for the period from January 1, 2025 to April 1, 2025.

***Contributions***

Effective January 1, 2025, all participant contributions and related employer contributions were withheld and remitted to The York Container Company Retirement Savings Plan. There were no contributions remitted to the Plan during 2025.

***Participant Accounts***

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Participants could have directed the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants were immediately 100 percent vested in employee salary and rollover contributions and the safe harbor employer match contribution plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions of their accounts, plus actual earnings thereon, was based on years of service. Participants vested in employer matching contributions and profit-sharing contributions made by the Company 25 percent after one year of service, an additional 25 percent after two years of service, and another 25 percent per year thereafter until they become fully vested after four years of service.

***Benefit Payments***

Distributions were payable upon retirement, death, disability, termination of employment, or attainment of normal retirement age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants were able to request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Forfeitures***

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future company contributions or to pay administrative expenses of the Plan.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments were stated at fair value.

All investments were valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded as earned. Dividends were recorded on the ex-dividend date.

***Benefit Payments***

Benefits were recorded when paid.

***Administrative Expenses***

Various administrative costs were paid by the Company. These transactions qualified as party-in-interest transactions.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 28, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Plan Merger**

During 2025, the Plan merged and combined with The York Container Company Retirement Savings Plan. Accordingly, all assets, participants, and their related account balances were transferred to The York Container Company Retirement Savings Plan on April 1, 2025.

**Note 4 - Certified Information**

Matrix Trust Company (the "Custodian") held the Plan's investments and executed all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements were based solely on information certified by the Custodian.

**Note 5 - Tax Status**

The Plan used a preapproved plan. The preapproved plan had received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, was qualified for federal income tax-exempt status. The Plan did not individually seek its own determination letter.

**Note 6 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 6 - Fair Value Measurements (Continued)**

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

As of April 1, 2025, the Plan was fully transferred out and there were no assets remaining in the Plan. The following table presents information about the Plan’s assets measured at fair value at December 31, 2024:
