### Opinion on the 2024 Financial Statements

We have audited the accompanying financial statements of R.C. Moore, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the 2024 financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

### Basis for Opinion on the 2024 Financial Statements

### 1. Description of Plan

The following description of R.C. Moore, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

R.C. Moore, Inc. (the Plan Sponsor), established the Plan effective January 1, 2022. On January 21, 2022, the Plan purchased 264,900 shares of the Plan Sponsor's common stock through issuance of a note payable for \$986,480. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the Code). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Plan Trustees.

The Plan is a leveraged employee stock ownership plan (ESOP). The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Plan Sponsor. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- 1) The accounts of participants with rights in allocated stock (Allocated), and
- 2) Stock not yet allocated to participants (Unallocated).

#### Eligibility

Substantially all employees of the Plan Sponsor are eligible to participate in the Plan as of the first day of January of each plan year immediately preceding the later of completion of 1,000 hours of service measured from the date the employee first completes an hour of service or the first day of any plan year thereafter.

#### Contributions

The Plan Sponsor is obligated to make contributions in cash or shares of the Plan Sponsor stock to the Plan which, when aggregated with any Plan earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

### Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited or charged with a proportionate allocation of the Plan Sponsor's contributions, common stock, forfeitures of terminated participants' non-vested accounts, investment income, and administrative expenses. Employees are eligible to receive an allocation of the Plan Sponsor contribution if they were employed on the last day of the plan year and have completed 1,000 hours of service. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

### Vesting

Participants become 100% vested upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in the Plan Sponsor's contributions and earnings thereon vests according to the following schedule:

Participants shall be credited with one year of service with the Plan Sponsor and with any affiliated company only for service from and after the Plan's effective date of January 1, 2022.

### Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. Forfeited cash and shares of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$0. There were no unallocated forfeitures at December 31, 2024.

### **Distribution of Benefits**

Distributions due to death, disability, or normal retirement as defined by the Plan document are made in the plan year following the event. A participant who has reached his or her normal retirement date and who also has reached the 10th anniversary of the year in which such participant commenced participation in the Plan will begin to receive a distribution of his or her account by the 60th day of the following plan year. Distributions for other separations from service may commence by the end of the sixth plan year following the plan year in which such termination occurs and after the note payable has been paid in full. Distributions are made in substantially equal periodic payments over a period of five years. The amount to be distributed is based upon the valuation date immediately preceding the distribution. Distributions in which the vested balances are \$1,000 or less are made in the plan year following the event. For distributions in which the balance is \$5,000 or less, but more than \$1,000, the participant may elect to receive such vested balance in a lump sum by the end of the following plan year. Distributions can be made in shares of Plan Sponsor stock, cash or a combination.

### **Administration of Plan Assets**

Spinnaker Trust was engaged to be the Trustee. Company contributions and Plan assets are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Administrative expenses for the Trustee's fees are paid directly by the Plan Sponsor.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. During 2024 and 2023, Principal and FuturePlan, respectively, were engaged to provide additional administrative services.

### **Voting Rights**

The Trustee shall vote all shares of the Plan Sponsor's common stock held by the Plan with respect to all corporate matters upon which shareholders are entitled to vote. Each participant shall direct the Trustee as to voting of shares held in his or her account with respect to any shareholder vote that is required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business. A participant who is entitled to such pass-through voting shall receive from the Plan Sponsor such proxy materials and a proxy form upon which voting directions may be indicated to the Trustee. The Trustee shall vote such allocated shares of common stock as instructed by participants. Allocated shares for which no direction is received shall be voted by the Trustee in its discretion. Fractional shares of common stock for which directions are received shall be combined to the extent practicable to reflect participants' directions.

### **Put Option**

Under federal income tax regulations, employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Plan Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Plan Sponsor may choose to pay for the purchase over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. During 2024, the Plan Sponsor did not repurchase shares from participants.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

### **Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of participants with rights in allocated stock (Allocated) and (b) stock not yet allocated to participants (Unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Benefit Payments**

Benefit payments are recorded when paid.

### Risks and Uncertainties

The Plan investments consist of the Plan Sponsor's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

### Subsequent Events

Management has considered transactions or events occurring through October 28, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### 4. Fair Value Measurement

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Moore Inc. management, along with the Plan trustees, review in detail, discuss and approve, the valuation prepared by the independent appraiser.

### 5. Note Payable

On January 21, 2022, the Plan entered into a note payable agreement with the Plan Sponsor in connection with the acquisition of the shares of the Plan Sponsor common stock. The note payable is due in annual installments of \$38,303, including interest at 1.82%, through December 20, 2056. The outstanding balance on the note payable was \$922,729 on December 31, 2024. The note payable is collateralized by unallocated shares of the Plan Sponsor common stock.

### 6. Parties-In-Interest and Related Party Transactions

The Plan invests in Plan Sponsor common stock and has indebtedness guaranteed by the Plan Sponsor. These are related party and party-in-interest transactions. The Plan Sponsor pays all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

### 7. Tax Status

The Plan received a favorable determination letter from the Internal Revenue Service dated March 6, 2023, notifying the Plan that it is designed in accordance with applicable sections of the Code. The plan administrator believes the Plan is currently being operated in compliance with its terms, and that the related trust is tax exempt. Accordingly, no provision for taxes has been recorded in the Plan's financial statements.

### 8. Plan Termination

The Plan Sponsor reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Employee Benefits Administration Committee directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code.
