Opinion

We have audited the financial statements of Blue Cross Blue Shield of Michigan Employees' Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for opinion

We conducted our audit of the financial statements in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in

conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held (at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and

reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Blue Cross Blue Shield of Michigan Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers employees of the Blue Cross Blue Shield of Michigan (the "Corporation" or "Employer" or "Plan Sponsor") and certain of its wholly-owned subsidiaries not governed by a collective bargaining agreement. The Corporation and its Savings Plan Committee are responsible for the general administration of the Plan.

The Plan participates in the Blue Cross Blue Shield of Michigan 401(k) Master Trust (the "Master Trust"). The Master Trust is was established for the investment of assets of the Plan and other plans sponsored by the Corporation including the Blue Cross Blue Shield of Michigan Represented Employees' Savings Plan ("Represented Employees' Plan"), the Emerging Markets Employees' Savings Plan ("Emerging Markets Plan") and Accident Fund Holdings, Inc. Represented Employees' Savings Plan ("Accident Fund Plan") (collectively "the Plans"). See Note C for details of the Plan's participation in the Master Trust. The assets of the Master Trust are held by Fidelity Management Trust Company ("Fidelity" or "Trustee"). Participants direct the investment of their contributions and Employer contributions into the various investment options offered by the Plan. The Plan is subject to the to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

An employee may become a participant in the Plan immediately upon the employee's employment commencement date (as defined in the Plan document), provided no applicable special considerations for eligibility in the Plan document. A participant receives matching contributions from the Corporation after one year of service following their employment commencement date.

Contributions and Vesting

Eligible employees are automatically enrolled into the Plan after 90 days at a pre-tax deferral rate of 6% of adjusted Form W-2 compensation, as defined in the Plan document. Adjusted Form W-2 compensation will be referred to as eligible compensation hereafter. The employee can change their contribution rate or stop automatic contributions at any time. Beginning in 2024, participants can make Roth after-tax contributions. Participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with the limitations of the International Revenue Code (the "IRC"). Eligible employees can elect to contribute up to 50% of their eligible compensation on a pre-tax or Roth after-tax basis not to exceed the Internal Revenue Service ("IRS") limits.

The Plan also permits participants to contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The rollover contributions include pre-tax contributions, and effective January 1, 2024 they can include Roth rollover contributions.

The Employer makes matching contributions equal to 50% of each participant's contribution on the first 10% of eligible compensation. The Employer does not match contributions on catch-up contributions. The Employer can also elect discretionary contributions. There were no discretionary contributions made during the year ended December 31, 2024.

All participant and Employer contributions are immediately 100% vested.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Employer contributions and allocations of Plan earnings or losses. Participant accounts are charged with withdrawals and applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Generally, participants may elect to withdraw their total account balance in the form of a lump sum upon separation. However, participants receiving a distribution due to retirement or disability, as defined in the Plan document, may elect to have the value of their participant accounts distributed as an annuity or in installment payments over a period of 2 to 15 years. Participants who are age 59½ or older may also make a one-time election to receive a lump-sum distribution of their total participant account balance. A participant who is terminated or a beneficiary who does not elect to receive an immediate distribution must receive, or begin to receive, a distribution no later than April 1 following the year the participant attains age 73.

The Plan also provides for early withdrawal of participant accounts in the event of a participant's financial hardship, as defined in the Plan document. The amount withdrawn for a financial hardship must not exceed the amount needed in the situation.

Notes Receivable from Participants

Participants may borrow from their individual account balance in the Plan a minimum of \$1,000 up to a maximum of the lesser of \$50,000, or 50% of their vested account balance, reduced by the outstanding balance of all other loans from the Plan on the date of origination. A participant may not have more than three loans outstanding at any given time. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a principal residence. The loans are collateralized by the balance in the participant's account and bear interest at the prime lending rate plus 1% at the beginning of the month prior to the loan origination. The loans rates range from 2.10% to 9.50% as of December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein as well as disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Master Trust's investments, except for its investments in synthetic investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note D for a description of fair value measurements.

The synthetic investment contracts are stated at contract value, as more fully described in Note E. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of Master Trust investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Master Trust's gains and losses on investments bought and sold, as well as those held during the year.

Benefit Payments

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued interest but unpaid. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Administrative Expenses

Transaction fees initiated by individual participants, such as loan set-up, loan maintenance, and overnight express mail fees, are paid by the Plan and are charged to the participant's account. Certain direct costs and expenses incurred in connection with the operation of the Plan are paid by the Corporation.

Reclassification of Prior Period Amounts

Certain amounts in the prior period disclosures have been reclassified to conform to the current year's presentation. These reclassifications had no impact on previously reported net assets available for benefits or change in net assets available for benefits.

NOTE C - MASTER TRUST

The Plan's investments are held in the Master Trust. Each participating plan in the Master Trust has a divided interest in the Master Trust. The value of the Plan's interest in the Master Trust is determined based on the Plan's allocated portion of the net appreciation in fair value of investments of the Master Trust, along with the allocated portion of the Master Trust interest and dividend income and Master Trust related administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides for a fair value hierarchy that provides the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets and liabilities in active markets that the Plan has the ability to access

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correctional or other means

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 - Inputs to the valuation methodology are both unobservable and significant to the fair value measurement

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered Investment Companies

Registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at the price. The mutual funds held by the Plan are actively traded.

Collective Trust Funds

Investments in collective trusts are valued at the NAV of units held by the Master Trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding.

Self-Directed Brokerage Accounts

Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable prices in active markets.

NOTE E - INVESTMENT CONTRACTS

The Master Trust holds a portfolio of synthetic investment contracts (the "Investment Contracts") held in a Fixed Income Fund (the "Fund"). These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate

permitted transactions under the terms of the Master Trust. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Fidelity is responsible for the accounting, valuation, and safekeeping of the Investment Contracts. The Investment Contracts include wrapper contracts, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Master Trust in certain circumstances. The wrapper contracts provide a guarantee that the credit rate will not fall below 0%. The wrapper contract typically incurs certain conditions and limitations on the underlying assets owned by the Master Trust.

Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plans through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting.

The Master Trust's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Master Trust to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- Failure of the Plans included in the Master Trust to qualify under Section 401(a) of the Internal Revenue Code or failure of the trust to be tax-exempt under Section 501(a) of the IRC
- Premature termination of the contracts
- Termination or merger of the Plans included in the Master Trust
- Changes to the Master Trusts prohibition on competing investment options
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Master Trusts normal operations.

No events are probable of occurring that might limit the ability of the Master Trust to transact at contract value with the contract issuers and that also would limit the ability of participants to transact at contract value.

In addition, certain events allow the issuer to terminate the contracts with the Master Trust and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Master Trust's investment guidelines
- A breach of material obligation under the contract
- Material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

NOTE F - ASSET TRANSFERS

When an employee's job classification changes, but the employee continues employment with the Corporation, a transfer occurs between plans sponsored by the Corporation, resulting in a change in eligibility of the employee between participating in this Plan and participating in the other plan sponsored

by the Corporation. The net of these transfers are reported in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2024, a net amount of \$636,311 was transferred to the Plan from the Represented Employees' Plan.

NOTE G - RISKS AND UNCERTAINTIES

The Master Trust invests in various securities. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

NOTE H - PLAN TERMINATION

Although it is not expressed any intent to do so, the Corporation has the right, by action of its Board of Directors, to discontinue its contributions or terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, disbursements of participants' account balances would be made as of the date of termination in the same manner as described for retirement.

NOTE I - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Master Trust investments are shares of registered investment companies or units of collective trust funds managed by the Trustee, or affiliates of the Trustee. Transactions involving these investments qualify as party-in-interest transactions; however, these transactions are exempt from the prohibited transaction rules.

Participants may also borrow from their individual account balances in the Plan. These transactions qualify as exempt party-in-interest transactions.

NOTE J - TAX STATUS

The Plan obtained its latest determination letter on September 8, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that would not be sustained upon examination by the IRS. The Corporation and the Plan's tax counsel have analyzed the tax positions taken by the Plan and have concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. As such, no reserve is required under US GAAP. The Plan is subject to audit by the IRS, including the periods presented in these financial statements; however, there are no current IRS audits for any tax periods in progress.
