Notes to Financial Statements

Note 1. Plan Description

The following description of the Moveworks Inc. (the Company) 401(k) Plan (the Plan) provides only general information with regard to the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of the Company who are age 21 or older, except members of a collective bargaining unit and non-resident aliens. The Plan has no service requirement. Employees may enter the plan on the date in which they satisfy the eligibility requirement. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration:

The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring investment performance.

Effective December 26, 2023, the Plan moved to a bundled service offering from Fidelity and related entities (Fidelity). The Company contracts with Fidelity Management Trust Company to act as custodian. Fidelity Workplace Services LLC acts as the third-party administrator and recordkeeper to process and maintain records of participant data. The Company previously contracted with Empower Annuity Insurance Company of America and related entities (Empower) through December 26, 2023.

Contributions:

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also designate a portion or all the deferral contributions as Roth 401(k). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Effective January 1, 2023, the Plan was amended to discontinue safe harbor matching contributions.

Participant accounts:

Each participant's account is credited with the participant's contribution via salary reductions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions and in previous employer safe harbor matching contributions, plus actual earnings thereon.

Notes receivable from participants:

The Plan does not permit participant loans.

Benefit payments and withdrawals:

On termination of service for any reason, participants or their beneficiaries are entitled to a benefit equal to the vested and non-forfeitable interest in their account as a lump sum distribution. If the terminated participant's vested and non-forfeitable balance is less than \$7,000, the participant's balance may be distributed in the form of a lump sum, as a cash distribution if the balance is under \$1,000, and as a direct rollover to a default IRA if the balance is under \$7,000, without authorization from the participant.

A participant may withdraw the elective deferral account balance of their account for reasons of hardship.

Forfeited accounts:

Forfeitures result from earnings on mistake of fact transactions and adjustments, if any. At December 31, 2024 and 2023, the forfeiture balance was \$31 and \$9,413, respectively. During the year ended December 31, 2024, and as a result of the custodian switch, \$9,413 of forfeitures were allocated to participant accounts. At the discretion of the Plan administrator, forfeitures may be applied to offset Plan expenses and qualified non-elective contributions, if any. Other than the allocation based on the custodian change, there were no forfeitures used during the year ended December 31, 2024.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value, if any). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor's management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits:

Benefits are recorded when paid.

Administrative fees:

Certain expenses incurred maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses, including transaction fees, are included in net appreciation of fair value of investments.

Note 3. *Certified Investments and Cash in Transit*

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and cash in transit at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America through December 26, 2023, and Fidelity Management Trust Company after December 26, 2023.

Note 4. *Transfer of Financial Assets*

On December 29, 2023, the Plan's investments were liquidated due to the transition from Empower to Fidelity Management Trust Company. The liquidated cash, amounting to \$19,944,992, was received by Fidelity Management Trust Company on January 2, 2024. The amount in transit was recorded as cash on the statement of net assets available for benefits as of December 31, 2023.

As a result of the transfer, Plan trustees approved a blackout period beginning December 22, 2023, and ending January 25, 2024. During this period, the Plan and Plan participants were restricted from initiating transactions and all assets were held in the Fidelity Government Money Market Fund.

Note 5. Investments and Fair Value Measurements

The Fair Value Measurements topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes to the methodologies used at December 31, 2024 and 2023 for each type of investment:

Mutual funds (and money market): Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end investment companies that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account (SDBA): Brokerage account assets are valued based on prices provided to the brokerage firm from external pricing sources and based on market prices. The securities held within the SDBA include cash equivalents, equities and mutual funds and are reported at quoted market price.

Note 6. Related Party and Party-in-Interest Transactions

Empower was the custodian and recordkeeper, as defined by the Plan, through December 26, 2023. Hicks Pension Services was the third-party administrator, as defined by the Plan, through December 26, 2023. Fidelity (through bundled service agreements) is the custodian, recordkeeper, and third-party administrator, as defined by the Plan, after December 26, 2023. Therefore, transactions with these entities qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Newfront Retirement Services, Inc. is the investment advisor, as defined by the Plan. Fees incurred by the Plan for advisory services are included in administrative expenses. These fees are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of the ERISA. In the event of Plan termination, all interests of participants become fully vested and the assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

Note 8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of IRC. Including any applicable amendments, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2024, and is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Reconciliation of the Plan Financial Statements to the Form 5500

Certain amounts included on Schedule H Part I and II on the Annual Return/Report of Employee Benefits Plan (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

There were no reconciling items between the financial statements and the Form 5500 as of December 31, 2024 and 2023.

Note 11. Subsequent Events

In 2025, the Company entered into a merger agreement to be acquired by a third party. As part of the transaction, certain employee benefit plans, including the Plan, may be required to terminate or merge into the acquirer's retirement plan as a closing condition. The timing of any termination or merger will determine when the Plan's final filing occurs.

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
