### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oregon Ice Cream LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **Note 1 - Description of Plan**

The following description of the Oregon Ice Cream LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution profit sharing plan covering all full-time employees of Oregon Ice Cream LLC (the Company) who have completed three months of service. Employees who are part time or whose wages are subject to collective bargaining are not eligible to participate in the Plan. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Committee determines the appropriateness of the Plan investment offerings, monitors investment performance, and reports to Plan Management.

##### Contributions

Each year, participants may elect to contribute pre-tax or after-tax Roth contributions of not less than 1% of compensation, as defined by the Plan, not to exceed the maximum allowed under the Internal Revenue Code (IRC), which was \$23,000 in 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional catch-up contributions of \$7,500 in 2024. The Plan automatically enrolls employees and withholds 5% from each participant's compensation unless the participant elects to not defer any of their salary or elects a different percentage. Beginning on the participant's anniversary date, their deferral percentage will increase by 1% annually until 12% is reached, unless the participant makes a different election. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and an insurance investment contract as investment options for participants.

Matching contributions are based upon the amount of contribution dollars contributed by each participant. The matching contribution is a discretionary amount determined by the Company on a yearly basis. Matching contributions were 50% of the first 6% of each participant's contribution in 2024. Additionally, the Company may elect to make a separate discretionary contribution to the Plan at the end of the Plan year. In 2024, the Company did not elect to make a separate discretionary contribution.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, (b) the Company's discretionary contribution and, (c) Plan earnings and expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### Investment Elections

Participants may choose from a variety of investment options. The qualified default investment allocation is the participant's appropriate target fund provided by Vanguard. Participants have the opportunity to change their investment combinations on a daily basis.

##### Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Accounts vest at 33% each year and become fully vested after three years of credited service. Participants shall also become 100% vested upon attainment of normal retirement age, death, or permanent disablement.

##### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1%, with rates ranging from 4.25% to 9.50% for the year ending December 31, 2024. Principal and interest are paid ratably through biweekly payroll deductions.

#### **Note 1 - Description of Plan, continued**

##### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a period of not more than the participant's assumed life expectancy, or Ad Hoc, as defined by the Plan. If the participant's vested balance does not exceed \$1,000, they will receive his or her account as a lump-sum distribution.

##### Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Forfeitures used to reduce employer contributions totaled \$8,958 for the year ended December 31, 2024. These accounts can be used to reduce future employer contributions or Plan expenses as determined by the Plan Administrator.

#### **Note 2 - Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### Investment Valuation and Income Recognition

Except for benefit-responsive investment contracts reported at contract value, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, Trustee and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of Benefits

Benefits are recorded when paid.

##### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, recordkeeping, and investment advisory are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Note 2 - Summary of Accounting Policies, continued**

##### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

#### **Note 3 - Information Certified by the Trustee**

The Plan's investments are held by Empower Annuity Insurance Company of America, the Trustee of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses charged by the Trustee. The Plan Administrator has obtained a certification from the Trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Trustee are complete and accurate:

- Interest on notes receivable from participants

#### **Note 4 - Fair Value Measurements**

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of input may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 - Investment Contract with Insurance Company**

The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the investment at December 31, 2024 and 2023, was \$742,286 and \$628,890, respectively.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Key variables influencing future crediting rates for the guaranteed investment contract include current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer’s general account.

The contracts do not specify any events which would limit the ability of the Plan to transact at contract value with the issuer or any events which would allow the issuer to terminate the contracts and settle for an amount different from contract value. The Company does not intend to surrender the contracts.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on earnings of the underlying assets in the entire medium-long term new portfolio compared to a minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Such interest rates are reviewed on a quarterly basis for resetting.

#### **Note 6 - Party-in-Interest Transactions**

Certain Plan investments are managed by Empower. These transactions qualify as party-in-interest transactions as Empower is the Trustee of the Plan. Fees paid for investment services are deducted from net appreciation of investments. Fees paid to Empower for administrative services totaled \$20,740 for the year ended December 31, 2024. Additionally, \$18,905 was paid to Deschutes Investment Consulting, LLC and \$4,537 was paid to Empower Advisory Group LLC for investment advisory services. These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

#### **Note 7 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan's prototype sponsor by an opinion letter dated November 14, 2022, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA by Empower Retirement LLC, which has been adopted by the Plan, is acceptable pursuant to Section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan has been amended since the adoption of the prototype sponsor plan. However, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator does not believe there are any uncertain positions at December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
