Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Charles Rizzo & Associates of NY, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 13, 2025, December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the period January 1, 2025, to January 13, 2025, and the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 13, 2025, December 31, 2024 and 2023, and for the period January 1, 2025, to January 13, 2025, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Plan Merger

As discussed in Note 8 to the financial statements, on June 16, 2024, the Plan's Sponsors were acquired by Pinchin, LLC and the Plan was merged with the Pinchin, LLC 401(k) Plan effective January 1, 2025. All plan assets were transferred to the Pinchin, LLC 401(k) Plan on January 13, 2025. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplemental Schedule Required by ERISA

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

Effective January 1, 2025, the Charles Rizzo & Associates of NY, Inc. 401(k) Retirement Plan (the Plan) Plan was merged into the Pinchin, LLC 401(k) Plan (the Surviving Plan). The following description of the Plan, prior to the merger, provides only general information. Participants should refer to the Plan's documents for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering certain employees of Rizzo Compliance Solutions LLC; Code Green Solutions, LLC; and United Building Sciences LLC (the Sponsors), who completed 1,000 hours of service during 12 consecutive months and were 21 or older. The Plan Administrator was responsible for oversight of the Plan. The Advisory Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan Administrator. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants were allowed to contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were allowed to contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Sponsors provided for a safe harbor matching contribution equal to 100% of the first 4% of participant deferrals. The Plan also allowed for non-elective contributions at the discretion of the Sponsors. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options: Upon enrollment in the Plan, a participant directed all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants were allowed to change their investment options daily.

Participant accounts: Each participant's account was credited with the participant's contributions and the Sponsors' matching contributions, as well as allocations of any non-elective contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant were entitled was the benefit that can be provided from the participant's vested account.

Vesting: Participants were vested immediately in their contributions and the Sponsors' safe harbor matching contributions plus actual earnings thereon. Participants were vested in the Sponsors' non-elective contributions based on years of continuous service and were fully vested after 6 years of service.

Payment of benefits: The Plan permitted withdrawals when a participant terminated employment, retired, or become deceased. In-service withdrawals were also permitted for certain financial hardships or other circumstances per the Plan provisions. Benefits were payable in lump-sum payments with certain exceptions allowed.

Forfeitures: Forfeitures of participant accounts attributable to the Sponsors' contributions may have been used for any permissible method prescribed by the Plan provisions. There were no forfeited nonvested accounts at January 13, 2025, December 31, 2024 and 2023.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants were allowed to borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms ranged up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans were collateralized by the vested balance in the participant's account and carried interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. There were no loans outstanding at January 13, 2025, as they were transferred to the Surviving Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Plan is subject to the provisions of ERISA.

Use of estimates: The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Advisory Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are recorded when incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. There were no notes receivable from participants as of January 13, 2025, as they were transferred to the Surviving Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Participant contributions and the related employer matching contributions that are determined from eligible compensation are recognized when compensation is incurred.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsors and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses, excluding financial advisor fees, are included in net appreciation (depreciation) in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events (events occurring after January 13, 2025) through October 31, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by John Hancock Life Insurance Company of New York (Trustee)

The following is a summary of the Plan's asset information as of January 13, 2025, December 31, 2024, and 2023, and for the period January 1, 2025 to January 13, 2025, and year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by the Trustee of the Plan. The Plan Administrator has obtained certifications from the Trustee, that the information provided to the Plan Administrator by the Trustee is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no assets measured at fair value at January 13, 2025. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts, subaccounts: Valued at the net asset value (NAV) of shares in each subaccount held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value.

- a. Seeks a balance between a high level of current income and growth of capital.
- b. Seeks long-term growth of capital.
- c. Seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index.
- d. Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.
- e. Seeks to achieve the approximate aggregate total return of a mid-cap U.S. domestic equity market index.
- f. Seeks to achieve the approximate aggregate total return of a small-cap U.S. domestic equity market index.
- g. Seeks to track the performance of a benchmark index that measures the investment return of small-capitalization growth stocks.
- h. Seeks to achieve a high level of dividend income and long-term growth of capital primarily through investments in stocks.
- i. Seeks to track the performance of a broad-based equity index of foreign companies primarily in developed countries and, to a lesser extent, in emerging markets.
- j. Seeks to track the performance of the Barclays Capital U.S. Aggregate Bond Index, which broadly represents the U.S. investment-grade bond market.
- k. Seeks maximum total return, consistent with preservation of capital and prudent investment management primarily through investments in investment-grade debt securities.
- l. Seeks a high level of current income primarily through investments in debt securities.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 5. Party-in-Interest Transactions

John Hancock Life Insurance Company of New York is the Trustee of the Plan; transactions with the Trustee qualify as party-in-interest transactions. There were no fees paid by Plan to the Trustee for the period January 1, 2025, to January 13, 2025. Fees paid by the Plan to the Trustee totaled \$2,364 for the year ended December 31, 2024.

Note 6. Tax Status

Effective January 1, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by CCH Incorporated, DBA FTWilliam.com. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since receiving this opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
