### **Report on the Financial Statements**

#### **Qualified Opinion**

We have audited the accompanying financial statements of the Pari-Mutuel Employees Guild of California, Local 280 Health and Welfare Trust ("Plan"), which comprise the statements of net assets available for benefits as of January 31, 2025 and 2024 and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

In our opinion, except for the effects of the matters discussed in the Basis for Qualified Opinion paragraph, the financial statements referred to in the first paragraph present fairly, in all material respects, the financial status of the Pari-Mutuel Employees Guild of California Local 280 Health & Welfare Trust as of January 31, 2025 and 2024 and the changes in its financial status for the year ended January 31, 2025 in accordance with accounting principles generally accepted in the United States of America.

#### **Basis for Qualified Opinion**

The Plan's financial statements do not present information regarding the Plan's accumulated benefits and the changes in accumulated plan benefits. In our opinion, presentation of that information is required to conform with accounting principles generally accepted in the United States of America. The Plan administrator has not quantified the amount of, or changes in the Plan's accumulated benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determinable.

#### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Pari-Mutuel Employees Guild of California, Local 280 Health and Welfare Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**A. General**

The Plan is a health and welfare benefit plan covering those eligible employees of the Pari-Mutuel Employees Guild of California, Local 280. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Benefits**

The Plan provides health, dental, prescription drug and life insurance benefits to the sponsoring companies' employees and their eligible dependents.

**C. Eligibility**

Active employees must work a certain number of hours based on a formula of the number of days of racing in Southern California, Northern California and Night Meets in a calendar year for the active employee and their dependents to be eligible to participate in the Plan in the following calendar year. The Plan uses a calendar year beginning on December 26 of each year.

Retirees must have worked 1,000 days within the 10 years prior to retirement for the retiree and their spouse to be eligible to participate in the Plan

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 FUNDING POLICY**

The sponsoring companies make contributions for their eligible employees and dependents. Contribution rates are established actuarially to provide sufficient funds for plan benefits. Benefits are provided by insurance companies from insurance premiums paid by the Plan.

**NOTE 4 AMENDMENT AND TERMINATION OF THE PLAN**

A. Right to Amend

Subject to the sponsoring companies' obligations under their collective bargaining agreement with the Union, the Trustees reserve the right to amend this Plan at any time.

B. Right to Terminate

It is the intention of the sponsoring companies to continue the Plan indefinitely and to make contributions to the Plan. However, subject to the sponsoring companies' obligations under their collective bargaining agreement with the Union, the Trustees reserve the right to terminate the Plan at any time.

Upon Plan termination, the assets will continue to be used to provide benefits for covered expenses incurred on or before the effective date of the Plan termination, until such time as the assets are exhausted.

**NOTE 5 TAX STATUS**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501 (c) 9 of the Internal Revenue Code as a tax-exempt organization. The trust has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. Generally accepted accounting principles require management to evaluate tax positions taken by the plan to determine if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of January 31, 2025 there are no uncertain tax positions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**NOTE 7 CONCENTRATIONS OF CREDIT RISK**

The Plan maintains its cash balances in financial institutions insured by the Federal Deposit Insurance Corporation up to \$250,000. At January 31, 2025 the Plan's had no uninsured balances.

**NOTE 8 SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through November 3, 2025 which is the date the financial statements were issued.


