## Graves-Gilbert Clinic Revised Profit Sharing Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the Graves-Gilbert Clinic Revised Profit Sharing Plan (the “Plan”) provides general information. Refer to the Plan document for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of the Graves Gilbert Clinic, PLLC (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Profit Sharing Committee is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Vanguard Fiduciary Trust Company, the qualified institution for the plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan Administrator. Vanguard Fiduciary Trust Company also acts as the third-party administrator and record-keeper for the Plan, which performs certain plan administration, annual ERISA compliance testing, and other record-keeping services.

#### ***Eligibility***

The Plan covers substantially all employees who have completed a twelve month period of employment consisting of 1,000 hours or more of service and have attained age 18 or older. Effective August 1, 2024 the plan has been amended to update the eligibility period and plan entry dates. For purposes of making Participant Deferrals, an employee hired on or after August 1, 2024 shall become a Participant in the Plan on the first day of his or her employment by the Company. For purposes of any employee hired prior to August 1, 2024 who has not yet become eligible to make Participant Deferrals, he or she shall become eligible to make Participant Deferrals on August 1, 2024.

The Entry Dates for purposes of participating in the Plan were changed from semi-annual to quarterly dates. The new quarterly Entry Dates were amended to be January 1, April 1, July 1 and October 1.

#### ***Contributions***

*Employee Elective Contributions* – Participants may contribute to the Plan through either a pretax or Roth salary deferral up to 100% of their annual compensation, as defined in the Plan Agreement, not to exceed the statutory maximum. The salary deferral percentage can be modified or revoked during any time during the Plan Year. Participants who are age 50 or older may make catch-up contributions in excess of their regular elective contributions, up to a maximum of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover contributions).

## Graves-Gilbert Clinic Revised Profit Sharing Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### **Contributions (Continued)**

The Plan agreement provides for an automatic 3% pre-tax salary deferral for all new participants unless they elect otherwise. This deferral percentage is increased 1% annually up to a maximum of 6% of eligible compensation. If no investment elections are made by the participant, these contributions will be invested in accordance with guidelines established by the Plan agreement.

*Non-Elective Safe Harbor Contributions:* Safe harbor contributions are the amounts contributed by the Company to all eligible non-highly compensated employees, regardless of whether the employee elected to make deferrals to the Plan. The non-elective safe harbor contribution is no less than 3% of the amount considered compensation as defined by the Plan document for eligible participants. During the year ended December 31, 2024, the Company made a contribution of 3% of eligible compensation totaling \$1,278,120.

*Employer Discretionary Profit-Sharing Plan Contributions:* The Company, at their sole discretion, may contribute amounts to the Plan in addition to any matching contributions. Participants must have completed 1,000 hours and been employed on the last day of the plan year to receive a profit-sharing contribution, except in the event of a participant's death, disability, or retirement. During the year ended December 31, 2024, the Company made a discretionary profit-sharing contribution of \$5,157,010. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company's safe harbor contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in that portion of their accounts attributable to employee contributions (including rollovers) and the Company's non-elective safe harbor contributions. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service according to the following schedule:

The Plan provides for 100% vesting for any participant whose termination is attributable to death, normal retirement, or permanent disability.

#### *Benefit Payments*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a predetermined period of time, or direct rollover into another qualified plan or individual retirement account. For termination of service for other reasons, a participant may elect the aforementioned option or roll the account balance over into an IRA or new employer's qualified plan. Participants over age 59.5 may also elect to receive a lump sum amount of all or a portion of their vested account balance.

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$71,480 and \$81,354, respectively. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$80,511 from forfeited nonvested accounts.

#### *Hardship Withdrawals*

As permitted by the Internal Revenue Code (IRC), and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding

U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and third party administrator.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 30, 2025 and determined there were no events that occurred that require disclosure.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Net appreciation in fair value of investments and investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at fair value on a daily basis by the market value of the underlying investments held by the fund account at year-end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts ("CCTs"):* The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### Note 5: TAX STATUS

The IRS has determined and informed the Company by a letter dated September 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Vanguard Fiduciary Trust Company, the trustee of the Plan provides investment services to the Plan. Certain plan investments are shares in mutual funds managed by Vanguard Fiduciary Trust Company, therefore, these transactions qualify as party-in-interest transactions. Vanguard Fiduciary Trust Company also provides administrative and investment services to the Plan, records interest and dividend income, and makes distributions to participants. The Plan paid fees of \$124,971 to Vanguard Fiduciary Trust Company during the year ended December 31, 2024.

### **Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 8: PLAN SPONSOR BANKRUPTCY**

During 2022, the Plan Sponsor filed a petition for relief under Chapter 11 of the federal bankruptcy laws in the United States Bankruptcy Court for the Western District of Kentucky. The Company continued to operate their business as “Debtor-in-Possession”. The employer contributions to the plan are not subject to the Bankruptcy Court’s challenge. On December 28, 2023 the Company’s plan of reorganization was confirmed by the court. This order completed the Company’s emergence from Chapter 11 reorganization.
