Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Metasource, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metasource, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Metasource, LLC (the Sponsor) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Sponsor who have 90 days of service and have attained age 18, except for collective bargained employees and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to dollar limits set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor makes matching contributions equal to 50% of the first 2% of eligible compensation for the participant or 50% of the amount the participant contributes to the Plan, whichever is lower. The matching contribution is invested as directed by plan participants. From January 1, 2023 to , the Sponsor paused matching contributions. Contributions are subject to certain limitations. The Sponsor may make discretionary profit sharing contributions at the option of the Sponsor's board of directors. The Sponsor has implemented a Roth 401(k) option for employees. Roth 401(k) contributions are made after tax and withdrawals from the option are tax-free. Roth 401(k) contributions are presented as part of participants contributions on the Statement of Changes in Net Assets Available for Benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions. Participant's elective deferrals are not subject to forfeiture for any reason. Vesting for the remainder of their accounts and actual earnings thereon is as follows:

<u>Years of Service</u>	<u>Vested</u>
Less than two years	0%
At least two, but less than three years	20%
At least three years	100%

If a participant dies or becomes disabled the participant's interest in the Plan becomes 100 percent non-forfeitable without regard to the graduated vesting schedule.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect certain in-service withdrawals from their vested account balance. Such distributions are subject to certain taxes, fees, and other restrictions. Upon termination of service, participants with account balances \$5,000 or less will automatically receive a lump sum distribution amount equal to the value of the participant's vested interest in his or her account. Participants with

account balances in excess of \$5,000 will require participant's consent before any distribution will be made. The Plan allows for certain in-service distributions including hardship and disability distributions provided certain conditions are satisfied and distributions do not exceed certain limits and the participant's vested account balance. Participants are not allowed to receive hardship distributions from qualified matching contributions. Disability distributions can be made from all contribution accounts.

Notes Receivable from Participants

Each participant is allowed a maximum of one outstanding loan at a time. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate between 4.25% and 9.50%. The loan plus interest, which is credited to the participant's account must be repaid within a five-year period (unless for purchase of primary residence) and is repaid directly through payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$532 and \$525 respectively. Amounts applied to employer discretionary matching contributions were \$10,749 and \$0 during the years ended December 31, 2024 and 2023, respectively. These accounts will be used to pay any administrative expenses first and any remaining forfeitures will be used to reduce future employer contributions.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Management of the Plan estimates that these notes are fully collectible and therefore has no reserve for expected credit losses.

Concentrations of Credit Risk

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities. Marketable securities are subject to daily changes in market valuations. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash and cash funds.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 6, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

Note 3 – Certified Information

As of December 31, 2024 and 2023 and for the year ended December 31, 2024, the following information included in the financial statements and supplemental schedule was provided and certified as complete and accurate by the trustee, Empower Trust Company, LLC:

- Net appreciation in fair value of investments, and dividend income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investments and notes receivable from participants, as reflected in the Statements of Net Assets Available for Benefits as of December 31 2024 and 2023;
- Supplemental Schedule- Schedule H, Line 4(i)- Schedule of Assets (Held at End of Year) as of December 31, 2024.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules of Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the investment information certified by the trustee, except for comparing the information contained therein to information included in the financial statements and the supplemental schedule.

Note 4 – Group Annuity Contract

The Plan has a fully benefit-responsive group annuity contract with an insurance company, which is called the Key Guaranteed Portfolio Fund. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying asset in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing interest rates for the fund over the year. The average interest rates for 2024 and 2023 were 1.41% and 1.23%, respectively. The actual average yield earned by the Plan for the group annuity contract is derived by averaging the Plan's quarterly interest rates. The actual averages for 2024 and 2023 were 1.41% and 1.23%, respectively.

Note 5 – Fair Value Measurements

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures (ASC 820) which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information,

volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

Collective Trust Funds – Valued at NAV based on collective trust funds underlying investments as determined by the fund's issuer. Redemptions from these collective trust funds generally can be made daily and are determined to have a readily determinable fair value.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 – Income Tax Status

The Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Services (IRS) dated November, 14, 2022 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has evaluated its tax positions and has determined that it has no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 10 – Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC and Great-West. Empower Trust Company, LLC and Great-West are the combined third party record keeper and trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these investment management services amounted to \$112,017 for the year ended December 31, 2024.

The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 11 – Excess Contributions

The Plan is subject to nondiscrimination requirements of the Internal Revenue Code, which limit the amount of elective deferrals that may be contributed by highly compensated employees. Excess contributions are determined by applying the Actual Deferral Percentage tests as required by the Internal Revenue Code and the applicable Treasury Regulations. A liability in the amount of \$226,952 and \$129,252 was booked to record the return of excess deferral contributions to certain active participants as required to satisfy the relevant nondiscrimination provisions of the Plan for the year ended December 31, 2024 and 2023, respectively.
