Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Frequence, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's adoption agreement and amendments for a more complete description of the Plan's provisions.

General: The Plan, a defined contribution plan qualified under Section 401(k) and related provisions of the Internal Revenue Code, was established effective January 1, 2018, and was restated effective January 1, 2023. The Plan was designed to provide participants with a means to defer a portion of their compensation for retirement funds and to provide benefits in the event of disability, death or financial hardship. The Plan's 401(k) Plan Administrative Committee determines the appropriateness of the Plan's Investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On January 31, 2025, all Plan assets totaling \$8,087,858 were transferred to the Madhive, Inc. 401(k) Plan (Madhive Plan) (see Note E).

Eligibility: All full-time employees who are at least eighteen years of age and have worked at least two months are eligible to participate in the Plan. The entry date is the first day of each calendar month after becoming eligible. The following employees are not eligible to participate in the Plan: nonresident aliens, members of a collective bargaining unit, leased employees and residents of Puerto Rico.

Auto-Enrollment: Unless they choose to formally opt out of the Plan or to defer a different amount, all newly hired employees are automatically enrolled into the Plan with an initial deferral rate of 3% of eligible compensation.

Contributions: Participants may elect to contribute the maximum amount allowed by law of their annual compensation on a pretax or Roth basis up to a maximum of \$23,500 and \$23,000 for 2025 and 2024, respectively. Pretax contributions to a qualified plan are tax deferred and therefore are not included in a participant's compensation for federal income tax purposes until distributed to the participant. The maximum contribution is normally adjusted annually by an inflation index. Eligible participants aged 50 or older are permitted to make catch-up contributions. The maximum catch-up contribution for each year is determined by the Internal Revenue Service and was \$7,500 for 2025 and 2024.

The Company may make discretionary profit-sharing contributions as determined by the Company annually. There were no discretionary matching contributions made for the period January 1, 2025 through January 31, 2025 and year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts: Each participant's account is credited with the participant's contribution and, if applicable, the employer's contribution, and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on the ratio of the participant's balance to all participants' account balances. Each participant directs how contributions made to the Plan are to be invested among the investment options available under the Plan.

Notes Receivable from Participants: The Plan allows participants to borrow an amount not to exceed the lesser of \$50,000 (reduced by the highest outstanding loan balance incurred in the previous one-year period) or one-half the vested interest in the participant's account. The loans are secured by the participant's vested balance and only one loan is permissible at a time, unless one loan is a principal residence loan amortized over a period greater than five years. The minimum loan amount is \$1,000. The term of the loan shall not exceed five years except in the case of a loan for purchasing the principal residence of the participant in which case the term of a loan may not exceed ten years. The loans bear interest at a reasonable interest rate based upon the prime rate as published in the Wall Street Journal plus 1% (which ranged from 9.00% - 9.50%) at the time the loan is approved by the Plan's administrative committee.

Principal and interest are repaid through payroll deductions. Loans are considered in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. In the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. During 2025, no loans were deemed to be in default and there were no deemed distributions. As of January 31, 2025, all loans have been transferred to the Madhive Plan (see Note E).

Vesting: The value of each participant's account is always fully vested and non-forfeitable for participant contributions, rollover contributions, and the interest and earnings on those funds. The Company's discretionary profit-sharing contributions and earnings thereon are fully vested after one year of service. The participants maintained and carried forward this vesting schedule after merging into the Madhive Plan (see Note E).

Distributions to Participants: Distributions from the Plan are available upon any of the following situations: termination of employment at the Company, attainment of normal retirement age, total disability, death, employee's reaching age 59-1/2 or qualified financial hardship or required minimum distributions. Following termination of employment, if a participant's vested account balance does not exceed \$5,000, a distribution of the participant's vested account balance will be made as soon as administratively feasible following termination, regardless of participant consent. If the automatic distribution is greater than \$1,000, and the participant does not elect to receive or roll over the distribution, the distribution will be automatically rolled over into an Individual Retirement Account (IRA). There were no distributions during the period January 1, 2025 through January 31, 2025.

Forfeitures: Forfeitures are created when participants terminate employment before they become 100% vested. Forfeitures can be applied to reduce discretionary profit-sharing or pay administrative expenses payable under the Plan. There were no additional forfeitures, and no forfeitures were used during the period January 1, 2025 through January 31, 2025. The forfeiture account balance was \$6,027 as of December 31, 2024. The forfeiture balance of \$6,039 was transferred to the Madhive Plan on January 31, 2025 (see Note E).

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: The investment in guaranteed insurance contract is stated at contract value (see Note F). The mutual funds are stated at fair value. For more information on valuation methods and inputs, please refer to Note G - Fair Value Measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments are held in a trust administered by Reliance Trust Company (Reliance).

Contributions: Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from amounts paid. Profit-sharing contributions are recorded in the year in which the related participant contributions are recognized.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on an accrual basis. If a participant ceases to make repayments and the plan administrator deems the notes receivable from participants to be in default, the notes receivable from participants' balances is reduced and a benefit payment is recorded. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 31, 2025 and December 31, 2024.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses are paid by the Plan, including loan setup and maintenance fees, which are deducted from participant accounts, if applicable.

Subsequent Events: Accounting Standards Codification (ASC) 855-10 *Subsequent Events* requires additional disclosure for events or transactions that occur after the statement of net assets available for benefits date. There were no significant subsequent events as of November 5, 2025, which is the date the financial statements were available to be issued.

NOTE C - INCOME TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan sponsor believes that the Plan is designed, and is currently being operating, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has an investment in a guaranteed investment contract that is managed by Standard Insurance Company (Standard). Standard is the third-party administrator of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Some fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. In addition, notes receivable from participants are party-in-interest transactions.

NOTE E - PLAN MERGER

On July 16, 2024, the Company entered into a merger agreement with Madhive, Inc. Under the terms of the merger agreement dated December 16, 2024, the Plan was merged into the Madhive Plan and terminated effective January 1, 2025. On January 31, 2025, the Plan assets totaling \$8,087,858 were transferred to the Madhive Plan. The assets transferred consisted of mutual funds totaling \$7,579,882, guaranteed investment contract value of \$484,601 and notes receivable totaling \$23,375. The merger did not change the Plan's vesting schedule, which is 100% vested after one year of service. In addition, the merger required a "No Transaction Period" from January 24, 2025 through February 28, 2025. During this period participants were unable to change investment directives, transfer assets among investment options, or request a distribution.

NOTE F - INVESTMENT IN GUARANTEED INSURANCE CONTRACT

The Plan maintains one guaranteed insurance contract (GIC) related investment option, the Standard Stable Asset C issued by Standard. The contract underlying this investment option is considered fully benefit responsive in accordance with ASC 962, *Plan Accounting – Defined Contribution Pension Plans*. As of January 31, 2025, there was no balance in the Standard Stable Asset C. For the year ended December 31, 2024, the contract value of the investment in the Standard Stable Asset C was \$486,601. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the Standard Stable Asset C become part of the Standard's general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Standard on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions.

Crediting rates for the Plan's Standard Stable Asset C are set by Standard using a process similar to that used by banks or other insurance companies for similar products. Standard declares a crediting rate quarterly for all assets in the fund during the coming quarter. This crediting rate is declared in advance and is reset quarterly. The crediting rate will never be below 1.00% annually. The crediting interest rate to participants for the contract as of December 31, 2024 was 2.33%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoff, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market adjustment or other withdrawal restrictions may apply. Plan management does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable. The Plan merger did not affect the Plan's ability to transact at contract value.

NOTE G - FAIR VALUE MEASUREMENTS

ASC 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820-10 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on January 31, 2025 and December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

We have conducted an ERISA Section 103(a)(3)(C) audit of Frequence, Inc. 401(k) Profit-Sharing Plan (the Plan) as of and for the period January 1, 2025 through January 31, 2025, and have issued our report thereon dated November 5, 2025. Professional standards require that we advise you of the following information relating to our audit.

Our Responsibility in Relation to the Financial Statement Audit

As communicated in our engagement letter dated October 13, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (GAAP). Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, our firm, and our network firms have complied with all relevant ethical requirements regarding independence.

Significant Risks Identified

We did not identify any significant risks with the exception of management override of controls which is a presumed risk in all audits performed in accordance with Generally Accepted Auditing Standards (GAAS).

Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note B to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during the period ended January 31, 2025. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates and Related Disclosures

Accounting estimates and related disclosures are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments. There were no significant estimates noted.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There were no disclosures involving significant judgement noted.

Significant Unusual Transactions

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. The only significant unusual transaction disclosed is the transfer of assets into Madhive, Inc. 401(k) Plan as discussed in Note E of the financial statements.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. In addition, no material misstatements were detected as a result of audit procedures.

Disagreements with Management

Other Significant Matters, Findings, or Issues

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the period, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Other Matters

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.
