Note 1 — Description of the Plan

The following description of ROIHS 401(k) Profit Sharing Plan and Trust (the “Plan”) is provided for general informational purposes only. Plan Participants (“Participants”) should refer to the Plan document for a complete description of Plan provisions.

General

Effective January 1, 2014, ROI Healthcare Solutions, Inc. (the “Company”) established a defined 401(k) contribution Plan with voluntary employee participation available on the first day of employment and attainment of 21 years of age. For an allocation of a Company contribution, a Participant must reach 1,000 hours of service in a plan year with the Company for eligibility. On May 17, 2023, a retroactive Plan amendment was implemented specifically for the plan year ended December 31, 2021, whereby all affected Participants were immediately eligible for an allocation of a Company contribution.

The Company coordinates and manages the administration of the Plan. In coordination with external benefit plan advisors the Company performs reviews of the Plan’s investment manager selection, investment benchmarks, investment performance, and investment risk management policies. The Company monitors the management of the Plan for compliance with the investment policies and guidelines and for meeting investment performance objectives over time. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Plan Trustee

Effective April 1, 2019, the Company engaged Matrix Trust Company as the Trustee (collectively the “Trustee”), and investment custodian of the Plan. Concurrently, the Company appointed Mutual of Omaha (Mutual) as the Plan’s recordkeeper. On August 20th of 2024 the Company engaged Empower Trust Company LLC as the Plan’s Trustee (now collectively the “Trustee”) and Recordkeeper and Matrix Trust and Mutual are no longer involved in plan management or administration. For additional information, see Note 4 Certified Information.

The Trustee holds all property received and invests and reinvests Plan assets pursuant to Participant investment selections and Plan documents.

Contributions

Under the Plan, Participants may elect to contribute from 1% to 100% (in increments of 1%) of eligible compensation. Eligible compensation is defined within the Plan document and is subject to restrictions of the Internal Revenue Code of 1986, as amended (“IRC”). Participants may also contribute amounts representing distributions from other qualified benefit or defined benefit contribution plans (Rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are withheld on a pro rata basis from each payroll as either pre-tax or Roth contributions. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation within 30 days of their hire date unless they affirmatively elect not to participate in the Plan. The deferral rate will increase automatically annually by 1% up to a maximum of 6% of eligible compensation. Participants may modify their election or opt out of the Plan at any time.

The Company will contribute a Safe Harbor matching contribution in an amount equal to: (i) 100% of the matched employee contributions that are not in excess of 1% of Plan compensation, plus (ii) 50% of the amount of the matched employee contributions that exceed 1% of your Plan compensation but that do not exceed 6% of your Plan compensation. There is also a provision allowing for additional discretionary Company contributions. There were no additional discretionary contributions for the year ended December 31, 2024.

With the IRC, Participant contributions were limited to \$23,000 in 2024 and \$22,500 in 2023. Participants 50 years of age or older prior to the end of the calendar year were eligible to make catch-up contributions of up to \$7,500 in 2024 and 2023.

Note 1 — Description of the Plan (Continued)

Vesting

Participant contributions (including Rollover contributions) are always fully vested upon contribution. Employer matching contributions and non-elective contributions vest over a six-year period, with 20% of the vesting after two years of service, and an 20% additional vesting every additional year of employment until six years of employment at which time the employer contributions are 100% vested. Employer Safe Harbor matching contributions vest at 100% after two-years.

Notes Receivable from Participants

A Participant may borrow up to 50% of his or her account balance, to a maximum of \$50,000. A Participant may have only one loan outstanding at any one time. A loan is required to be repaid through payroll deductions over a period not to exceed five years, with the exception of loans for the purchase of a primary residence which may be repaid over a period of up to 15 years. Early payoff of Participant loans is permitted by the Plan. The loan interest rate applied to Participant loans is fixed on the date the loan is requested at the prime rate published in the Wall Street Journal on the last business day of the previous month plus 1%. Participant loans are limited to Participants who are active employees. As of December 31, 2024 and 2023, the interest rates on Participant loans ranged from 4.25% to 9.50%.

Payment of Benefits

A Participant may withdraw the total amount in his or her account upon either (i) termination of employment, (ii) reaching age 59½, (iii) disability, or (iv) death. The full value of the Participant's account may be distributed to the Participant upon retirement or permanent disability, if elected by the Participant, and is subject to income taxation upon distribution. If death occurs before termination of employment, the Participant's account is fully distributed to his or her designated beneficiary(ies). Upon termination of employment, if the value of the Participant's account is between \$1,000 and \$7,000 the Participant can elect the manner in which the distribution is made to them. If the Participant does not make such election within 30 days of termination of employment the vested balance will be rolled over to a traditional Individual Retirement Account in the Participant's name. If the balance of the account is less than \$1,000 and no election is made within 30 days of termination of employment the Participant will receive a cash distribution of the amount, less any fees and a 20% federal tax withholding, unless an alternative withholding amount is requested..

Forfeitures

Forfeitures are available to reduce Company contributions, pay Plan expenses, or be reallocated to Participant accounts. The balance of the forfeitures at December 31, 2024 and 2023 was \$8,952 and \$28,080, respectively. In addition to the forfeiture account, the Plan has established a suspense account to hold excess contributions that have previously been made to the Plan. The balance of the suspense account was \$0 and \$2,328 as of December 31, 2024 and 2023, respectively. Also, for the year ended December 31, 2024 the Plan used \$40,474 of forfeitures to reduce Company contributions.

Participant Accounts

Each Participant account is credited with the Participant's contributions, Company matching, and Company profit sharing contributions, if any, and charged with fees related to notes receivable from Participants and distributions and allocations of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings, account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Note 2 — Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America ("GAAP") as applied to defined contribution plans and in accordance with the terms of the trust agreement.

Administrative Expenses

Administrative expenses consist of all expenses incidental to the administration, termination, or protection of the Plan, including, but not limited to, legal, accounting, investment manager, and trustee fees.

Certain administrative fees are incurred by Participants such as loan management fees, investment advisory fees and account liquidation fees as a result of early distribution penalties or due to unqualified account withdrawals or distributions. All other administrative fees are paid by the Plan Sponsor, the Company, and thus are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (exit price). See Note 3, Fair Value of Financial Instruments, for further discussion and disclosures related to fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and for which participant compensation is earned

Notes Receivable from Participants

Notes receivable from Participants are measured at the Participant's unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as Plan distributions in accordance with the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

Note 2 — Summary of Significant Accounting Policies (Continued)

Consideration of Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosure through November 4, 2025, the date the financial statements were available to be issued.

Note 3 — Fair Value of Investments

Fair value is defined as the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Inputs utilized in determining fair value are based on a three-level valuation hierarchy that prioritizes these inputs based on the degree to which they are observable. Following is a description of the three input levels of the fair value hierarchy:

- Level 1 — unadjusted, quoted prices for identical assets or liabilities in active markets;
- Level 2 — quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and inputs other than quoted market prices that are observable or that can be corroborated by observable market data. If the asset or liability has a specified term, the level 2 inputs must be observable for substantially the full term of the asset or liability;
- Level 3 — unobservable inputs based upon the reporting entity's internally developed assumptions that market participants would use in pricing the asset or liability that are significant and unobservable.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

Pooled Separate accounts are valued at the net asset value (NAV) or equivalent based on units of the mutual fund accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

Mutual Funds

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 — Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was derived from information supplied to the Plan administrator and certified as complete and accurate by the Matrix Trust Company and Empower Retirement, qualified institutions. Empower Retirement has also certified the notes receivable from participants' balance as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5 – Guaranteed Investment Contract

The Plan had an investment in a fully-benefit responsive guaranteed investment contract with Empower Retirement and Matrix Trust Company for \$17,329 and \$44,863 as of December 31, 2024 and 2023, respectively. The contractor maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average rate for 2024 was 1.41%. The crediting rate is reviewed on a periodic basis for resetting. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by the Participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer, including Plan amendments, bankruptcy of the Plan sponsors, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, premature termination of the contract, or other significant changes or regulatory matters. At this time no events are probable of occurring that might limit the Plan to transact at contract value with the contract issuers and that would also limit the ability to transact at contract value with the Participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Such events include uncured violation of the Plan investment guidelines or other material breaches or misrepresentations under the contract, as well as any material amendments to the agreement without consent of the issuer.

Note 6 — Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100 percent vested in their accounts.

Note 7 — Tax Status

The Plan received a favorable opinion letter dated July 13, 2021, from the Internal Revenue Service ("IRS"). The Plan has been amended since the most recent opinion letter; however, the Company believes that both the Plan design and operation remain compliant with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate Plan tax positions and recognize a tax liability (or asset) if the Plan has entered into an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that require recognition of a liability (or asset) or disclosure in the financial statements. Additionally, the Plan has not incurred any penalties or interest on penalties by any taxing jurisdictions for any reason. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 8— Related Party and Party-in-Interest Transactions

Certain Plan investments are in accounts managed by the Trustees which include various mutual fund accounts and other pooled separate accounts, and an investment contract. The Plan has notes receivable from some of its Participants. Such balances would be considered party-in-interest transactions. However, investments in these funds and Participant notes receivable are permitted under the provisions of the Plan and would be exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan did not pay any fees to the trustee for the year ended December 31, 2024 as the Company was responsible for such fees. There were also identified delinquent participant contributions representing a party-in transaction.

Note 9 – Risks and Uncertainties

The Plan offers investments in securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities, and thus the net asset value (NAV) of the funds, will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades.
