### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Youth Dynamics, Inc. Employer Sponsored Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 14, 2025 (in liquidation) and June 30, 2024 (ongoing), and the related statements of changes in net assets available for benefits for the period from July 1, 2024, to March 14, 2025 (in liquidation) and the year ended June 30, 2024 (ongoing), and the related notes to the financial statements (2025 and 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended March 14, 2025, and as of and for the year ended June 30, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting***

As further discussed in note 1 to the financial statements, the Board of Directors of Youth Dynamics, Inc., the Plan sponsor, voted on September 4, 2024, to enter into a partnership agreement with the Yellowstone Boys and Girls Ranch. The decision was made to terminate the Plan, effective December 16, 2024. In accordance with GAAP, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2024 financial statements, to the liquidation basis used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance, and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

### 1. DESCRIPTION OF THE PLAN

The following description of Youth Dynamics, Inc. Employer Sponsored Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**Plan Termination** On September 4, 2024, the Board of Directors of Youth Dynamics, Inc. (the Company and Plan sponsor) unanimously approved a partnership agreement with Yellowstone Boys and Girls Ranch. As part of this merger, management decided to terminate the Plan subject to the provisions of *Employee Retirement Income Security Act of 1974* (ERISA) on December 16, 2024. At December 16, 2024, all contributions into the Plan ceased. All participant account balances have been distributed at March 14, 2025.

**General** The Plan was a 403(b) defined contribution plan covering all full-time employees of the Company, who normally work 20 or more hours per week and have attained the age of 18. The Plan was subject to the provisions of ERISA, as amended. The Plan was originally established at November 30, 1998, and has been subsequently amended and restated. The general administration of the Plan, and the responsibility for carrying out the provisions of the Plan, rested with Plan management, who delegated certain authority to the trustee. The trustee maintained participant account records and executed transactions such as benefit payments to participants.

**Contributions** Effective December 16, 2024, contributions were no longer permitted. Prior to that, participants could elect to contribute to the Plan, in the form of pre-tax elective deferrals or Roth 403(b) deferrals up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants with 15 years of service were eligible to make a special one-time 403(b) catch-up contribution up to \$3,000. Participants could also contribute amounts representing distributions from other qualified retirement plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company contributed a safe harbor matching contribution not to exceed a 100% match for the first 5% of compensation contributed by participants who have completed 1,000 hours during a consecutive 12-month period. For the period ended March 14, 2025, and the year ended June 30, 2024, safe harbor matching contributions totaled \$58,660 and \$167,046, respectively. Each year, at the option of the Company's Board of Directors, the Company may make a discretionary nonelective contribution. In addition to the age requirement noted above, participants must also have completed 1,000 hours during a consecutive 12-month period and be employed on the last day of the Plan year to be eligible to receive this contribution. The Company did not make a discretionary nonelective contribution for 2025 or 2024.

**Participant Accounts** Each participant's account was credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings. Allocations of Plan earnings were based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants** Loans were not permitted by the Plan.

**Vesting** Participants were 100% vested in their elective deferrals, rollover contributions, and any Company contributions, plus actual earnings thereon.

**Payment of Benefits** Upon termination of service due to death, disability, retirement, or other reasons, a participant or their beneficiary could have elected to receive a lump-sum amount equal to the value of the participant's vested interest, could have transferred the vested value to another retirement investment vehicle, or could have chosen to leave vested benefits in the Plan until April 1 following the end of the year in which age 73 was attained. At March 14, 2025, and June 30, 2024, there were no amounts due to participants who had withdrawn from the Plan, but had not yet been paid.

**Hardship Distributions** Under certain circumstances, participants who were still employed by the Company could withdraw from their account balance to pay for a financial hardship as described in the Plan document. Hardship distributions could only be withdrawn from the participant's pre-tax elective deferrals or Roth deferrals.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** The 2025 financial statements were prepared under the liquidation basis of accounting, which is consistent with the Company's Board of Directors' decision to terminate the Plan. Under the liquidation basis of accounting, the Plan is required to accrue, and separately present, the costs that it expects to incur and the income that it expects to earn through the liquidation date. The 2024 financial statements were prepared under the accrual method of accounting, or, in other words, the ongoing basis of accounting. Both methods are in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** Investments were reported at fair value (except for fully-benefit responsive investment contracts, which were reported at contract value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisors and the trustee (or custodian). Fair value measurements are discussed below.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on their ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology included quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that were observable for the asset or liability; or inputs that were derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability had a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024.

*Mutual Funds:* Assets were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

See note 4 for the classification of these assets within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes Receivable From Participants** Loans were not permitted by the Plan.

**Payment of Benefits** Benefits were recorded when paid.

**Expenses** Certain operating expenses of the Plan were deducted from participant accounts and the remaining expenses were paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

### 3. INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included on the statements of net assets available for benefits, and the investment income included on the statements of changes in net assets available for benefits as of and for the period ended March 14, 2025, and as of and for the year ended June 30, 2024, were not subject to auditing procedures and have been certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) for 2025 and 2024. Empower is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional group unallocated fixed deferred annuity contract with Great-West Life and Annuity Insurance Company (Great-West). Great-West maintained the contributions in a general account. The contract met the fully benefit-responsive investment contract criteria, and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At June 30, 2024, the total contract was \$40,082.

The guaranteed investment contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1.00% or more than 3.00%. The crediting rate was reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The average yield earned for period ended March 14, 2025, and year ended June 30, 2024, was 2.84% and 2.20%, respectively.

The Plan's ability to receive amounts due was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events include the following: (1) The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code* (IRC), or the failure of the trust to be tax exempt under Section 501(a) of the IRC; (2) Premature termination of the contracts; (3) Amendments to the Plan document, including complete or partial plan termination or merger with another plan; (4) Changes to the Plan's prohibition on competing investment options; or (5) Bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, or that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) Uncured violation of the Plan's investment guidelines; (2) Breach of material obligation under the contract; (3) Material misrepresentation; or (4) Material amendment to the agreements without the consent of the issuer.

## 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Empower. Empower was the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Empower provided certain administrative services to the Plan pursuant to an agreement between the Company and Empower. Empower received revenue from mutual fund service providers for services provided to the funds. This revenue was used to offset certain amounts owed to Empower for administrative services to the Plan.

Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing rather than a direct payment. If the revenue received by Empower from investment providers exceeded the amount owed under the agreement, Empower remitted the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company made payments to Allied Investment Advisors, First Interstate Wealth Management, and Big Sky Retirement for administrative expenses not covered by revenue sharing.

## 7. TAX STATUS

The Plan was designed to qualify under section 403(b) of the IRC. The terms of the Plan were prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedures 2007-71 (or the draft Listing of Required Modifications issued April 4, 2009). The Plan was required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under section 403(b).
