## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Primary Care Partners, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Primary Care Partners, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Primary Care Partners, Inc. (the Company) who have completed one year of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Under the terms of the Plan, participants may elect to make both pre-tax and after-tax contributions. The total of each participant's annual pre-tax and after-tax contributions are subject to applicable Internal Revenue Code (IRC) limits. Additionally, all employees eligible to participate in the Plan that have attained age 50 before the close of the plan year are eligible to make pre-tax and after-tax catch-up contributions up to the maximum amount allowed under the IRC. Each year, the Company makes a safe harbor nonelective contribution equal to 3% of each participant's compensation. The Company may also make a profit sharing contribution each year at its discretion. The amount that can be added each year to a participant's account, which includes contributions made by the participant and the Company on the participant's behalf, is subject to restrictions imposed by the IRC.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions made on the participant's behalf, and an allocation of plan earnings. Additionally, plan expenses are paid by the participants by reducing each participant's contribution by an allocated amount. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their employee contributions and safe harbor nonelective contributions made by the Company plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on continuous service at 20% per year beginning at the end of year one, resulting in the participant becoming 100% vested at the end of year five. As defined in the plan agreement, to earn a year of service, a participant must be credited with at least 1,000 hours of service during the plan year.

A participant can also become 100% vested in the Company's discretionary contribution portion of their account plus earnings thereon if the participant dies, attains age 59½, becomes disabled, or upon termination of the Plan.

### **Notes Receivable from Participants**

Vested participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. Loan terms are up to five years or twenty years if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime rate on the date of the loan.

### **Payment of Benefits**

Upon separation of service, a participant will receive a lump-sum payment equal to the value of his or her account, provided the account does not have a value greater than \$1,000. Distributions greater than \$1,000 must be directly rolled over to an IRA on behalf of the terminated participants who do not select a payout option. A participant with a vested account balance greater than \$7,000 may continue holding investments within the Plan, or elect to withdraw. Prior to separation from service, a participant may elect to receive a distribution of all or any portion of the participant's account balance attributable to deferral contributions, safe harbor contributions made by the Company, and profit sharing contributions made at the Company's discretion if the participant has attained the age of 59½ or the participant has incurred a disability.

### **Forfeitures**

If a participant terminates service prior to earning enough years of service to become fully vested in the Company's discretionary contributions, they will forfeit the amount in which they are not vested. Forfeitures may be used to offset employer contributions for the Plan year in which the forfeiture occurs or in the Plan year immediately following the year in which the forfeiture occurs. Net forfeitures used to reduce employer contributions for the years ended December 31, were \$16,554 (2024) and \$8,834 (2023). Unallocated forfeitures are not considered assets available for benefits as of year-end. At December 31, unallocated forfeitures totaled \$27 (2024) and \$17,390 (2023).

### **Administrative Expenses**

Administrative expenses shown in the Plan's statements of changes in net assets available for benefits include marketing fees charged to the Plan's mutual funds (referred to as 12b-1 fees) and other expenses paid to third party administrators performing various services such as recordkeeping, transaction processing, and custodial services for the Plan.

### **Plan Tax Status**

On March 31, 2008, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, was acceptable for use by employers for the benefit of their employees under Section 401 of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan agreement. Interest income is recorded on the accrual basis.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the Supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

### **NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan complies with Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* (ASC 820). ASC 820 defines fair value, establishes a consistent framework for measuring fair value, and expands disclosure requirements for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Under ASC 820, assets and liabilities are grouped into three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

- Level 1 – Valuation is based upon quoted prices for identical instruments traded in active markets.

- Level 2 – Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 – Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobserved assumptions reflect plan management’s own estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models, and similar techniques.

Under ASC 820, the Plan bases fair values on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements for assets and liabilities where there exists limited or no observable market data, and therefore, are based primarily upon the Plan’s estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability, and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future values.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds and Money Market Fund(s):* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Self-Directed Funds:* Valued at the total of the ending balances of participants’ accounts, which approximates fair value since the underlying investments principally consist of mutual funds, common stocks, money market funds, and bond funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PLAN TERMINATION**

Although they have expressed no intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA and any collective bargaining agreements in effect at the time. In the event of Plan termination, all participants will become 100% vested in their accounts.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds and money market funds managed by Charles Schwab Trust Bank, the Plan's trustee, at December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental Schedule H, Line 4i of Assets (Held at End of Year).

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through October 8, 2025, the date at which the financial statements were available to be issued, and determined that no events have occurred that would require disclosure.
