Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Davis Wright Tremaine LLP 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Davis Wright Tremaine LLP 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of the Davis Wright Tremaine LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General – The Plan is a defined contribution plan for the partners, associate attorneys, and staff (collectively, the Employees) of Davis Wright Tremaine LLP (the Firm or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employer contributions – Employees, excluding certain partners and staff, as defined by the Plan, are eligible to receive Employer contributions at the first start date following completion of two years of service. The Employer contributes, at its discretion, quarterly and annual contributions. Partners may be provided an additional Employer contribution based on their distributable income. Employer contributions of \$16,832,993 were made for the 2024 Plan year.

Participant contributions – Employees and eligible partners are eligible to make salary deferrals as soon as they elect to participate in the Plan. Participants who elect to participate may contribute, on a pretax basis or after-tax basis, up to 100% of eligible compensation, subject to certain limitations.

The Plan has an auto-enrollment feature whereby the Firm automatically deducts 5% on behalf of participants who reach the eligibility requirements unless the participant declines in writing or makes a different election. Participant contributions under the automatic enrollment feature are invested in a qualified default investment alternative until the participant designates their own investment allocation.

Effective, July 1, 2023, employees designated as project attorneys, surge attorneys, or contract attorneys are eligible to participate in the Plan with respect to tax-deferred contributions.

Vesting and participant accounts – Employer and participant contributions and related earnings are 100% vested to the participant at all times. Participants designate how their contributions and the Employer contributions will be invested in a variety of investment funds, including an option for individually directed accounts. Individually directed accounts include investments in common and preferred stocks, mutual funds, corporate and U.S. government obligations, and approved investment partnerships.

Earnings or losses in individually directed accounts are credited or charged to the individuals' accounts. Investment earnings in all other funds are allocated daily to participants based on their proportionate share of their asset balance to all balances.

Payments of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive the vested interest in their account in either a lump sum, partial or annual installment distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum or partial distribution. Participants with balances less than \$1,000 receive an automatic distribution.

Notes receivable from participants – Participants may borrow from the Plan at amounts limited to the lesser of 50% of their account balances or \$50,000 and may request no more than two new loans in a Plan Year. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case the term of the loan may be greater. Loans are secured by the participant's accrued benefits. Interest rates are fixed based on the prime rate as reported in the Wall Street Journal plus 1.0% on the day the note is processed. As of December 31, 2024, interest rates on outstanding loans ranged from 3.25% to 9.50% with various maturities through October 2039.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates – The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value as certified by the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest.

Plan expenses – All expenses of Plan administration shall be paid by the trust to the extent that the Employer does not elect to pay in accordance with applicable law. Such expenses shall include any expenses incident to the functioning of the committee, including but not limited to accountants, actuary, counsel, and other specialists, and other costs of administering this Plan. Participants are also charged based on specific participant transactions, such as to maintain individually directed accounts and loans.

Payment of benefits – Benefits are recorded when paid.

Subsequent events – Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Shares of registered investment companies (mutual funds) are valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Cash and cash equivalents – The cash and cash equivalents are money market accounts which are public investment vehicles valued using \$1 for the NAV. The money market accounts are classified within Level 1 in the valuation hierarchy as cash equivalents.

Collective trusts – Units held in collective trusts are valued using the NAV practical expedient of the fund. The NAV practical expedient of a collective investment fund is based on the fair value of the underlying assets owned by the collective trust managers minus liabilities and divided by the number of units of the fund outstanding on the calculation date. The collective trusts have no liquidity restrictions at year end and daily redemptions are permitted.

The following investments are held in the individually directed accounts:

Common and preferred stocks – Common and preferred stocks are classified within Level 1 of the valuation hierarchy when they are valued at the closing prices reported on the major market on which the individual securities are actively traded. Certain common and preferred stocks held by the Plan do not have active markets or quoted market prices and may be valued using formal appraisals, estimated liquidation values, or forecasted future cash flows discounted at interest rates commensurate with the risk involved. If valuation inputs are observable, the investments are classified within Level 2 of the valuation hierarchy. Otherwise, the investment is classified within Level 3 of the valuation hierarchy.

Corporate obligations and U.S. government obligations – Corporate obligations and U.S. government obligations generally do not have quoted market prices available and fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, discounted cash flows and other observable inputs. Such securities are classified within Level 2 of the valuation hierarchy.

Limited partnerships and real estate investment trusts – Limited partnerships and real estate investment trusts with no public markets are classified within Level 3 of the valuation hierarchy. Investments in partnerships and real estate investment trusts are valued by the trustee and/or the management of the partnership or real estate investment at estimated fair value.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Firm by a letter dated February 19, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various domestic and international investment securities. Investment securities are exposed to multiple risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities that changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Note 6 – Certified Investment Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of:

- Participant-directed investments and notes receivable from participants reflected in the accompanying statements of assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by an affiliate of Charles Schwab Trust Bank and, therefore, these transactions qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has expressed no intent to do so, the Firm has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' account balances would be disbursed in accordance with the Plan's provision for normal payment of benefits.

Note 9 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
