## Independent Auditors' Report

### Opinion

We have audited the financial statements of District 65 Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets (in liquidation) available for benefits as of January 31, 2025 and 2024, and the related statements of changes in net assets (in liquidation) available for benefits for the years ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets (in liquidation) available for benefits of District 65 Pension Plan as of January 31, 2025 and 2024, and the changes in net assets (in liquidation) available for benefits for the years ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of District 65 Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **A. Description of the Fund**

The following brief description of the District 65 Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provision.

*General*

The Plan is a multi-employer, defined benefit pension plan established under the provisions of an Agreement and Declaration of Trust (the “Trust”), as amended, between District 65, U.A.W., AFL-CIO (the “Union”) and the Trustees. The Trust was established for the purpose of providing and maintaining normal, early and disability retirement benefits. These benefits are available to employees who meet specific eligibility requirements as to age and years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

*Plan Termination and Mass Withdrawal of Employers*

During the fiscal year ended January 31, 1996, the Plan experienced two significant events: (1) an amendment was adopted that provided that service and pay after April 15, 1995 be disregarded for all Plan purposes; and (2) all employers withdrew from the Plan as of January 31, 1996. The amendment freezing benefit accruals and vesting service credit as of April 15, 1995 and the withdrawal of all employers as of January 31, 1996 terminated the Plan under ERISA Section 4041A(a)(2).

Upon termination, all assets of the Plan shall be used for the exclusive benefit of participants and beneficiaries and shall be allocated among them in accordance with the Plan agreement.

Certain benefits under the Plan are insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor’s pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Whether all participants receive their benefits will depend on the sufficiency of the Plan’s net assets to provide those benefits and also may depend on the level of benefits guaranteed by the PBGC.

*Pension Benefit Guaranty Corporation (“PBGC”) Assistance*

On October 25, 2005, the Plan entered into an agreement with the PBGC for financial assistance. The agreement provides for the PBGC to provide the Plan additional amounts and that such additional amounts shall be added to the amount in the original agreement. Such amounts are evidenced by promissory notes. Monthly, the Plan must provide the PBGC with (a) an estimate of funds needed to pay benefits and administrative expenses for the following month, and (b) a reconciliation of financial assistance received from the PBGC and payments of benefits and administrative expenses of the prior month. As of January 31, 2025 and 2024, total financial assistance from the PBGC amounted to \$290,061,318 and \$280,326,718, respectively.

The Plan has no resources nor does it expect to have resources in the future to repay these notes. Accordingly, such amounts have been included as additions to Plan assets in the statements of changes in net assets available for benefits (in liquidation) for the years ended January 31, 2025 and 2024.

**A. Description of the Fund (Continued)**

*Plan Benefits*

Pension benefits under the Plan depend primarily on the following factors:

- Average annual earnings
- Credited service
- Whether service was continuous or interrupted
- Benefit tables

The various types of benefits and requirements are described as follows:

- Normal Pension Benefits: The later of 65 years of age or the fifth anniversary of Plan participation.
- Early Pension Benefits: Before January 1, 1994, an employee must have (a) attained age 55 and completed 10 years of credited service, or (b) completed 30 years of credited service. On or after January 1, 1994, an employee must have attained age 55 and completed 10 years of credited service.
- Disability Pension Benefits: If an employee becomes totally and permanently disabled after completing 10 years of credited service. No disability retirements after April 15, 1995.
- Vested Benefits: Participants are fully vested after completion of 10 years of vesting service.
- Cash Withdrawal Benefits (non-vested pension benefits): Participants who has completed 5 years of credited service and was not eligible for a vested benefit.
- Pre-Retirement Spouse's Protection: 10 years of vesting service or eligible for a retirement benefit. Effective November 1, 2005, this benefit is no longer available.

The Plan also provides for a joint and survivor annuity benefit whereby the employee will receive a reduced pension benefit, as actuarially determined, for his or her lifetime. Upon the employee's death, his or her survivor will receive a joint and survivor annuity benefit equal to 50% of the employee's pension. An option which allows a survivor to receive a joint and survivor annuity benefit equal to 75% of the employee's pension was added effective January 1, 2008.

Effective November 1, 2005, benefit payments may not exceed the amounts guaranteed by the PBGC which are 10% of the first \$11 plus 75% of the remaining balance of the Plan's monthly benefit accrual rate, times each year of credited service.

**B. Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements have been prepared using the liquidation basis of accounting due to the Plan's termination and the mass withdrawal of employers during the fiscal year ended January 31, 1996.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results could differ from these estimates.

*Concentration of Credit Risk*

Financial instruments that potentially expose the Plan to concentrations of credit risk include cash. In assessing its risk, the Plan's policy is to maintain funds only with reputable financial institutions. While the Plan attempts to limit any financial exposure, its deposit balances may, at times, exceed federally insured limits. The Plan has not experienced any losses on such accounts.

*Actuarial Present Value of Accumulated Vested Plan Benefits*

The Plan (i) was amended on April 15, 1995 to freeze service and salaries for benefit purposes and (ii) experienced a mass withdrawal termination on January 31, 1996. Because of these events, non-vested benefits can no longer become vested. Therefore, the actuarial present value of non-vested accrued benefits was not determined.

For retired participants and beneficiaries, the present value of benefits is based on the amount and form of annuities being paid as of January 31, 2025 and 2024.

**C. Actuarial Present Value of Accumulated Plan Benefits**

The actuarial present value of accumulated vested Plan benefits is the present value of expected future payments for benefits to Plan participants which have been accrued as of the termination date. Accumulated benefits include amounts expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of vested participants who have died, and (c) present participants or their beneficiaries.

The actuarial present value of accumulated Plan benefits is that amount which results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The actuarial present value of accumulated vested benefits of the Plan was determined by the Plan's actuary, First Actuarial Consulting, Inc. ("FACT"), as of January 31, 2025 and 2024. These valuations were determined in accordance with PBGC Regulation Part 4281, Subpart B – Valuation of Plan Benefits and Plan Assets Following Mass Withdrawal.

The significant actuarial assumptions used in the January 31, 2025 and 2024 valuations are as follows:

- Investment Return – 5.42% in 2025 (5.45% for the first 20 years, and 5.22% thereafter in 2024).
- Mortality – Mortality table specified in ERISA Section 4044.
- Retirement Age – Age of earliest retirement eligibility, or attained age if greater.
- Expense Load – Calculated in accordance with ERISA section 4044.
- Changes in Methods and Assumption from Last Year - The interest rate and mortality assumptions were changed to be those in effect at January 31, 2025, in accordance with ERISA §4281.

**D. Due from Withdrawing Employers**

During the fiscal year ended January 31, 1997, the Trustees issued a settlement proposal to the former contributing employers, which set forth options to employers to settle their withdrawal liability and minimum funding deficiency obligations (namely, a lump-sum option and a payment over time option). As of January 31, 2025 and 2024, the Plan had one receivable from a withdrawing employer, which represents their share of:

- the Plan’s unfunded liabilities, as determined by the Plan’s consulting actuary, based on the valuations, as of January 31, 1995; and
- the Plan’s accumulated funding deficiency as determined by the Plan’s consulting actuary for the years ended January 31, 1995, 1994 and 1993.

This receivable has been recorded net of an allowance for the amount estimated to be doubtful of collection.

The “employer withdrawal liability” amounts, on the statement of changes in net assets (in liquidation) available for benefits, if any, for the years ended January 31, 2025 and 2024, represent the net adjustment to the amounts due from withdrawing employers after evaluating collectability at the end of each fiscal year, including amounts collected. During the year ended January 31, 2025 and 2024, the Plan received \$0 from withdrawing employers for both years. During the year ended January 31, 2024, the Plan increased the allowance by \$1,000 to fully reserve the balance owed.

The Plan will pursue legal action against those withdrawing employers who have not signed a settlement agreement or have failed to remain current in their obligations to the Plan under the settlement agreement.

**E. Tax Status**

The Internal Revenue Service (“IRS”) determined and informed the Plan by a letter dated April 30, 2015, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Prior to the 2015 letter, the Plan was informed by the IRS by a letter, dated June 6, 2011, that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan’s counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has conducted that, as of January 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

**F. Minimum Funding Standards**

As discussed in Notes A and D to the financial statements, any funds needed to pay benefits and administrative expenses of the Plan shall be received from former contributing employers as settlement of their withdrawal liability and minimum funding deficiency obligations and from the PBGC in accordance with its financial assistance agreement with the Plan.

**G. Subsequent Events**

For purposes of determining the effect of subsequent events on these financial statements, management has evaluated events subsequent to November 6, 2025, the date on which the financial statements were available to be issued.
