### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Metropolitan Anesthesia Network Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Metropolitan Anesthesia Network Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Metropolitan Anesthesia Network, LLP. The Plan excludes nonresident aliens, leased employees, temporary and seasonal employees, independent contractors, certified registered nurse anesthetists (CRNAs), licensed physicians working as independent contractors and employees covered by a collective bargaining agreement. CRNAs employed by South Valley Anesthesia, P.A., Midwest Anesthesiologists, P.A., and Minneapolis Anesthesia Partners, PLLC, CRNAs employed by Multi-Sites Anesthesia, P.A. and Associated Anesthesiologists, P.A. are eligible to participate in the plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, CRNAs employed by White Oak Anesthesiology Associates, P.A. may participate in the plan.

Effective January 1, 2024, the Plan was amended to merge Central MN Anesthesia, Ltd 401k PS Plan into the Plan, which included adding Central MN Anesthesia, Ltd as an adopting employer, and allowing temporary and seasonal employees to participate in the Plan. Assets of \$8,365,068 were transferred in related to the merger during the year ended December 31, 2024.

**Eligibility**

Eligible employees of adopting employers (collectively, the Employer) of the Metropolitan Anesthesia Network Profit Sharing Plan are eligible to participate in the deferral, safe harbor matching and non-safe harbor matching portions of the Plan on January 1 and July 1 coinciding with or immediately following their employment date. An eligible employee begins to participate in the profit-sharing portion of the Plan on January 1st or July 1st coinciding with or immediately following completion of two years of service and attainment of age 21.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants can elect to contribute up to 50% of their compensation, not to exceed annual limitations specified in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to make Roth 401(k) deferrals. The Employer annually contributes a safe harbor matching contribution of 100% of employee deferrals up to 3%, plus 50% of participant deferrals that exceed 3% but do not exceed 5% of employees' eligible compensation. Nonelective contributions are determined annually by the Employer. For the year ended December 31, 2024, adopting employer contributions were \$13,193,662.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in all contributions plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ or age 55 from vested accounts containing discretionary, nonelective and matching contributions and hardship distributions subject to plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Self-Directed Brokerage Accounts**

Participants have the opportunity to invest their contributions in participant-selected investments through a brokerage account established with Charles Schwab Bank or Charles Schwab Trust Bank.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to pay administrative expenses or reduce Employer contributions. During the year ended December 31, 2024, there were \$6,555 of forfeitures used to pay administrative expenses and \$6,467 of forfeitures used to reduce Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$0 and \$6,892, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured as fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at NAV of units, without further adjustment. Net asset value is based upon the fair value of the underlying investments. NAV is a readily determinable fair value and is the basis for current transactions.

Self-Directed Brokerage Accounts include mutual funds, cash and cash equivalents, exchange trade funds, common stock, and corporate bonds. The mutual funds are valued as per the above. The remaining categories are valued as per the below:

*Cash and Cash Equivalents:* Includes money market funds and invested cash accounts. Money market funds are valued at the net asset values reported by the money market fund on quoted market prices. Invested cash accounts are valued at cost which approximates to fair value. T Bill Notes are valued using broker feeds and are based on the yield to maturity.

*Exchange Trade Funds and REITS:* Valued at the closing price in active markets in which the individual security is traded.

*Common and Preferred Stocks:* Valued at the closing price in active markets in which the individual security is traded.

*Corporate Bonds:* Valued at the closing price reported in the active market in which the bond is traded, or if not traded on the day of measurement, valued based on yields currently available on comparable securities of issuers with similar credit ratings.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter on the prototype plan dated September 21, 2020, from the Internal Revenue Service (IRS). The Plan has been amended subsequent to the determination letter being received; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Charles Schwab Trust Bank, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
