Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Capitol Hill Day School DC and TDA Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Capitol Hill Day School DC and TDA Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan was a 403(b) defined contribution plan covering all eligible employees of Capitol Hill Day School (the “School”). The Plan was established and originally effective January 1, 1983, and most recently restated January 1, 2018, to provide eligible employees of the School to accumulate savings that provide benefits in the event of retirement, disability, or death. The Plan was structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The School was responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

The School retained Teachers Insurance and Annuity Association (TIAA) to maintain assets of the plan as custodian and to perform recordkeeping services.

Effective November 1, 2024, the Plan merged into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan.

Eligibility - Prior to the merger, an employee became immediately eligible to participate in the plan for elective deferral purposes. An eligible employee must have attained 21 years of age to receive employer matching and discretionary nonelective contributions. Hourly employees were excluded from receiving matching and nonelective contributions. An eligible employee could enter the Plan on the first day of each month following the date of eligibility.

Contributions - Prior to the merger, participants could contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. An eligible employee could also contribute a qualified organization catch-up. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The School contributed a matching contribution of 2% of compensation as long as the participant’s elective deferrals equaled or exceeded 4% of the participant’s compensation. The School could also contribute a discretionary fixed nonelective contribution up to 5% of the participant’s compensation. Employees could elect to defer an amount up to the annual Internal Revenue Service (IRS) deferral limits.

Participant’s Accounts - Prior to the merger, each participant’s account was credited with the participant’s contributions and School matching contributions, as well as allocations of the School’s nonelective contribution and Plan earnings. Participant’s accounts were charged with an allocation of administrative expenses that were paid by

Participant's Accounts - Continued - the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

Vesting - Participants were immediately vested in their contributions, School contributions, and actual earnings thereon.

Participant and Employer Contributions Receivable - As of October 31, 2024 and December 31, 2023, participant contributions receivable amounted to \$0 and \$11,971, respectively. Additionally, as of October 31, 2024 and December 31, 2023, employer contributions receivable amounted to \$0 and \$14,163, respectively.

Notes Receivable from Participants - Prior to the merger, participants could borrow from their pre-tax elective deferrals and rollover accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan or 50% of their vested account balance. Loans from a TIAA annuity were further limited. The loans were secured by the balance in the participant's account. A participant could have three loans outstanding at one time. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions. Loans had to be repaid within five years of the date of the loan unless the loan was used to purchase a primary residence in which case could be repaid longer than five years.

Payment of Benefits - Prior to the merger, upon termination of service due to death, disability, or retirement (age 65), a participant could elect to receive a lump-sum equal to the value of the participant's vested interest in his or her account, installment payments, annuity, or ad-hoc distributions.

Benefit payments would commence no later than April 1 following the calendar year in which the participant became 73 or the calendar year in which the participant retired. Participants could roll over distributions from the Plan directly to an eligible retirement plan specified by the participants. If the payment was to a beneficiary that is not a spouse, a direct rollover was only payable to an individual retirement account or individual retirement annuity that had been established on behalf of the beneficiary as an inherited Individual Retirement Account (IRA).

Hardship Withdrawals - Prior to the merger, participants could withdraw their account balances in the form of a hardship withdrawal to satisfy an immediate and heavy financial need, as defined by the Plan. The participant was required to first exhaust all other assets reasonably available prior to obtaining a hardship withdrawal, including obtaining a commercial loan or reasonable liquidation of assets.

Plan Termination - Before the merger, the School had the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants remain fully vested in their accrued benefits. See Note 10 about the plan merger.

Forfeited Accounts - As of October 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based upon the terms of the plan agreement.

Payment of Benefits - Benefits are recorded when paid.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The School has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurements*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of October 31, 2024 and December 31, 2023:

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

Variable Annuity Contracts - The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate investments. Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on a professional's opinion. The investment is classified as Level 2 within the fair value hierarchy.

Insurance Company General Account - Different contracts within the TIAA Traditional Annuity provide certain unique features and characteristics within the contract. The School has both TIAA Traditional Benefit-Responsive and Traditional Non-Benefit-Responsive contracts. The non-benefit-responsive contract is reported at fair value, which approximates contract value. NOTE 5: INVESTMENTS

Guaranteed Annuity Contract - The TIAA Traditional Annuity (Annuity) was a fixed rate annuity contract that was fully and unconditionally guaranteed and backed by the claims-paying ability of TIAA, a New York domiciled nonprofit legal reserve life insurance company. During the accumulation phase, the Annuity provided a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3%, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. When the contract value accumulation (plan assets) of the Annuity is converted to an annuity (plan withdrawal) based on life expectancy, the present value of the stream of payments is equal to the accumulation.

The Annuity was offered through a variety of contract types with TIAA. The type of contract through which the Plan holds the Annuity determines the applicability of certain account features, such as a guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of participant accounts, and the options for receiving income upon retirement. The Plan held both benefit-responsive and non-benefit-responsive contracts. As of October 31, 2024 and December 31, 2023, \$0 and \$1,821,293, respectively, of the Annuity consisted of non-benefit responsive contracts. These contracts are reported at fair value on the financial statements, which approximates contract value.

Benefit-responsive contracts were controlled by the investment plan. For certain benefit-responsive contracts, 90-day equity wash applies if competing funds exist (i.e., money market, TIAA Real Estate Account). As of October 31, 2024 and December 31, 2023, \$0 and \$1,349,345, respectively, of the Annuity was fully benefit-responsive. These contracts are reported at contract value on the financial statements.

These guaranteed annuity contracts are traditional investment contracts. Due to the nature of these contracts, they do not have specific underlying assets assigned.

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

Market value events may limit the ability of the Annuity Fund (Fund) to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Funds and have a financial effect on the investment contract or wrap issuer’s interest hereunder.

Such events may include, but are not limited to: fund administration amended or changed, merger or consolidation of investors, group termination or layoffs, implementation of an early retirement program, termination or partial termination of the Funds, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Funds, transfers to competing options without meeting the equity provisions of the Funds, and plan sponsor withdrawals without the appropriate notice to the Funds and/or issuer.

In the normal course of business, such events or conditions would not limit the ability of the Funds to transact at in the normal course of business, such events or conditions would not limit the ability of the Funds to transact at contract value with the participants in the Funds. The Funds are managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants, as well as the occasional market value.

The School does not believe that any events which would limit the Funds' ability to transact at contract value with participants are probable.

An issuer can terminate an investment contract upon the event of default by the contract holder, advisor, or trustee if the issuer determines in its reasonable discretion that such an event has had or is likely to have a material adverse effect on the issuer's interest with respect to the contract. Such events may include, but are not limited to, management of the portfolio not in accordance with investment guidelines, a breach of any material obligation under the agreement, any representation or warranty made by the contract holder that becomes untrue in any material way, a replacement of the advisor without prior consent of the issuer that the Funds are terminated or cease to qualify as a group trust or plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA.

CREF Accounts - The College Retirement Equities Funds (CREF) consist of eight investment portfolios including the Stock, Global Equities, Growth, Equity Index, Bond Market, Inflation-Linked Bond, Social Choice, and Money Market Accounts. In accordance with each portfolio's investment objectives, the accounts invest principally in equity securities, fixed income investments, and short-term investments.

Accumulation units in CREF accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. In an effort to reduce market timing and excessive trading, shareholders will not be permitted to make electronic transfers (i.e., transfers over the Internet, by telephone, or by fax) back into that same account through a purchase or exchange for 90 calendar days if a purchase, sale and repurchase within that account is made within a 60-day period, other than the CREF Money Market Accounts.

NOTE 5: INVESTMENTS - CONTINUED

TIAA Real Estate Account - The TIAA Real Estate Account (REA) is an insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the REA with a liquidity guarantee (i.e., TIAA Ensures that the REA has funds available to meet participant redemption, transfer, or cash withdrawal requests executed at quoted unit values). Unit values are calculated each day and are posted on the Plan's website.

NOTE 6: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The School has not considered normal plan operations such as participant and School contributions or benefits accrued or paid by the Plan for participants as parties-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies (mutual funds), pooled separate accounts, and a guaranteed annuity contract managed by TIAA, the custodian. Fees paid during the year for professional services rendered by parties in interest were partially absorbed by the School. Participant loan origination fees are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Certain plan investments are shares of annuities managed by the Plan's investment trustee; therefore, these transactions qualify as exempt party-in-interest transactions.

NOTE 7: PLAN TERMINATION

The School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the School may determine. See Note 10 regarding the plan merger.

NOTE 8: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain the Plan's tax-exempt status for plan participants. The School believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

NOTE 8: TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The School has analyzed the tax positions taken by the Plan and has concluded that as of October 31, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and the DOL, generally for the three years after it is filed.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invested in various investment products. Investments are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 10: PLAN MERGER

Effective November 1, 2024, the Plan was merged into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan.
