Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Summit Healthcare Regional Medical Center Performance Based Flexible Contribution Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

General

The following brief description of Summit Healthcare Regional Medical Center Performance Based Flexible Contribution Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan was established January 1, 1988. The Plan has been amended and restated throughout the years to comply with tax legislation, and most recently, was amended and restated November 1, 2023. The Plan is a defined contribution plan covering all eligible full-time and part-time employees of Summit Healthcare Regional Medical Center (Organization and Administrator). Employees become eligible to make contributions on their date of hire. Employees who are 18 years of age or older and have completed 12 months of service are eligible for Organization discretionary matching and discretionary profit-sharing contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each year, participants may contribute up to 100% of their pre-tax eligible compensation, as defined, to the Plan, subject to limitations prescribed by the IRS. Participants may also make after-tax contributions designating the salary deferrals as Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Organization may make discretionary matching or discretionary profit-sharing contributions each year to the Plan. During 2024, the Organization made discretionary matching contributions at 100% of participant contributions up to 2% of eligible compensation. The Organization did not make any discretionary profit-sharing contributions to the Plan during 2024. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants direct the investment of their contributions into various investment options offered by the Plan and may change the allocation daily. The Plan has investments with Variable Annuity Life Insurance Company (VALIC) and Ascensus Trust Company (Ascensus). The Plan is in the process of transitioning all investments to Ascensus, subject to restrictions per VALIC, as defined. As such, no additional contributions are permitted to be allocated to the VALIC investments. Total investments with VALIC at December 31, 2024 and 2023 were \$6,122,106 and \$6,499,500, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and Organization discretionary matching contributions, as well as allocations of (a) Organization discretionary profit-sharing contributions and (b) plan earnings. Additionally, participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vesting in the Organization's discretionary matching and profit-sharing contribution portion of their accounts is based on years of continuous service. For employer discretionary matching contributions, a participant is fully vested after three years of credited service as follows: 33% after one year, 67% after two years, and 100% after three years. For discretionary profit-sharing contributions, a participant is vested 20% after two years of credited service and vests an additional 20% each year until fully vested after six years of credited service. A participant

will become 100% vested in Organization contributions upon the attainment of age of 55 and the completion of five years of vesting service. If a participant reaches retirement age (age 65), dies, or becomes disabled, the participant becomes fully vested in Organization matching and profit-sharing contributions, irrespective of years of service.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A fee is deducted from the participant's loan proceeds for administrative costs. Loan terms are not to exceed 5 years or up to 10 years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. At December 31, 2024, the interest rates on outstanding loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Participants are allowed one outstanding loan at a time.

Plan Loans

Participants may also borrow against their fund accounts held by VALIC a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the amount of the participant's vested account held by VALIC. These loans are not funded with plan assets. However, plan loans issued by VALIC are secured by the balance in the participants' accounts and bear interest at rates ranging from 5.00% to 7.50%, with maturities through July 2025 as of December 31, 2024. Principal and interest are paid directly to VALIC. The participant's collateral is equal to the sum of the original principal of the loan requested plus the first quarter interest due and potential surrender charges. Collateral amounts are transferred into collateral fixed accounts. Outstanding plan loans issued by VALIC totaled approximately \$228,700 and \$263,800, all of which are in default at December 31, 2024. The collateral for the loans issued totaled approximately \$548,600 and \$579,400 at December 31, 2024 and 2023, respectively. Participants are allowed one outstanding loan at a time.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest of their account. Under the terms of the Plan, lump-sum distributions or installment-type distributions, as defined, will be made from the Plan upon a participant's termination, disability, retirement, or death. The Plan also allows for in-service distributions from the Plan during employment for financial hardship, as defined by the Plan. The Plan generally requires lump-sum distributions of account balances of less than \$5,000 upon termination.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$23,400 and \$2,600, respectively. These accounts may be used to reduce future Organization contributions or to pay administrative expenses, which would otherwise be paid by the Plan. During the year ended December 31, 2024, approximately \$21,000 and \$54,300 of forfeited nonvested accounts was used to reduce Organization contributions and pay administrative fees, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by investment advisers and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Expenses relating to specific participant transactions (*i.e.*, loan setup, distribution request, etc.) may be charged directly against the appropriate participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3. Certification of Plan Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance and VALIC, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Plan investments are shares of mutual funds, units of pooled separate accounts, and guaranteed investment contracts (GIC) held by Reliance and VALIC, the custodians. These investments and transactions in these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. As described in Note 2, expenses for benefits paid to participants and participant loan services are charged directly to the participant's account. Additionally, the Plan uses other service providers for professional services, and transactions with these other service providers qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Mutual Funds

Investments in mutual funds are based on quoted market prices for the identical security in an active market.

Pooled Separate Accounts

Pooled separate accounts are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, and mutual funds. Units held in pooled separate accounts are valued based on the market prices of similar assets in active markets.

Note 6. Investment Contracts With Insurance Companies

The Standard Stable Asset Fund – II (Standard Insurance Company), Fixed Account Plus (VALIC), and Short-Term Fixed Account (VALIC) are fully benefit-responsive investment contracts, which maintain contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuers are contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The GICs are fully benefit-responsive, therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GICs. Contract values, as reported to the Plan by Reliance and VALIC, represent contributions made under the contracts, plus interest at the contract rates, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The GICs do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer’s contributions.

Note 8. Income Tax Status

The Plan operates under a prototype 403(b) volume submitter employer plan document sponsored by Ascensus, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Delinquent Participant Contributions

During the years ended December 31, 2024, 2023, and 2022, the plan administrator was late remitting certain voluntary contributions within the period prescribed by the Department of Labor regulations. These late remittances totaled \$1,115,817, \$1,224,143, and \$318,456 for the years ended December 31, 2024, 2023, and 2022, respectively. The plan administrator is in the process of calculating lost earnings relating to the 2024, 2023, and 2022 late deferrals.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the accompanying statements of net assets available for benefits.
