### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Moody Bible Institute Match Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF PLAN:

The following description of the Moody Bible Institute Match Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### GENERAL

The Plan was established on January 1, 2006, and is sponsored by the Moody Bible Institute (the Institute). The Plan is a defined contribution retirement savings plan to provide matching contributions and discretionary profit-sharing contributions on behalf of eligible employees of the Institute. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The employee benefits audit committee (EBAC) and employee benefits investment committee (EBIC) are responsible for oversight of the Plan, determine the Plan's investment offerings, and monitor investment performance with assistance from a contracted third party.

#### ELIGIBILITY

Certain Institute employees, as defined in the Plan provisions, who are at least 21 years of age and have completed one year of service, which includes at least 1,000 hours of service during the year, are eligible to participate in the Plan. Entry dates are each January 1 or July 1 following the completion of the age and service requirements. Institute employees who are part of the following groups of employees are ineligible for participation: (1) members of a union unless their bargaining agreement requires participation, (2) employees who are associated with a religious order and have taken a vow of poverty, and (3) students exempt from Federal Insurance Contributions Act ("FICA") withholding.

#### CONTRIBUTIONS

Employees do not make deferral contributions to the Plan but are allowed to make deferral contributions to a separate plan, the Moody Bible Institute Retirement Plan (Retirement Plan), a 403(b) plan. Employer contributions, including those related to employee contributions made to the Retirement Plan, are contributed by the Institute to this Plan. The Institute matches 100% up to 3% of a participant's compensation (Matching Contribution), as defined, each plan year.

The Institute may also make a discretionary contribution. For the year ended December 31, 2024, the Institute contributed 4% of the participant's compensation for all eligible employees except certain "grandfathered" employees who have access to retiree health benefits received a discretionary contribution equal to 3% of the compensation.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the employer's contribution and allocations of the Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. DESCRIPTION OF PLAN, continued:

#### VESTING

Participants are vested 100% in the Institute's matching and discretionary contributions after three years of service.

#### PAYMENT OF BENEFITS

Participants have the option to receive payments as lump-sums, installments, or purchases of annuities for the vested balance in their account upon termination, retirement, disability, or death. Options under annuity contracts will pay equal installment amounts over an elected number of years. Upon death or disability, participants are immediately 100% vested. An immediate distribution is allowed without the consent of the participant, and if applicable, the participant's spouse, if the participant is terminated and the participant's vested interest in the Plan does not exceed \$5,000. Distributions for accounts which are 100% vested can be taken after age 59½.

#### FORFEITURES

On the date a terminated participant receives or is deemed to receive a distribution, the portion of the participant's matching account that was not fully vested becomes a forfeiture. Forfeitures are used to reduce any future employer contributions. The balance of forfeitures available to offset future employer contributions as of December 31, 2024 and 2023, was \$29,399 and \$14,313, respectively. \$287 of forfeitures were used in the year ended December 31, 2024, to reduce employer contributions.

### 2. SIGNIFICANT ACCOUNTING POLICIES:

#### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. SIGNIFICANT ACCOUNTING POLICIES, continued:

#### INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments, other than the fully benefit responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount plan participants generally receive when executing transactions under the terms of the contract and plan provisions. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### PAYMENT OF BENEFITS

Benefits are recorded when paid.

#### EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### 3. INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VALIC Trust Company, Inc. and Variable Annuity Life Insurance Company, the qualified institutions.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The carrying value of interest-bearing cash approximates fair value due to its short-term nature and liquidity.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan holds traditional fully benefit-responsive investment contracts with The Variable Annuity Life Insurance Company (VALIC or Issuer) with a contract value of \$1,912,803 and \$1,694,593 as of December 31, 2024 and 2023, respectively. VALIC maintains the contributions in its general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The Issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the Issuer but may not be less than 1%. The crediting rate is set no more frequently than every 90 days with interest credited on a daily basis.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the Issuer's ability to meet its financial obligations. The Issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Institute, and certain other Institute-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Institute has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

7. TAX STATUS:

The Plan has adopted the prototype documents created by VALIC Retirement Services Company. The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, the Plan administrator believes that the Plan is currently being operated in accordance with applicable requirements of the Internal Revenue Code.

8. PARTIES-IN-INTEREST:

Certain investments for the Plan are funds managed by VALIC. VALIC is the issuer of some contracts and recordkeeper for the Plan; therefore, these transactions qualify as party-in-interest transactions.

Direct fees of \$60,953 were paid to VALIC by the Plan for the recordkeeping and investment management services for the year ended December 31, 2024. Indirect fees are included with net appreciation on investments in the statement of changes in net assets available for benefits.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through November 7, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
