Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AWP, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the AWP, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that covers all employees of AWP, Inc. (the “Company”) except ineligible classes as defined by the Plan document. Employees are eligible to participate in the Plan after ninety days of service and upon attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan Administrator is responsible for oversight of the Plan, determining appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Contributions

Newly eligible participants who fail to provide the Company with a salary reduction agreement are automatically enrolled in the Plan at a pre-tax deferral contribution rate equal to 3% of compensation. Participants may elect to contribute up to 100% of eligible compensation to the Plan on a pre-tax or Roth basis, plus catch-up contributions as defined in the Plan document. Total annual contributions made to the plan on behalf of participants are subject to limitations imposed under the Internal Revenue Code (IRC). The Company, at its sole discretion, may make discretionary matching contributions, discretionary profit-sharing contributions, discretionary Qualified Non-Elective Contributions (QNEC), and discretionary safe harbor contributions. The Company made discretionary contributions for the year ended December 31, 2024 in the amount of \$1,316,036. Employees may roll over eligible amounts from other qualified plans to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions described above (if any), and Plan earnings thereon; and charged with an allocation of administrative expenses based on the participants’ account balances.

Allocation of discretionary matching contributions and discretionary safe harbor contributions are based on the participants’ deferrals, and discretionary profit-sharing contributions and discretionary QNEC are based on the participants’ compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants are also immediately vested in discretionary QNEC contributions, discretionary safe harbor contributions, and earnings thereon. Vesting in all other employer contributions is based on years of continuous service according to the following schedule:

Forfeitures

Forfeitures may be used to reduce administrative expenses, employer contributions, or are allocated to participants based on compensation. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,772 and \$4,773, respectively. Administrative expenses were reduced by forfeitures of \$215,350 for the year ended December 31, 2024. Employer contributions were reduced by forfeitures of \$30,203 for the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 10.50% as of December 31, 2024, and 4.25% to 9.50% as of December 31, 2023; which are commensurate with local prevailing rates. Principal and interest is paid over a period not to exceed 60 months unless it is for a primary residence loan. The employee repays the loan and all related interest through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants or their beneficiaries can elect to receive a distribution of his or her vested account in the form of installment payments, a lump sum payment, or an annuity. However, if the vested account balance is less than \$5,000, a lump sum distribution will be made to the participant regardless of whether the participant elects to receive it. In-service distributions of vested balances are permitted if the participant is 100% vested. Upon proven financial hardship, participants may elect to withdraw an amount equal to the cumulative value of their elective contributions.

Investment Options

Upon enrollment in the Plan, participants may direct contributions to their accounts into various investment options offered by the Plan.

Administrative Expenses

Administrative expenses of the Plan may be paid out of the Plan assets to the extent not paid by the Company. Expenses paid by the Company are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

In preparing the Plan's financial statements, the Plan Administrator is required to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities and the reported increases and reductions of Plan assets during the reporting period. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measurement attributable to that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in the Putnam Stable Value Fund, the Principal Stable Value Fixed Income Fund, the State Street Emerging Markets Index Fund, and the State Street US Bond Index Securities Fund. These funds meet the fully benefit responsive investment contract criteria and therefore are reported at contract value. Contract value, as reported to the Plan by the Trustees represents deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

The Plan allows loans in accordance with the Plan document. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document. In management's opinion, all notes receivable are fully collectible; accordingly, no allowance for credit losses was recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated events through November 6, 2025, the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in inactive markets. Level 2 inputs include those other than quoted prices that are observable for the asset or liability and that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) - Valued at the closing price reported on an active market on which the individual securities are traded.

Pooled separate accounts - The fair value of the underlying assets are used to determine the net asset value (NAV) of the funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. All of the Plan's investments are in accordance with Subtopic 820-10. Investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan is invested in the Putnam Stable Value Fund, the Principal Stable Value Fixed Income Fund, the State Street Emerging Markets Index Fund, and the State Street US Bond Index Securities Fund, which are fully benefit-responsive investment contracts. There are no events that could limit the ability of the Plan to transact at contract value. There are not any events that could allow the issuers to terminate the contracts and which require the Plan to settle at an amount different than contract value.

NOTE 6 – TAX STATUS

Effective May 1, 2022, the Plan adopted the Principal Life Insurance Company non-standardized pre-approved profit-sharing plan with cash or deferral arrangement (“Pre-Approved Plan”). The IRS has determined and informed Principal Life Insurance Company, by letter dated June 30, 2020, that the Pre-Approved Plan is qualified and is tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving this determination letter. However, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status and believe that the Plan is designed and currently operating in compliance with the applicable requirements of the IRC

Under the Income Taxes Topic of the FASB ASC, the Plan Administrator is required to identify potential uncertain tax positions taken, assess and quantify those positions and record reserves. As of December 31, 2024 and 2023, the Plan Administrator has identified no uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and related Principal entities and therefore, these transactions qualify as party-in-interest transactions. The Plan also makes loans to Plan participants who are also considered to be parties-in-interest.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024 and 2023, the Company failed to timely remit employee contributions and loan repayments to the Plan in the amounts of \$142,344 and \$298,100, respectively. These failures to remit contributions timely are considered a prohibited transaction according to the provisions of ERISA and the IRC.

NOTE 10 – TRANSFERS

Effective January 11, 2024, the MOT 401(k) Plan and Arrive Alive Traffic Control 401(k) Plan merged into the Plan. As a result, \$1,066,124 of assets were transferred into the Plan.

NOTE 11 – SUBSEQUENT EVENTS

In January 2025, Site Barricades, Integrity Traffic and WS Barricade merged into the Plan. As a result, approximately \$10,741,717 of assets were transferred into the Plan.

NOTE 12 – AMENDMENT OF FINANCIAL STATEMENTS

The financial statements for the year ended December 31, 2024, were originally issued on October 13, 2025. These financial statements have been amended to add a footnote reconciling the financial statements to the Form 5500 for the same period. Except for the addition of Footnote 13, no other changes have been made to the financial statements.
