Members of the Board:

### **Opinion**

We have audited the accompanying financial statements of Office and Professional Employees International Union Locals 30 and 537 Health and Welfare Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of January 31, 2025 and 2024, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are

presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Office and Professional Employees International Union Locals 30 and 537 Health and Welfare Fund (the "Plan") is a multiemployer welfare benefit plan providing medical, dental, prescription drug, life, accidental death and dismemberment and vision benefits as detailed in the summary plan description for eligible participants and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The Plan's financial statements have been prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

**C. Contributions**

Employer contributions are reported on the accrual basis. Employer contributions are contributions made by employers on behalf of employees at a fixed monthly rate for the hours worked during the year. Employer contributions receivable is based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

Participants may choose to pay \$150 per month for eligible dependent medical and dental coverage.

COBRA contributions, which vary according to the levels of participation elected and dependent status are accounted for and reported in accordance with the rules of the Plan.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records, under a separate employer compliance program.

**E. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Investments**

GAAP establishes a fair value hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are based on quoted prices for identical instruments in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds that are actively traded on a national exchange.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the current (market) value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the residual unrealized (depreciation) of investments results in differences in reporting on the financial statements and Form 5500.

**G. Concentration of Employer Contributions**

The January 31, 2025 employer contributions receivable includes \$271,198 from eight significant employers. Employer contributions from these eight employers totaled \$3,449,110 or 53% of total employer contributions for the year ended January 31, 2025. The January 31, 2024 employer contributions receivable includes \$234,538 from six significant employers. Employer contribution from these six employers totaled \$3,719,642 or 51% of total employer contributions for the year ended January 31, 2024.

**H. Risks and Uncertainties**

Plan investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the financial statements.

**NOTE 3 - ADMINISTRATION FEES**

Benefit Programs Administration (BPA) provides monthly administrative services for a flat monthly fee of \$35,334 through May 31, 2023, \$36,394 through May 31, 2024, and \$37,486 effective June 1, 2024.

**NOTE 4 - STOP-LOSS INSURANCE REIMBURSEMENTS**

The Plan purchased stop-loss insurance on behalf of the participants covered under the self-insured health plan in order to limit its exposure, which will reimburse the Plan for total individual and aggregate claims exceeding certain limits.

**NOTE 5 - BENEFITS AND BENEFIT OBLIGATIONS**

Benefits reported on the statements of changes in net assets available for benefits are segregated by premiums for eligible participants paid during the year, and benefit claims for participant services paid during the year under the self-insured medical, dental, vision and prescription plans, net of rebates (Claims - Net).

Benefit obligations are segregated on the statements of benefit obligations based on estimates at the end of the year of premiums for coverage during the year unpaid (Premiums Payable); claims incurred during the year, reported but unpaid (Claims Payable); claims incurred during the year but not reported nor paid (Claims Incurred But Not Reported - IBNR) and the future benefits costs to be incurred based on participants' accumulated eligibility credits (Earned Benefit Liability). The statements of changes in benefit obligations reports the components of the changes in benefit obligations. The IBNR and accumulated eligibility credits were estimated by the Plan's consultant based on the claims experience.

Postretirement benefits are provided to eligible retirees. The full cost of the retiree coverage is paid by the retiree. Because all future retiree benefit costs will be fully funded by future retiree contributions, the Plan has no postretirement benefit obligations.

**NOTE 6 - PLAN TERMINATION**

The Plan shall continue until all the collective bargaining agreements providing for contributions to the Plan have expired and negotiations for extension thereof have ceased. The Plan and trust agreement may be terminated at an earlier date by written agreement of all of the employers and the Union Locals, subject to all of the requirements and procedures for plan termination provided by ERISA, and all regulations issued pursuant to such public law.

In the event the obligations of all the employers to make contributions to the Plan shall terminate or the Plan otherwise terminates, the Trustees shall determine the disposition of any assets in the Plan remaining after all expenses of the Plan have been paid; provided that any such distribution shall be made only for the benefit of former participants and for the purpose set forth in the Plan. Upon termination of the Plan, the Trustees shall continue in such capacity for the purpose of dissolution of the Plan with full powers as herein provided and may execute any and all instruments which may be required.

**NOTE 8 - CONCENTRATION OF CREDIT RISK**

As of January 31, 2025, the Plan maintained bank accounts with Union Bank in excess of the Federal Deposit Insurance Corporation ("FDIC") insurance limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 9 - RELATED-PARTY TRANSACTIONS**

The Plan's third-party administrator, BPA, is a contributing employer to the Plan. During the years ended January 31, 2025 and 2024, BPA contributed \$582,400 and \$541,350, respectively. Contributions receivable from BPA totaled \$51,800 and \$47,600 as of January 31, 2025 and 2024, respectively.

The Plan's medical service provider, Kaiser, is a contributing employer to the Plan. During the years ended January 31, 2025 and 2024, Kaiser contributed \$517,244 and \$497,047, respectively. Contributions receivable from Kaiser totaled \$43,948 and \$43,888 as of January 31, 2025 and 2024, respectively.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.



