**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of JobNimbus 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Notes to Financial Statements**

### **Note 1 – Description of Plan**

The following description of the JobNimbus, LLC (the Sponsor) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on January 1, 2020, by JobNimbus, LLC (the Sponsor) and was most recently amended on October 14, 2022 to exclude commissions from eligible compensation. The Plan is a defined contribution plan covering full-time employees of the Sponsor who have completed 60 days of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

#### **Participant Contributions**

Effective April 1, 2022, eligible participants are automatically enrolled in the Plan. The Company will deduct 2% of their eligible compensation, as defined in the Plan, unless the participant elects otherwise. Participants in the Plan may elect to contribute a percentage of their annual compensation, subject to Internal Revenue Code (IRC) annual limits. In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution up to \$7,500 for the year ended December 31, 2024. Roth contributions are permitted by the Plan and may be subject to certain IRC limitations. Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

#### **Employer Contributions**

The Company may elect to make a discretionary matching contribution to the Plan as a percentage match of the participant's compensation. The Company's discretionary match during 2024 was 100% of the amount of the participant's elective deferrals that do not exceed 2% of the participant's compensation. For the year ended December 31, 2024, the employer match totaled \$455,539. The Company made no profit-sharing contributions during the year ended December 31, 2024.

#### **Participant Accounts**

Individual accounts are maintained for each participant and each account is credited and/or reduced with the participant's elective contributions, rollover contributions, and an allocation of the Company's discretionary contributions and Plan earnings (losses) including realized and unrealized gains and losses on investments, distributions, and administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Participants are immediately vested in all contributions.

#### **Payment of Benefits**

On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59½, or in certain hardship situations. A participant may elect to receive a lump-sum payment or may roll over the value of their account into another qualified plan. In the event a participant

terminates and the participant's vested account balance is less than \$5,000, the balance will automatically be rolled into an IRA, unless otherwise directed.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding from the Plan at a time. Loan terms range from one to five years, unless for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 7.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through semi-monthly payroll deductions.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### **Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefit payments are recorded when paid by the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Management of the Plan estimates that these notes are fully collectible and therefore has no reserve for expected credit losses.

## **Notes to Financial Statements**

### **Concentrations of Credit Risk**

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities. Marketable securities are subject to daily changes in market valuations. The Plan believes it is not exposed to any significant credit risk on cash and cash funds.

### **Subsequent Events**

Management of the Plan has evaluated subsequent events through September 23, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

### **Note 3 – Fair Value Measurements**

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures (ASC 820) which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Mutual Funds** - These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

**Fixed Annuities** - The reported value for fixed annuity options is reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. These are classified within Level 2.

### Note 4 – Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement, LLC (the trustee of the Plan).

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 6 – Income Tax Status

The Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Services (IRS) dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has evaluated its tax positions and has determined that it has no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## **JobNimbus 401(k) Plan Notes to Financial Statements**

### **Note 7 – Risks and Uncertainties**

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8 – Party in Interest Transactions**

Certain Plan assets at December 31, 2024, are invested in funds sponsored by the Trustee. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL Regulations. Certain administrative expenses are paid to the Trustee and Prior Trustee of the Plan and also qualify as party-in-interest transactions for which a statutory exemption exists. These administrative expenses amounted to \$76,780 and \$23,729 for the year ended December 31, 2024 and 2023. Notes receivable from participants also qualify as party-in-interest transactions.

### **Note 9 – Voluntary Correction Program**

Subsequent to December 31, 2022, the Plan Sponsor determined that certain compensation that meets the Plan's definition of eligible compensation was not being properly included as part of the eligible compensation base for determining participant and employer contributions. The Plan Sponsor is taking remedial actions under the IRS's Voluntary Correction Program (VCP) to correct the matter through a missed deferral opportunity. The Plan Sponsor submitted its VCP request to the IRS in January 2024, and as of the date of this report, the Plan Sponsor has not received a response.
