## FUNDING ASSUMPTIONS

Actuarial assumptions are estimates of the occurrence of future events affecting the costs of the plan such as mortality rates, changes in compensation levels, retirement ages, rates of investment earnings, expenses, etc. The assumptions have been chosen to anticipate the long-range experience of the plan. The enrolled actuary will certify to the reasonableness of these assumptions, as required by ERISA.

## PLAN PROVISIONS

The actuarial valuation was prepared in accordance with the provisions of the plan, a summary of which is presented below. The summary describes the principal provisions only and is not intended to be authoritative. For questions about specific benefits, please refer to the plan document. This summary of plan provisions is intended to only describe the essential features of the plan.

### Basic Information

**Plan Name:** Proctor Home Pension Plan

#### Effective Date

November 1, 1976

**Participation:** Each Employee is eligible to become a Participant as of the first day of the Plan Year coincident with or next following: six months of service, 1,000 hours of service, and attains age 20-1/2. Participation in the plan was closed as of April 1, 2018.

**Average Monthly Compensation:** Highest 60 consecutive months of compensation out of the last 120 months.

**Year of Service:** Plan Year during which an Employee is credited with at least one thousand (1,000) Hours of Service.

#### Normal Retirement

**Normal Retirement Date:** Age 65 with 1 years of service.

**Normal Retirement Benefit:** 1% of Average Monthly Compensation in excess of \$750, times Years of Service (maximum 30 years). Accrued benefit is determined based on a fractional rule, where the benefit based on potential service at normal retirement is multiplied by a fraction equal to actual service divided by potential service. Benefit accruals are frozen effective June 6, 2018.

#### Death Before Retirement

**Eligibility:** Participant with 3 years of service

**Death Benefit:** Beneficiary receives a pre-retirement survivor annuity that is Actuarially Equivalent to the participant's vested accrued benefit.

#### Termination Benefit

**Eligibility:** 7-year graded vesting [20% at 3; 40% at 4; 60% at 5; 80% at 6; 100% at 7].

**Termination Benefit:** Vested Accrued Retirement Benefit payable at Participant's Normal Retirement Date.

#### Forms of Payment

**Normal Forms:** Life Annuity

**Optional Forms:** Lump Sum; Single Life Annuity; 10-Year Certain and Life Annuity; 50%, 75%, and 100% Joint and Survivor Annuity
