INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of
Nexient 401(K) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nexient 401(K) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and December 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nexient 401(K) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Nexient 401(K) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Nexient 401(K) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Plan Merger

As further discussed in Note 1, this Plan merged into NTT Data Americas 401(K) Plan and the plan assets were transferred in accordance with the provisions of ERISA.

NOTE 1 – PLAN DESCRIPTION

The following brief description of Nexient 401(K) Savings Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

Plan Merger:

The Plan Sponsor approved the merger of the Nexient 401(K) Savings Plan (“The Plan”) into the NTT Data Americas 401(K) Plan as of the end of the year December 31, 2022. As a result of this merger, the Plan's total assets of approximately \$26million, was transferred from the Plan to the NTT Data Americas 401(K) Plan. The following provisions described in the description of the Plan were in effect prior to the Plan merging out of existence, except where noted below.

General:

The Nexient 401(K) Savings Plan was established by Nexient LLC (“The Company”) under the provisions of Section 401(K) of the Internal Revenue Code. The Plan is a defined contribution plan for eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan administrator manages the operation and administration of the Plan. The Company has contracted with Reliance Trust Company (Reliance) to act as the trustee, and a third-party administrator to process and maintain the records of the participant data. The Company is the Plan sponsor and serves as the plan administrator.

Eligibility:

Employees become eligible to participate for the purpose of salary deferral once they have attained the age of twenty-one years and upon the completion of three months of service. Employees may enroll in the Plan on the first day of the month coinciding with or next following the date eligibility requirements are satisfied. Employees excluded from the Plan are certain nonresident aliens who have no earned income from sources within the United States.

Participant contributions:

Each Participant may make either Pre-Tax Elective Deferrals or Roth Elective Deferrals under the Plan. Each year, participants may elect to contribute any combination of Pre-Tax Deferrals or Roth Elective Deferrals up to 90% of their eligible earnings. However, total deferral for any employee in any tax year cannot exceed the maximum statutory limits imposed by the Internal Revenue Service (IRS) and the Plan terms. The limit is set as \$20,500 for the year 2022. In addition, participants age 50 or older before the end of the Plan year, are able to make catch-up contributions. The Catch-up dollar limit is \$6,500 for the year 2022. Contributions withheld are invested in accordance with the participant's direction.

Rollover

Employees may roll over eligible amounts from other qualified retirement plans to the Plan.

Employer contributions:

The Plan allows for a discretionary employer matching contribution. The Company will match 50% of the salary deferrals up to the first 4% of the eligible compensation.

Vesting:

Participants are immediately vested in their elective deferrals, rollover contributions (if any) and earnings thereon. Participants are fully vested in the employer's matching contributions allocated to their account after three years of credited service. The vesting schedule for matching contribution is as follow:

<u>Years of Service</u>	<u>Percentage</u>
Year 1	25%
Year 2	50%
Year 3	100%

Investment:

The Plan provides for investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct contributions in any of the investment options and may change their investment options at any time.

Individual participant account:

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching contributions and Plan earnings. Further, the participant's account is charged with withdrawals and allocations of Plan losses and administrative expenses. Allocations were based upon the participant's earnings as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Certain investment and fund fees are charged to the funds and are included in plan investment income and losses and charged to participant accounts. Participants should refer to the funds' prospectuses for further information on these fees.

Forfeitures:

Forfeitures are the non-vested portion of participants' account that are lost upon termination of employment. Forfeitures may be used to pay plan administrative expenses or reduce future employer contributions. Forfeited account balance of \$10,790 were transferred out of the Plan as of December 31, 2022. As of December 31, 2021, the forfeiture account balance was \$128,037. Forfeited accounts of

\$213,520 and \$111,656 were used to offset the employer contributions for the year ended December 31, 2022 and 2021 respectively.

Payment of benefits:

Upon termination of service due to death, disability, retirement or any other reason, a participant with account balance of \$5,000 or greater may elect to receive distribution of the vested account balance in either a single lump sum payment, or direct rollover, may choose to receive installments, request a partial withdrawal. Terminated participants whose account balance is less than \$5,000, then the Plan will rollover the distribution to an IRA if participant do not make an affirmative election to either receive or roll over the distribution.

Notes receivable from participants:

The Plan allows participants to borrow not less than \$500 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant's vested balance. Such notes bear interest and must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence in which case Plan Administrator may allow a longer repayment period. A participant has to repay any outstanding note before a new note can be made. The specific terms and conditions of such notes are established by the Plan Administrator. The notes receivable from participants carry an interest rate of prime rate plus 1%.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The participant notes are valued at their outstanding balances, which approximates fair value.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes Plan's gain and losses on investments bought or sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as deemed distributions based upon the terms of the plan document.

Administrative expenses:

In 2022 and 2021, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees and participant transaction fees were charged to participant accounts as applicable.

NOTE 3 – INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated October 6, 2020 from the IRS stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The Plan has been amended since, however the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 – FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Registered investment companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Valued at net asset value (NAV) per unit on valuation date, as the practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 6: RISK AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities, including a group annuity contract, registered investment companies and pooled separate accounts. Investment securities are exposed to various risks such as interest rate, overall market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 – RELATED PARTY TRANSACTIONS

The Plan's investments in the shares of registered investment companies are managed by Reliance Trust Company. Reliance Trust Company is the Trustee as defined by the Plan and therefore, these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan issues notes to participants, which are secured by the balances in the participant's account. These transactions also qualify as party-in-interest transactions.

NOTE 8: EXCESS CONTRIBUTIONS PAYABLE

The Plan is required to return contributions to participants in the event certain non-discrimination tests defined under the Internal Revenue Code are not satisfied. Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability. As of December 31, 2021 excess contribution payable was recorded amounting to \$386.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 16, 2023, which is the date the financial statements were available to be issued.
