INDEPENDENT AUDITORS' REPORT

To The Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Damascus Bakery OPCO, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following description of the Damascus Bakery OPCO, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General - The Plan became effective on January 1, 2013, as a defined contribution plan sponsored by Damascus Bakery OPCO, LLC (the “Company” or the “Plan Sponsor”). The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Reliance Trust Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

Eligibility - Employees of the Company are eligible to participate in the Plan, after attaining age twenty-one or older and completing one year of service. Nonresident aliens and employees of Puerto Rico are not eligible to participate in the Plan. Enrollment in the Plan occurs on the first day of the month coinciding with or next following the date in which employee satisfies the eligibility requirements.

Contributions - Eligible employees may elect to contribute voluntarily through payroll deductions, subject to certain limitations. In 2024, eligible employees may elect to contribute up to 85% of their salary to a maximum of \$23,000 and employees over the age of 50 can elect to contribute an additional \$7,500. Participants may make elections to invest their account balances and contributions made during the year among various types of investment accounts.

Effective January 1, 2016, the Company elected to make a safe harbor matching contribution based on the active participant’s annual contributions. The Company matches 100% of the first 4% of the participant’s compensation which is deferred as an elective deferral. The Company made safe harbor matching contributions to the Plan for the year ended December 31, 2024 totaling \$359,783, which is net of forfeitures applied of \$3,435. The Company may also make a discretionary non-elective contribution to eligible participants. There were no non-elective contributions for the year ended December 31, 2024.

Participant Accounts - Each participant’s account is credited/charged with the participant’s contribution, employer’s safe harbor matching and discretionary non-elective contribution, if any, and an allocation of (i) Plan earnings/(losses) and (ii) administrative expenses. Allocations are based on participant earnings and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the employer discretionary non-elective contributions is based on continuous service. The participant vests 20% in the employer matching contributions starting in year one and is fully vested after five years of service.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be applied to reduce the employer’s matching contributions and to pay plan expenses. There were \$30 and \$32 of unallocated forfeitures as of December 31, 2024 and 2023, respectively. In 2024, forfeitures totaling \$3,435 were used to reduce employer matching contributions.

Payment of Benefits - On termination of service, the Plan provides for a participant to have the option to receive all or any portion of eligible rollover distribution either (i) paid directly to the participant or (ii) paid in a direct rollover to an individual retirement account or another employer plan. Amounts are not distributable except by reason of retirement, death, disability and separation from service, hardship or the attainment of age 59 1/2.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping and administrative services, the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Fees related to investment advisory services are allocated to participants pro-rata based on participant balances and are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payments of Benefits - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

Risks and Uncertainties - Investment funds, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may have investments in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Concentration of Investment Risk - The Plan's investment in two funds comprises approximately 44% of total investments as of both December 31, 2024 and 2023.

Subsequent Events - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through September 18, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c) Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures FASB ASC 820, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers out of Level 1, 2 or 3.

Note 5 - Party-in-Interest:

Certain Plan investment transactions are recorded by Automatic Data Processing, Inc. (“ADP”). ADP provides recordkeeping and administrative services to the Plan and the Trustee provides other services to the Plan, therefore, these transactions qualify as party-in-interest. Expenses incurred by the Plan for recordkeeping and administration totaled \$17,738 for the year ended December 31, 2024.

The Plan also utilizes the services of a third-party investment advisor. Fees paid by the Plan to the investment advisor for investment advisory services totaled \$36,987 for the year ended December 31, 2024.

Note 6 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants’ contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan’s assets as a result of such termination.

Note 7 - Tax Status:

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on October 6, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8 - Notes Receivable from Participants:

Participants may borrow up to the lesser of \$50,000 or 50% of their respective vested account balances. The loans are secured by the balance in the participants' account and bear interest at the prevailing prime rate plus 2% on the origination date of the loan and are generally repayable through payroll deductions within five years, unless the loan provides funding for the purchase of the participant's principal residence in which case it is payable over twenty years.
