Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sunless, Inc 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Sunless, Inc 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with a 401(k) feature covering all eligible employees of Sunless Inc. (the Company, Plan Administrator and Plan Sponsor). Employees who have attained the age of 21 are eligible to participate in the Plan after completing one month of eligibility service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may elect to defer up to 90% of their compensation as defined by the Plan on either a pretax or after-tax basis. The Company provides a safe harbor matching contribution of 100% of participants' elective deferral contributions up to 3% of compensation, plus 50% of their elective deferral contributions from 3% up to 5% of compensation. The Plan also provides for discretionary employer matching and profit sharing contributions. Participants must complete 500 hours of service during the plan year and be employed on the last day of the plan year to receive a profit-sharing contribution. There were no discretionary employer contributions made during 2024. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the plan year. Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, compensation, specific participant transactions or account balances, as defined in the Plan document. The benefit which a participant is entitled to receive is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their deferral contributions, rollovers and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, as defined in the Plan document, after one year at a rate of 20% per year. Participants are 100% vested after six years of credited service.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participants' highest outstanding notes receivable balances during the previous 12 months or 50% of their vested account balances. Notes receivable terms are up to five years, or longer for the purchase of a primary residence and are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Note 1. Description of Plan (Continued)

Payment of benefits: Participants or their beneficiaries are eligible to receive benefits upon reaching age 59½, termination, retirement, disability or upon the death of a participant. A participant may elect to receive a distribution in the form of a lump sum equal to the value of his or her vested account, partial withdrawals or installments over a period of time as defined in the Plan document. If the value of the vested benefits credited to a participant's account is \$1,000 or less at the time of termination, the entire amount will be automatically distributed to the participant without the participant's consent. If the value of the vested benefits credited to a participant's account is greater than \$1,000 but not exceeding \$5,000, the participant may elect to receive a lump-sum distribution directly or receive the distribution in the form of a direct rollover to another qualified plan. If the participant does not elect a form of distribution, the entire amount will be distributed, without the participant's consent, in the form of a direct rollover to an individual retirement account as designated by the Plan Administrator.

Forfeited accounts: Forfeitures may be used to reduce the Company's discretionary matching and profit-sharing contributions to the Plan or used to reduce administrative expenses of the Plan. At December 31, 2024 and 2023, unallocated forfeited accounts and forfeitures applied to Plan expenses during the year ended December 31, 2024, were not material to the financial statements.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their total participant account balances.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment valuation: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Reliance Trust Company, the trustee of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make payments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable is reclassified to benefits paid to participants based upon the terms of the Plan document. The interest rates on notes receivable from participants were 4.25% to 9.50% as of December 31, 2024 and 2023.

Contributions: Participant and employer contributions are recorded in the year in which the participant contributions are withheld from compensation. Any contributions attributable to the plan year but not received by the trust by the last day of the plan year are recorded as a receivable.

Note 2. Summary of Significant Accounting Policies (Continued)

Income taxes: The Company adopted a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC. The plan sponsored by ADP, LLC received an opinion letter from the IRS dated October 6, 2020, stating that the plan and related trust were designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 12, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, ADP Retirement Trust Services, LLC was appointed as the trustee of the Plan. Effective July 1, 2025, the Plan's name was changed to Innove, Inc 401(k) Profit Sharing Plan and Trust.

Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Money market account: Valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain fair value instruments could result in a different fair value measurement at the reporting date.

Note 5. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, two funds made up approximately 33.7% of the Plan's total investments (both individually greater than 10%). At December 31, 2023, two funds made up approximately 31% of the Plan's total investments (both individually greater than 10%). This is considered a concentration of credit risk.
