**Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of North Texas Health Care Laundry Cooperative Association 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of North Texas Health Care Laundry Cooperative Association 401(k) Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

**NOTES TO FINANCIAL STATEMENTS**

**1. Description of Plan**

The following description of the North Texas Health Care Laundry Cooperative Association 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers employees of North Texas Health Care Laundry Cooperative Association, referred to as the “Employer”. The recordkeeper and insurance company of the Plan is Brighthouse Life Insurance Company. The Plan was originally established and effective on September 1, 1995.

Eligibility – Employees are eligible for participation in the Plan on the next available pay period for employee contributions to be made after enrollment in the Plan. Employees are eligible for matching contributions after completing one year of service and attainment of age 18 years.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute up to 100% of their pre-tax annual compensation, as defined by the Plan. The Employer matches 50% of the participant's pre-tax contributions, up to 6% of compensation, as defined in the Plan. Participant and Employer contributions are subject to limitations prescribed under Section 415 of the Internal Revenue Code.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts were \$23,004 and \$19,595, respectively. For the year ended December 31, 2024 and 2023, no forfeitures were used to reduce Company contributions or pay plan expenses. During 2024 and 2023, \$0 and \$0, respectively, in forfeitures were paid back to the Employer.

Participant Accounts – Each participant has two accounts, with one account designated for participant contributions and one account designated for Employer contributions. Participants' contribution accounts are credited with the participant's contributions and the earnings of the specific investment vehicles selected. Participants may self-direct their contributions to several investment vehicles, including mutual funds.

Employer contribution accounts are credited with the Employer's matching contribution and the earnings of the specific investment vehicles selected. Participants may also self-direct the Employer account to several investment vehicles.

Vesting – Participants are always fully vested in their contributions. The Employer's matching contributions vest at a rate of 20% after two years until fully vested after six years.

If a participant dies or becomes disabled, the participant's accrued benefit derived from Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% non-forfeitable.

Payment of Benefits – Upon normal retirement age or death, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested balance of the participant's account, or substantially equal installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse or beneficiary. Participants may receive distributions prior to separation of service after normal retirement age is reached. Distributions to terminated participants will be made as soon as administratively feasible and an automatic distribution will be made to those participants with a vested balance below \$5,000. Hardship and in-service distributions are allowed under the Plan. After a hardship withdrawal, the participant is not allowed to make contributions to the Plan for six months. If the participant dies prior to receiving all benefits under the Plan, the balance of the participant's account is paid to the beneficiary.

**2. Summary of Accounting Policies**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Benefits are recorded when paid.

Investments are reported at fair value other than the fully benefit-responsive investment contracts, which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

**3. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes' terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. All notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Interest rates on outstanding notes range from 3.50% to 4.65% at December 31, 2024 and 3.50% to 4.65% at December 31, 2023.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Principal and interest are paid quarterly by the participant. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant's note to be in default, the participant's note balance is reduced and a benefit payment is recorded.

**4. Administration of Plan Assets**

The Plan assets are held by the Trustees of the Plan. Employer and participant contributions are invested by the Trustees as directed by the participants. The administrative expenses associated with the third-party administrator for the Plan are paid directly by the participants. Other expenses associated with the Trustees of the Plan are paid by the Employer. Certain fees are paid by the participants' investment funds to their affiliated investment advisors, transfer agents and recordkeeper as further described in each fund prospectus, plan service agreements, or other published documents. These fees were deducted prior to allocation of the Plan's investment earnings activity.

**5. Information Prepared and Certified by Trustees**

The following information included in the accompanying financial statements and supplemental information was obtained from data that has been prepared and certified to as complete and accurate by Brighthouse Life Insurance Company and MetLife Holdings, the Trustees. **NOTES TO FINANCIAL STATEMENTS**

Financial Accounting Standards Board (FASB), *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled Separate Accounts:* The Net Asset Value (NAV) of the pooled separate accounts is used as a practical method to determine fair value for these accounts. Each pooled separate account provides for redemptions by the Plan at reported NAV per share, with no advance notice requirement; therefore, these funds are classified within Level 2 of the valuation hierarchy. Investments in this category can be transferred once every 30 days at the current NAV per share based on the fair value of its underlying investments. Participants are not allowed to transfer back into this category until the 30-day period has expired. New contributions are allowed during this time period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risk.

The Guaranteed Investment Contract has been recorded at contract value due to the fact that it was not materially different than its fair market value.

**6. Net Asset Value (NAV) Per Share**

Entities are permitted, as a practical method, to estimate the fair value of investments within its scope using the NAV per share of the investment as of the reporting entity’s measurement dates.

The Plan has expanded its disclosure to include the category, fair value, redemption frequency, and redemption notice period for those assets whose fair value is estimated using the NAV per share or its equivalent for which the fair value is not readily determinable at December 31, 2024 and 2023. For the Plan, such assets include investments in pooled separate accounts.

The following table for December 31, 2024 and 2023 sets forth a summary of the Plan’s investments with fair values that have been estimated using NAV per share:

**7. Guaranteed Investment Contract with Insurance Company**

In September 1995, the Plan entered into benefit-responsive guaranteed investment contracts with Brighthouse Life Insurance Company. Brighthouse Life Insurance Company maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Brighthouse Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The group annuity contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.5%. The crediting rate is reviewed on an annual basis for resetting.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. Amendments to the plan documents for a complete or partial plan termination or merger with another plan;
2. Termination of the contract by the Employer; or
3. Termination of the contract by the contract issuer.

No events are probably of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. A breach of material obligation under the contract; or
2. Not being in conformity with applicable law.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. Tax Status**

The Plan has adopted a Prototype Non-Standardized Profit Sharing Plan with CODA sponsored by Metropolitan Life Insurance Company. On March 31, 2014, the Internal Revenue Service (IRS) stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC) and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

The Plan adopted the “uncertain tax positions” provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not that its tax positions would be sustained upon examination by the IRS, or other State taxing authority. There were no penalties or interest recognized during the years ended December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal income tax examinations by federal taxing authorities for years before 2021.

**11. Related Party Transactions**

Certain Plan investments are shares of pooled separate accounts and Guaranteed Investment Contract that are managed by Brighthouse Life Insurance Company and MetLife Holdings. Brighthouse Life Insurance Company and MetLife Holdings are the Trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023 fees were paid by the Plan for the investment management services amounted to \$1,672 and \$1,812, respectively.

**12. Subsequent Events**

The Plan’s management has evaluated subsequent events through November 5, 2025, the date which the financial statements were available for issue.
