Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nustar Thrift Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan’s sponsor approved the termination agreement on May 2, 2024 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

Note 1. Description of the Plan

General

The NuStar Thrift Plan (Plan) is a qualified defined contribution plan covering eligible employees of NuStar Services Company LLC (NuStar Services Co), a wholly owned subsidiary of NuStar Energy L.P. (NuStar Energy) (NYSE: NS). NuStar Energy is a Delaware limited partnership primarily engaged in the transportation, terminalling, and storage of petroleum products and renewable fuels and the transportation of anhydrous ammonia. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

NuStar Services Co. (Plan Sponsor) is the Plan Sponsor and the Benefit Plans Administrative Committee (Administrative Committee), comprised of officers of NuStar Services Co., administers the Plan. The securities and investments of the Plan are held in a trust by Charles Schwab Trust Bank (Trustee), and the recordkeeper is Schwab Retirement Plan Services. The description of the Plan included in these notes to financial statements was in effect for the years ended December 31, 2024 and 2023, and provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

Unless otherwise noted, the below represents the provisions of the Plan prior to the effective date of the plan termination.

Participation

Participation in the Plan is voluntary and is open to substantially all domestic employees. Employees become eligible to participate in the Plan beginning the first pay period following their date of hire. Employees become eligible to receive employer matching contributions as soon as they begin participating in the Plan. Temporary employees are eligible to participate in the Plan only after attaining age 21 and completing one year of eligible service.

Contributions

Participants may make contributions to the Plan of not less than 1% or more than 30% (in whole percentages) of their annual eligible compensation. Participants may change their contribution percentages at any time.

Participants may elect to make: 1) before-tax contributions, 2) after-tax contributions, 3) Roth 401(k) after-tax contributions, or a combination thereof. The Internal Revenue Code of 1986, as amended (Code), establishes an annual limitation on the combined amount of individual before-tax and Roth 401(k) contributions. The limit was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively.

Participants who attained age 50 before the end of the year were eligible to make additional catch-up contributions of up to \$7,500 for the years ended December 31, 2024 and 2023. In addition, any participant may make eligible rollover contributions to the Plan.

The employer makes a matching contribution to the Plan equal to 100% of each participant's total contribution, up to 6% of their annual eligible compensation. Cash bonuses are excluded for purposes of calculating the matching contribution.

Participant Accounts

Employer contributions are credited to an employer account for each participant, and employee contributions are credited to an employee account maintained under the Plan for each participant. The employer and employee accounts for each participant are adjusted to reflect all contributions, withdrawals, income, expenses, gains, and losses attributable to these accounts.

Vesting

Participants are vested 100% in their employee account at all times. Participants vest in their employer account at the rate of 20% per year with 100% vesting after the fifth year of continuous service.

Continuous service begins the first day for which an employee is paid and terminates on the date of the employee's retirement, death, or other termination from service. If an employee's employment is terminated and the employee is subsequently reemployed within 12 months, the period between the severance from service and the date of reemployment is generally included in continuous service. If the employee is not reemployed within 12 months, the employee is deemed to have incurred a break in service. Former participants who are reemployed after a break in service are generally eligible to become participants immediately following reemployment.

The Plan provides that if an employee incurs a break in service prior to becoming vested in any part of his employer account, the employee's prior continuous service will not be disregarded for purposes of the Plan until the break in service equals or exceeds the greater of five years or prior continuous service. Upon a participant's termination of employment for other than death, total and permanent disability, or retirement, the non-vested portion of the participant's employer account is forfeited. In the event the participant is reemployed prior to incurring a break in service of five successive years, any amounts forfeited under this provision will be reinstated pending certain conditions.

Forfeitures

Forfeited non-vested accounts of terminated participants can be used to pay the Plan's administrative expenses or reduce employer contributions. Employer contributions for the years ended December 31, 2024 and 2023 were reduced by \$136,528 and \$57,474, respectively, from forfeited non-vested accounts. As of December 31, 2024 and 2023, forfeited non-vested accounts available to reduce future employer contributions or to pay plan expenses totaled \$59,086 and \$157,593, respectively.

Investment Options

Participants direct the investment of 100% of their employee and employer contributions and may transfer existing account balances into any of the funds offered. The funds offered include mutual funds, pooled separate accounts, common/collective trusts and self-directed investments.

Benefit Payments

Participants may make the following types of withdrawals of all or part of their respective accounts:

- One withdrawal during any six-month period from a participant's after-tax employee account and rollover contribution account with no suspension of future contributions;
- Upon completion of five years of participation in the Plan, one withdrawal from a participant's after-tax account, rollover contribution account and employer account, with a similar withdrawal allowed 36 months after the date of a previous withdrawal under this provision, with no suspension of future contributions;
- Upon reaching age 59½, one withdrawal during any six-month period from a participant's employee account and employer account; or
- Upon the certification of an immediate and heavy financial hardship for reasons permitted under the Plan and applicable law, one withdrawal during any six-month period from a participant's accounts in the order of priority determined by the plan administrator.

Upon a participant's death, total and permanent disability, or retirement on or after age 65, the participant or the beneficiary of a deceased participant is entitled to a distribution of the entire value of the participant's employee account and employer account regardless of whether or not the accounts are fully vested. Upon a participant's termination for any other reason, the participant is entitled to a distribution of only the value of the participant's employee account and the vested portion of the participant's employer account. Distributions resulting from any of

these occurrences may be received in a single lump-sum payment. Alternatively, a participant or beneficiary may elect to receive this distribution in the form of equal monthly installments over a period not exceeding the lesser of (i) five years or (ii) the participant's life expectancy or the joint life expectancy of the participant and the participant's designated beneficiary. In addition, if the value of a participant's vested account balance is equal to or less than \$1,000, the account balance may be distributed to the participant in a cash lump-sum distribution without the participant's consent. If the value of a participant's vested account balance exceeds \$1,000, or such higher amount as permitted by law or regulation, the distribution may be made prior to the participant attaining age 65 only with the participant's consent. When the value of a participant's vested account balance is equal to or less than \$5,000 but greater than \$1,000 and prior to the participant attaining age 65, if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution directly, the distribution will be paid in a direct rollover to an individual retirement account (as designated by the plan administrator) in the participant's name. The distribution of a vested account balance greater than \$5,000 shall not be made without the participant's consent.

Terminated participants may elect to have the Trustee hold their accounts for distribution to them at a date not later than April 1 of the calendar year after which they attain age 72. In this event, terminated participants continue to share in the income, expenses, gains and losses of the Plan until their accounts are distributed.

SECURE 2.0 Act of 2022

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates. Significant provisions related to the Plan include:

- An increase of the required minimum distribution (RMD) age from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- A reduction of the penalty for failure to take RMDs from 50% to 25% of the RMD amount that was not taken, and to 10% if the correction is made in a timely manner, beginning January 1, 2023; and
- Elimination of the requirement for Roth 401(k) owners to take RMDs from those accounts and a requirement for all catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) to be designated as Roth 401(k) contributions beginning January 1, 2024.

The Plan incorporated changes in its plan document and administration to the extent required by the SECURE 2.0 Act.

Notes Receivable From Participants

Participants may borrow from \$1,000 up to a maximum of the lesser of a) \$50,000 or b) one-half of the current value of the participant's vested account balance. The balance of the participant's employee account and vested portion of their employer account serve as security for the loan. Loans may extend from six months to five years, or 15 years for the purchase of a primary residence. The loan will carry an interest rate of 1% plus the Trustee's prime interest rate on the last business day of the month preceding the month in which the loan is approved. As of December 31, 2023, interest rates on outstanding participant loans generally range from 4.25% to 9.50% and maturity dates range from 2025 to 2038. Loan repayments are made through payroll deductions or lump-sum payments. A participant can have two loans outstanding at any time. As of December 31, 2024, there are no outstanding loans.

Plan Expenses

Administrative expenses of the Plan are paid either by the Sponsor or, at the Sponsor's option, by the Plan, subject to any restriction of law or plan provisions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the liquidation basis of accounting for 2024, and on the accrual basis of accounting for 2023.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Administrative Committee to make estimates that affect the reported amounts of assets and changes therein in the financial statements and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value as described in Note 3.

Income Recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments consists of net realized gains or losses on the sale of investments and net unrealized appreciation or depreciation of investments.

Notes Receivable From Participants

Notes receivable from participants are reported at the outstanding principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan's investments, in general, are exposed to various risks, such as interest rate, liquidity, credit, and overall market volatility risk. These risks may be impacted by certain external financial, business, and other factors, such as the effects of economic downturns, natural disasters, pandemics, war, or hostilities. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in the future. The values of the Plan's individual investments will fluctuate in response to changing market conditions; therefore, the amount of gains and/or losses that will be recognized in subsequent periods and the related impact on the Plan's liquidity cannot be determined at this time.

Note 3. Fair Value Measurements

The Plan segregates the inputs used in measuring fair value into three levels: Level 1, defined as observable inputs such as quoted prices for identical assets or liabilities in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable, such as quoted prices for similar assets or liabilities in active markets or quoted prices for identical assets or liabilities in markets that are not active; and Level 3, defined as unobservable inputs for which little or no market data exists.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and self-directed investments (whose underlying investments include interest-bearing cash and cash equivalents). If quoted market prices are not available, then the fair values of Level 2 securities are estimated by using pricing models, quoted prices of securities with similar characteristics, or net asset value. Level 2 securities include pooled separate accounts, common/collective trusts, and collective investment trusts reflected as a portion of the self-directed investments. Common/collective trusts and pooled separate accounts are valued at the net asset value as determined by the issuer based on the fair values of the underlying net assets divided by the number of units outstanding. The net asset value per unit is a quoted price in a market that is not active; therefore, these investments are classified within Level 2 of the fair value hierarchy.

The Administrative Committee has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this method of compliance, no audit procedures were performed by the Plan's independent auditors with respect to information certified by the Trustee except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Sponsor and fiduciaries of the Plan provide certain administrative services at no cost to the Plan.

Note 6. Plan Termination

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any termination of the Plan or complete discontinuance of employer contributions, participants become 100% vested in their employer accounts. If the Plan were terminated, the Administrative Committee directs the Trustee to distribute the remaining assets, after payment of all Plan expenses, to participants and beneficiaries in proportion to their respective balances.

On May 3, 2024, NuStar Energy completed the Merger with Sunoco LP and its employees became employees of Sunoco. Effective, May 2, 2024, the Plan Sponsor made a plan amendment to terminate the Plan. No further contributions or new loans are permitted under the Plan. Upon termination, all participant accounts became 100% vested. The net assets will be distributed to participants. Participants may elect a lump sum payment or an individual retirement account rollover.

Note 7. Tax Status

The Plan received a determination letter from the Internal Revenue Service dated January 16, 2018 stating that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and tax-exempt.

Note 8. Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
