Subject: Reasonable Cause for Late Filing of Form 5500 for Plan Year Ending 2024

Dear Sir or Madam,

We are writing to provide the reason for the late filing of Form 5500 for Isenhour Door Products, Inc (EIN: 62-1506267, Plan Number: 4-58417) for the plan year ending 12/31/2024.

The delay in submission was not due to willful neglect, but rather to unintentional administrative oversight that occurred while transitioning internal responsibilities and systems used to manage plan filings. Specifically, we were transitioning responsibility to a new HR Resource. In that change, key permissions for completing compliance items on the Principal Financial website were missed during the setup for the new staff member responsible for coordinating Form 5500. Consequently, the items did not display for him to complete, the filing was missed and led to an inadvertent delay.

As soon as the error was identified, we took immediate steps to complete and file the Form 5500 electronically through the EFAST2 system. We have since implemented additional review procedures to ensure timely compliance in the future, including enhanced internal filing calendar reminders, and a formalized annual compliance checklist.

We sincerely regret the delay and appreciate your understanding. Our company is committed to full and timely compliance with all ERISA filing requirements going forward.
